Thursday, March 7, 1963

Senate called to order by the President.

Prayer by Rev. Roland Normandeau of South Portland.

On motion by Mr. Stilphen of

Mr. FARRIS of Kennebec: Mr. President, I move acceptance of the majority "Ought to pass report," and I would like to explain that on today's calendar Item 6-33 on Page 5, which was reported from the Judiciary as "Ought not to pass as covered by other legislation,' this is the measure which covers that other matter, and in this particular bill we return to the juvenile statute the taking of motor vehicles without authority, and also death caused by violation of a traffic law upon the highways, so that in those two classes of cases children under 17 will be attended to in the juvenile court rather than in the public court. That is the purpose of the bill. I move that we accept the majority "Ought to pass" report.

Bill, "An Act to Authorize the Municipalities of Frenchville and St. Agatha to Form a School Administrative District." (H. P. 433) (L. D. 639)

Which received the affirmative vote of 30 members.

Which bills, being emergency measures, and having received the affirmative votes indicated, were passed to be enacted.

Orders of the Day

The President laid before the Senate the 1st tabled and today assigned item (S. P. 143) (L. D. 420) Senate Report, Ought to Pass in New Draft under the same Title; (S. P. 524) (L. D. 1439) from the Committee on Inland Fisheries and Game on Bill, "An Act Regulating Fishing in Certain Waters in York County"; tabled on March 5 by Senator Lovell of York pending acceptance of the report; and on further motion by the same Senator, the report was accepted and the bill read once.

Senator Stilphen of Knox presented Senate Amendment A.

Which Amendment (S-50) was read and adopted and the bill as amended was tomorrow assigned for second reading.

The President laid before the Senate the 2nd tabled and today assigned item (H. P. 503) (L. D. 705) House Report, Ought to Pass as amended by Committee Amendment A from the Committee on State Government on Bill, "An Act Relating to the Duties of Department of Labor and Industry Regarding Industrial Safety"; tabled on March 6 by Senator Edmunds of Aroostook pending acceptance of the report; and on further motion by the same Senator, the ought to pass report was accepted, the bill read once, Committee Amendment A read and adopted and the bill as amended tomorrow assigned for second reading.

On motion by Mr. Edmunds of Aroostook, the Senate voted to take from the table the 37th tabled item (H. P. 113) (L. D. 157) Bill "An Act Revising Laws Relating to Panel of Mediators"; tabled by that Senator on February 28 pending enactment.

Mr. EDMUNDS of Aroostook: Mr. President, while I recognize that this bill came out of the Joint Standing Committee on labor with a unanimous "Ought to pass" report, there have been certain facts which have come to light since the committee reported this bill out. Not only is this bill of questionable value as far as State Government is concerned, but it is my firm belief that it would do actual harm if it was enacted and that it would be most injurious to the excellent labor relations record that we do have in the State at this time. For that reason, Mr. President, I would now move the indefinite postponement of this bill.

The motion prevailed and the bill was indefinitely postponed, in non-concurrence.

Sent down for concurrence.

On motion by Mr. Hinds of Cumberland, the Senate voted to take from the table the 13th tabled item (S. P. 159) (L. D. 435) Bill, "An Act Providing Expense Reimbursement for Members of the Legislature; tabled by that Senator on February 12 pending assignment for second reading.

Mr. Hinds presented Senate Amendment B.

Senate Amendment B (S-49) was read.

Mr. HINDS of Cumberland: Mr. President and Ladies and Gentlemen of the Senate: I think we all know what happened to the bill as written originally. The Supreme Court was very wise in their ruling, and I think if we all read the ruling carefully we will see that they admit themselves that they feel the legislature is underpaid, but they have to rule on what is constitutional and what is not, and they did so.

This amendment would simply strike out the emergency clause and make this bill effective for the next session. The only other change in this bill is that the approval of vouchers would be by the Joint Standing Committee on Appropria

tions and Financial Affairs of the respective bodies.

I feel that this is something that we should do for the next session of the legislature, and I would now move that Senate Amendment "B" be adopted.

Mr. WHITTAKER of Penobscot: Mr. President, may I point out that there is now pending before the Committee on State Government L. D. 848, which has been heard by the Committee but has not yet been acted upon. It is similar legislation and I would like to move that the item now under consideration be tabled and specially assigned for March 14th so that the Committee on State Government may act on similar legislation.

The motion prevailed and the bill was tabled and specially assigned for Thursday, March 14, pending motion by Mr. Hinds to adopt Senate Amendment B.

On motion by Mr. Porteous of Cumberland, the Senate voted to take from the table the 43rd tabled item (H. P. 513) (L. D. 715) House Report, Ought Not to Pass, from the Committee on Taxation on Bill, "An Act Eliminating Certain Exemptions Under Sales Tax Law"; tabled by that Senator on March 6 pending acceptance of the report; and on further motion by the same Senator, the bill was retabled and especially assigned for Wednesday next.

Mr. Edmunds of Aroostook was granted unanimous consent to address the Senate.

Mr. EDMUNDS: Mr. President, may I just comment on behalf of the leadership, and I know all of the Senate, that the action which Senator Porteous has just taken is most appreciated. We certainly respect him for what he has done because he has solved a very diffi-

cult problem for the leadership and I wish to publicly thank him.

Mr. Porteous of Cumberland was granted unanimous consent to address the Senate.

Mr. PORTEOUS: Mr. President and members of the Senate: In view of the kind remarks of the Senator from Aroostook, Senator Edmunds, I would like to thank him for his remarks.

I intended and did abide by the rules that when discussing tabling no debate is allowed, and I am not about to debate, but I would like to ask the members of the Senate between now and Wednesday next if they will thoroughly re-examine all the information they have hand on the various taxation measures that are before them. I would like to prepare them for some figures I have received and that have been published about the State of North Carolina, which is a State that has removed certain exemptions from their sales tax law. I would like at this time to throw one figure at you, and that is that out of the \$40,000,000 extra that they raised in North Carolina in the 1961-62 year, that is a single year, \$22,000,000 was derived from the removal of the exemption on food.

I will be prepared on Wednesday to debate thoroughly on this, but I thought I would leave you with this thought in mind: that to thoroughly discuss one of the most pressing problems you have before you in this 101st session that it would behoove each one of us to thoroughly examine or re-examine our information before Wednesday next.
