### SENATE

Friday, March 22, 1963

Senate called to order by the President.

Prayer by Rev. Arthur G. Christopher of Augusta.

On motion by Mr. Boisvert of Androscoggin, the Journal of yesterday was read and approved.

The PRESIDENT: The Chair is happy to recognize in the Senate Chamber Miss Penelope Blaisdell, daughter of Mr. and Mrs. Alton W. Blaisdell. She is a 4th grade pupil at the Readfield Elementary School. She is the daughter of the Secretary of the President of the Senate. The Chair would like to appoint her as an honorary page for today, and if she is as efficient at that as her mother is in her job we have nothing to worry about. (Applause)

The Chair would like to congratulate the Senator from Hancock, Senator Brown, who completed public hearings for the Business Legislation Committee a week ago last Tuesday: and the Senator from Washington, Senator Wyman, who yesterday reported out fifteen bills from the Taxation Committee, which is a remarkable achievement the day after the "Doc" Arnold testimonial dinner. And the Chair is happy to recognize that there is another hardboiled egg in the Senate Chamber other than the Senator from Aroostook, Senator Edmunds.

The Chair is honored today to recognize in special recognition a young man who is a citizen of this State and who is a National Champion. With the permission of the Senate, I would ask that the Sergeant-at-Arms escort Jerry Varnam and his coach, Grady Erickson, to the rostrum. (Applause)

Jerry Varnam is 19 years old and he is the U. S. National Junior Crosscountry Ski Champion. He won this honor in the State of Wyoming a week ago. He first won this title in 1961 at Lake Placid, New York, when he was a sophomore at Cony High School here in Augusta.

It is interesting to note that he could not have made this trip if there had not been a special fundraising drive by the local citizens and an offer and delivery of \$150

from the Governor and Council of this State.

He is the only schoolboy ever to win the Eastern, the Northeastern and the Maine Crosscountry championship three times in succession.

He was reluctant not only to appear here, but he was reluctant to appear here in his skiing jacket, and it was almost impossible to have him bring these beautiful trophies.

But it is not so significant that we honor this particular individual as it is what he represents. I think it is fitting and proper that the Senate of this State recognize not only Grady Erickson, his coach, and Jerry Varnam, the U.S. Champion, but what can be accomplished in one of many fields by a young citizen of this State. Jerry, we congratulate you. (Applause)

Mr. JERRY VARNAM: Mr. President, I appreciate very much the honor that has been given me. (Applause)

Mr. LOVELL of York: Mr. President, I move the acceptance of the Majority Ought to Pass Report.

Mrs. CHRISTIE of Aroostook: Mr. President, I move that we concur with the House in the indefinite postponement of the bill.

Mr. LOVELL of York: Mr. President, I would like to clarify this bill to the members of the Senate.

The Committee on Industrial and Recreational Development, in traveling through the ski areas a year ago and visiting our seven major ski areas and talking with the operators there, found that they wished fair treatment, and they asked our committee if they could have fair treatment in the Maine Legislature. I say "fair treatment."

The resorts in the summer time, if you will note, are on the Liquor Commission time, or standard time, and the resorts stayed open until 1:00 A.M. or twelve o'clock standard time, and when we go back onto standard time in the skiing areas the resorts have to close at twelve, in the hotels and class "A" restaurants. Now it seems only fair to me that these resorts in the skiing area be given the same privilege that the summer resorts have.

Now you will note the amendment on this in regard to "prevailing time." It came to my attention that members in the other body did not recognize what the definition of "prevailing time" was. I assume when this bill comes back to them it will be clarified to them that prevailing time means that the time that is now the time by law in the State of Maine. So consequently when Daylight Saving Time goes off and we go back on Standard Time then these resorts have to close at twelve, whereas the summer resorts are allowed to remain open until one.

Now if this was a bill to put Prohibition back into the State of Maine I would agree that you could all vote for it, but this is not a bill of that type; this is simply to give fair, even, distribution, and whether you vote wet or dry this is simply fairness in the State of Maine. Now if you want to be fair with the skiing areas and with the resorts in the winter time as compared with the resorts in the summer time, I urge you to vote against the prevailing motion, and when the vote is taken I would ask for a division. I ask that you please be fair.

The PRESIDENT: The question before the Senate is on the motion of the Senator from Aroostook, Senator Christie, that this bill be in-

definitely postponed.

Mr. WHITTAKER of Penobscot: Mr. President, I rise to support the motion of the Senator from Aroostook, Senator Christie, and would point out that this is not a bill simply for the winter ski areas, but, if passed, it would permit late openings throughout the State for all establishments qualifying.

Mrs. CHRISTIE of Aroostook: Mr. President, I just want to mention this one thing which came to me. One of the members of another body was speaking to a State Highway Police official, and he said this bill would be bad from the standpoint of highway safety, and he felt that it was very good that the House turned down this bill.

Mr. LOVELL of York: Mr. President, there are a great many things, I will say to this Senate, that will probably help highway safety. If you want to have a bill to bring Prohibition back and put liquor out of the State of Maine, that assuredly would probably help highway safety a great deal. But this is only fairness. If these reports, regardless of where they are, or any hotel or Class "A" restaurant, can stay open until one o'clock five or six months out of the year when Daylight Saving Time is in, it does not seem fair to stop the other areas from staying open until one o'clock when Standard Time is in. I just ask you to be fair.

A division of the Senate was had. Sixteen having voted in the affirmative and eleven opposed, the motion to indefinitely postpone in concurrence prevailed.
