SENATE

March 27, 1963

Senate called to order by the President.

Prayer by Rev. Victor P. Musk of Augusta.

On motion by Mr. Brooks of Cumberland, Journal of yesterday read and approved.

Mrs. CHRISTIE of Aroostook: Mr. President and members of the Senate: This bill had appeared to be rather an innocuous bill, and that is apparently what influenced the decision of those who voted to refuse acceptance. On the other hand, the Department of Forestry, with Mr. Wilkens at its head, feel that it is a very normal thing and a very useful thing to have the botanical name of the correct tree, and that is done in a great many states. But I do not think this is sufficiently important to ask for a committee of conference. so I move that we recede and concur with the House.

The PRESIDENT: The Chair is honored to recognize in the Senate Chamber a former distinguished Senator from Somerset County, Senator Sanger Cook. (Applause) The Chair is likewise honored to recognize in the Senate Chamber an equally distinguished Senator from Kennebec County, Senator Sylvio "Turk" Gilbert. (Applause)

The President laid before the Senate the 1st tabled and today assigned item (S. P. 48) (L. D. 98) Bill, "An Act Revising the Law Relating to Closing Out Sales;" tabled on March 13 by Senator Stilphen of Knox pending passage to be engrossed; and that Senator yielded to the Senator from Cumberland, Senator Porteous. On motion by Mr. Porteous of Cumberland, the bill was tabled until later in today's session.

The President laid before the Senate the 2nd tabled and today assigned item (H. P. 625) (L. D. 881) House Report, Ought to Pass with Committee Amendment A from the Committee on Business Legislation on Bill, "An Act Relating to Authority Under Non-resident Insurance Agent's License;" tabled on March 20 by Senator Brooks of Cumberland pending acceptance of the report, and that Senator moved the pending question.

Thereupon, the Ought to Pass report was accepted, the bill read once; Committee Amendment A was read and adopted and the bill as amended was tomorrow assigned for second reading.

The President laid before the Senate the 3rd tabled and today assigned item (H. P. 104) (L. D. 148) Bill, "An Act Relating to Definition of Industrial Project under Maine Industrial Building Authority Act;" tabled on March 20 by Senator Farris of Kennebec pending that Senator's motion to Indefinitely Postpone; and that Senator was granted permission to withdraw his motion.

Mr. FARRIS of Kennebec: Mr. President, in view of the fact that Senator Noyes is not present and since he has an interest in this legislation, I now move that the bill be tabled.

The motion prevailed and the bill was laid upon the table pending consideration.

D. 1286) bill, "An Act Adding the Suspension or Revocation of Licenses of Official Inspection Stations to the Administrative Code"; tabled on March 26 by Senator Edmunds pending assignment for second reading; and on further motion by the same Senator the bill was tomorrow assigned for second reading.

On motion by Mr. Brown of Hancock, the Senate voted to take from the table the 43rd tabled and unassigned item (H. P. 568) (L. D. 878) bill, "An Act Revising the Savings Bank Law"; tabled by that Senator on March 26 pending passage to be engrossed; and on further motion by the same Senator, the bill was passed to be engrossed.

On motion by Mr. Lovell of York, the Senate voted to take from the table the 18th tabled and unassigned item, (H. P. 97) (L. D. 141) bill, "An Act to Authorize a Bond Issue for Purchase of Voting Machines for Resale to Municipalities"; tabled by that Senator on March 6 pending assignment for second reading; and that Senator presented Senate Amendment A and moved its passage.

The Secretary read the amendment. (S-111)

Mr. LOVELL of York: Mr. President and members of the Senate: This amendment is to clarify this bill on certain objections that were brought up in the other body. The feeling was that in small communities they did not want to have to participate and pay interest on a bond issue, which this bill would have originally called for.

As you will remember, two years ago this bill passed the Senate. To me it is certainly a pro-gressive bill. Voting machines, as you can realize, in the recent election would have saved the State a great deal of money on the various recounts that they had from Governor on down through to mi-Consequently. nor offices. this amendment is to allow commu-nities and cities who so wish to purchase machines through the State and pay for them on a time basis with the prevailing interest that the State is getting for sur-plus moneys that they have invested. Consequently this is coming from the unappropriated surplus, and, to my knowledge, this surplus has not dropped below a million dollars or so; and the sum of \$60,000 with the interest being paid at the prevailing rate that the State could invest the money for-this would seem to clarify this bill against any objection.

We are living in a democracy, and I think we should know the results of our elections as other states do, two or three hours after. and avoid the necessity of long recounts. I say we are living in a democracy-it is almost a democracy - we don't have quite fair apportionment in some of our bodies, and on some questions we believe in local option, on questions such as liquor, but on other questions, on stores staying open, they do not seem to be very pleased with local option, but nevertheless I would move the adoption of this amendment.

The motion prevailed and Senate Amendment "A" was adopted and the bill was assigned for second reading on the next legislative day.

The PRESIDENT' The proceedings of the Senate should never take such a pace that we do not have time to recognize students who visit these halls.

In the gallery today there is a group of 35 students in the Classes

of United States History and American Government from the High School of Strong, Maine, accompanied by their teacher, Mr. Lloyd Davidson. These students are guests of Representative Smith of Strong.

We are happy and proud to have students visit here. We want you to be impressed by these proceedings and by your stay. You hear so often in your course in history about the accomplishments of other areas and particularly the history of the Commonwealth of Massachusetts and St. Augustine, Florida. but I am wondering whether or not you know that historians tell us that the Vikings spent the winter of the year 999 somewhere along the Maine coast. and that during the year 1496 Sebastian Cabot visited the State of Maine; that the French people settled St. Croix Island in the year 1604, which became the scene, incidentally, of this country's first Christmas tree. And you ought to know that the Popham Colonists settled on the Kennebec River in 1607, which was thirteen years before the Pilgrims landed at Plymouth Rock. The first vessel we definitely know to have been constructed on the American continent was named Virginia, and she was constructed on this same Kennebec River in 1607. The town or city of York, Maine was chartered in 1642, and it was the first chartered city in America, and the oldest public building in New England is the York jail, which they spelled "gaol," and which observed its 300th birthday in 1953.

Be proud of your State. We are happy to have you here. (Applause)

On motion by Mr. Cram of Cumberland, the Senate voted to take from the table the 29th tabled and unassigned item (H. P. 691) (L. D. 947) House Report, Ought Not to Pass, from the Committee on Taxation on bill, "An Act Creating an Excise Tax on Sales of Real Estate"; tabled by that Senator on March 13 pending acceptance of the report; and on further motion by the same Senator, the Ought Not to Pass report was accented. On motion by Mr. Couture of Androscoggin, the Senate voted to take from the table the 45th tabled and unassigned item (S. P. 491) (L. D. 1343) Senate Reeport, Ought Not to Pass, from the Committee on Welfare on bill, "An Act Relieving Children and Certain Relatives of Financial Responsibility in Old Age Assistance, Aid to the Blind and Aid to the Disabled;" tabled by that Senator on March 26 pending acceptance of the report; and that Senator moved the pending question.

Mr. EDMUNDS of Aroostook: Mr. President, due to the enforced absence of the Chairman of the Joint Standing Committee on Welfare, Senator Harrington, I would move that this bill be retabled and especially assigned for tomorrow, pending motion by Senator Couture to accept the report.

The motion prevailed and the bill was so tabled.

On motion by Mr. Couture of Androscoggin, the Senate voted to take from the table the 1st tabled and unassigned item (H. P. 544) (L. D. 801) bill, "An Act Relating to Establishment of a Personnel Law for Certain Employees of the City of Lewiston"; tabled by that Senator on February 5 pending motion by Senator Jacques of Androscoggin that

the bill be referred to the Committee on Municipal Affairs; and Mr. Couture moved the pending question.

Thereupon, on motion by Mr. Edmunds of Aroostook, the bill was retabled and especially assigned for tomorrow.

On motion by Mr. Porteous of Cumberland, the Senate voted to take from the table S. P. 48, L. D. 98, (Item 1, Page 9) bill, "An Act Revising the Law Relating to Closing Out Sales"; tabled earlier in today's session by that Senator pending passage to be engrossed; the same Senator presented Senate Amendment B and moved its adoption.

The Secretary read Senate Amendment B (S-110).

Which amendment was adopted.

The same Senator presented Senate Amendment C and moved its adoption.

The Secretary read Senate Amendment C (S-116).

Which amendment was adopted and the bill as amended was passed to be engrossed and sent down for concurrence.
