SENATE

Friday, April 5, 1963

The Senate was called to order by the President.

Prayer by the Rev. Kenneth Brookes of Augusta.

On motion by Mr. Cole of Waldo, the Journal of yesterday was read and approved.

The PRESIDENT: The Chair would ask the Sergeant-at-Arms to escort the Senator from Cumberland, Senator Brooks to the well before the rostrum.

Senator Brooks of Cumberland was escorted to the well before the rostrum by the Sergeant-at-Arms.

The PRESIDENT: The Chair would inquire of the Senator his birthplace.

Mr. BROOKS: Mars Hill, Maine. The PRESIDENT: And would you, Senator, give us the date of your birth?

Mr. BROOKS: April 5, 1920, sir. The PRESIDENT: Is it a fact then that this is your birthday?

then that this is your birthday? Mr. BROOKS: Yes, Mr. President. The PRESIDENT: The Senate of this state is cognizant of this fact and could not let this day go by with out the proper recognition. Therefore I ask that the Senate Majority Leader enter the chamber.

Senator Edmunds of Aroostook entered the chamber.

The PRESIDENT: We have a gift for you, Senator Brooks, which symbolizes and will help you consider the future education problems of this State. We hope you will be able to use this as you consider our future financial problems in the field of education. Not only this, but we have an additional gift for you which we hope you will likewise appreciate. This is symbolic of your many future years ahead of you, and we want you to take this home with you too, Senator. In addition to this, we understand that you are a boating enthusiast but you have no means by which to secure your boat at the dock and that you also have a rowboat along with your regular boat and we give you these gifts to help you out in this direction.

We notice that you are visibly affected by these gifts. Lastly, our esteem is represented by a flag of this State indicating your sincere devotion to your effort. (Applause)

SENATOR BROOKS: Thank you very much, Mr. President. The gifts do overwhelm me emotionally and I am just rather speechless, but I do appreciate such a fine array of gifts from this illustrious body.

The PRESIDENT: The Chair recognizes the Senator from Aroostook, Senator Edmunds.

Mr. EDMUNDS: Mr. President, I think in the interests of the decorum of the Senate that the Senator should remove his gifts from the Senate Chamber.

The PRESIDENT: The Senator will forthwith remove his gifts from the Senate Chamber.

Mr. BROOKS: Thank you, sir. I have a compact car, gentlemen.

The PRESIDENT: The Chair recognizes in the gallery of the Senate 27 8th grade students from the Dr. Louis Libby Elementary School of Milford, accompanied by the principal, Edward DiCenzo, and 20 8th grade students from Viola R an d Elementary School of Bradley, accompanied by the principal Peter Benson, who happens to be the brother of Representative David Benson. This is a Penobscot County delegation.

May we pause in the Senate to point out to you students that you have just seen with one motion of the gavel 28 laws be passed, but it would be entirely wrong for you to get the idea that they are passed that easily, because this group has been sitting here since the first day of January of this year considering these things. As you know, any laws which are passed in this building start out as someone's idea, and this idea goes to one of these Senators or one of the members of the House of Representatives in the hall at the other end of the building. This idea is put on paper and is sent to a Reference of Bills Committee and this committee decides which one of several committees this bill should be considered by. And even this decision has to be acted upon and approved by both the Senate and the House of Representatives. Once they have agreed on it goes to this committee and the committee holds a public hearing on the subject matter. They discuss the pros and cons, and if they decide it is still a good idea the committee reports it out either to the House of Representatives or to this Senate for further action. Once again, both the House of Representatives and the Senate of this State have to agree and approve this idea. In spite of all this, it must have two readings, so-called, in this body and it must have three readings in the House of Representa-tives. Following all this, if this idea still seems to be a good one it is passed to be engrossed. And nobody is ever quite sure what this means but I best can show you.

As this idea goes through the process of legislation it takes several forms on paper and it becomes marked up with a variety of notations indicating its course of travel

and it is not a very artistic sight by the time it gets to the point where it can become a law. Within this elastic are several pages of just what I am suggesting to you and it is completely marked up. When it appears that it is just about ready to become a law this idea in writing is completely reviewed for grammatical corrections, for typographical errors, and is finally put into printed form, much better to look at, with a cellophane window-face, and it is now in a position for final consideration. Having gone through this entire process, it then goes back to the House or Senate for final enactment. On c e more, the House and Senate consider this idea, and if it is finally enacted then it must be signed by the Governor of the State.

Now lest you think that this is a ridiculous, inefficient system — and it may be — we would point out to you that this legislative process is like a giant sifting process, and we hope with all the strength we have that as a result of this sifting process only good legislation comes through and that in the end justice is done.

Orders of the Day

Mr. BOARDMAN of Washington: Mr. President, I would inquire if L. D. 1428, "An Act Increasing the Number of Superintending School Committee of Town of Baileyville' is in the possession of the Senate?

The PRESIDENT: The Chair answers the Senator in the affirmative, the House having returned the document to the Senate.

On motion by Mr. Boardman, under suspension of the rules, the Senate voted to reconsider its action whereby the bill was passed to be engrossed, and on further motion by the same Senator the bill was recommitted to the Committee on Municipal Affairs.

The President laid before the Senate the first tabled and specially assigned matter (H. P. 975) (L. D. 1347) Resolve, Authorizing State Highway Commission to Construct Certain Highway Facilities on Interstate Highway 95 in towns of Kittery and York, which was tabled on March 29 by Mr. Porteous of Cumberland pending passage to be engrossed.

Mr. COLE of Waldo: Mr. President and members of the Senate: In making inquiry of the Senator from Cumberland, Senator Porteous as to his interest in this particuar bill I was informed by Senator Porteous that his only interest was the fact that he would possibly like to amend the bill in regard to the removal of the Publicity Bureau at the entrance of the Interstate system at Kittery. Since that time, Mr. Johnson from the Maine Publicity Bureau and his directors have had a meeting with the Highway Commission, and at this time they have no further interest in the bill, and Mr. Portecus has informed me through the Maine Publicity Bureau that he also has no further interest in the bill. So, Mr. President, may I have permission to proceed with the normal process of this bill.

The PRESIDENT: The Senator from Waldo, Senator Cole, requests permission to proceed with the normal process of the bill. The Chair hears no objection and the Senator may proceed.

Mr. COLE: Mr. President, I now offer Senate Amendment "A" and move its adoption.

I might add in the way of explanation that this is a technical amendment clarifying the agreement that would be signed between the State Highway Commission and the Maine Turnpike Authority.

Senate Amendment "A" was read and adopted and the resolve was passed to be engrossed as amended and sent down for concurrence.

The President laid before the Senate the 2nd tabled and specially assigned matter, (H. P. 156) (L. D. 207) Bill, "An Act Relating to the Beginning of Standard Time," which was tabled on March 29th by Mr. Ferguson of Oxford, pending passage to be engrossed.

Mr. FERGUSON of Oxford: Mr. President and members of the Senate: I have no personal strong feeling about this bill either one way or the other, but I have had several calls in regard to the changing of Daylight Saving Time from the last Sunday in April to the last Sunday in February, which extends Daylight Saving Time by two months. Therefore I feel I would be remiss in my duties if I did not bring this before the Senate, I would like to ask the Secretary of the Senate the status of the bill now. I have no record to show that there is any amendment to this bill.

The PRESIDENT: The Secretary will read the status of the bill.

The SECRETARY: In the House of Representatives, read a third time and passed to be engrossed as amended by Committee Amendment "A" on March 26th. In the

Senate on March 27th Committee Amendment "A" adopted, read once and tomorrow assigned. In the Senate, read a second time and tabled by Senator Ferguson pending passage to be engrossed as amended.

The PRESIDENT: It would appear that Committee Amendment "A" to the bill has been read and adopted by both branches.

Mr. FERGUSON: Then I move the pending question.

Thereupon the bill was passed to be engrossed as amended.

The President laid before the Senate the 3rd tabled and unassigned matter, (H. P. 957) (L. D. 1391) House Report "Ought not to pass" from the Committee on Welfare on Bill, "An Act Relating to Definition of Dependent Child Under Aid to Dependent Children," which was tabled on April 2nd by the Senator from Penobscot, Senator Harrington, pending acceptance of report.

On motion by Senator Harrington of Penobscot, the "Ought not to pass" report of the Committee was accepted.

On motion by Mr. Edmunds of Aroostook, the Senate voted to take from the table the 38th tabled and unassigned matter, (H. P. 673) (L. D. 929) House Reports, from the Committee on Liquor Control on Bill, "An Act Permitting Sale of Liquor by Passenger Boat "Ought to pass"; Minority Report, "Ought not to pass," which was tabled on March 29th by that Senator pending acceptance of either report.

Mr. EDMUNDS: Mr. President, I now yield to the Senator from Aroostook, Senator Christie.

Mrs. CHRISTIE of Aroostook: Mr. President and members of the Senate: Ten years ago when I first became a legislator the attitude of most law-makers was to hold the line, no liberalizing of the liquor laws. In 1950 Maine was 41st among the states in the rate of per capita consumption of alcoholic beverages. In 1955 a law was enacted permitting the sale of bottled malt beverages in chain stores. In 1957 a bill was enacted permitting sale of liquor in Class "A" restaurants. Per capita drinking climbed until we rose from 41st place to 20th place among the states in per capita consumption.

Perhaps you wonder what this has to do with this bill. It has just this: if we pass this bill we are authorizing a new avenue of sale of this dangerous product. I am still greatly concerned at the drive to let down the bars, and with good reason. We are being asked to provide 25 additional state police in an attempt to reduce highway accidents, which last year took 176 lives, 62 of them in accidents where alcohol was involved. Of the fourteen families of children now living at the Bath Children's Home nine of them are there because of broken homes due to alcohol. Washington, D. C. has the highest rate of alcohol consumption of any city in our country. Today it is a city of thugs. Mae Craig, in last Sunday's Telegram, told of the terrible crime conditions there and said it is not safe to be on the streets or parks of that city day or night unless close to the police and their trained dogs. Congressman Tupper, speaking on TV Thursday night, warned people to stay away from Washington because of the terrible crime conditions there. I would not say that the entire crime condition in Washington is due to alcohol but I would say that it plays a large part in the criminal conditions that exist in Washington today.

But to come back to Maine. Early in 1959 I read in an editorial in the Portland Sunday Telegram the tragic story of a group of teenage Alcoholics Anonymous recently organized in that city. How would you like to have your child a member of such a group? You are certainly making it easier for such things to happen when you vote to sell more liquor.

Someone questioned recently the definition of an alcoholic. No doubt he knows the definition. An alcoholic is a compulsive drinker, one who is unable to control his drinking. Their number is increasing in Maine. If you want to contribute to this increase by making more liquor available let's not let the dollar sign blind our eyes; let's hold the line on liquor. We need less, not more. Let's defeat this bill.

I move for the acceptance of the Minority "Ought not to pass" report.

The PRESIDENT: The question before the Senate is on the motion of the Senator from Aroostook, Senator Christie, that the Senate accept the Minority, "Ought not to pass" report of the committee. Mr. JACQUES of Androscoggin:

Mr. JACQUES of Androscoggin: Mr. President, as a member of the Liquor Control Committee I wish to stand up here.

As you will notice in L. D. 929, this only brings us back to the passenger boat service. We have it on steamboats now; we have it on the Pullman train, we have it on everything else, but we have not changed the law for passenger boats, and that is all that this is doing.

Mr. President, I would like to know what the status of the bill is right now.

The PRESIDENT: The Secretary will read the passage of the bill.

The SECRETARY: In the House of Representatives, Majority "Ought to pass" report accepted on March 12th. On March 27th the bill was passed to be engrossed as amended by House Amendment "A." Tabled in the Senate pending acceptance of either report.

Mr. JACQUES of Androscoggin: Mr. President, when the vote is taken I move that it be taken by a division.

The PRESIDENT: A division has been requested.

Mr. LOVELL of York: Mr. President and members of the Senate: I have no particular interest in this bill but I would like to answer the good Senator from Aroostook, Senator Christie, on a couple of things she mentioned.

This certainly will not cause any deaths on the highway, as she mentioned, because this is on the water, and I do not think we need to worry about that portion. Also, in regard to relaxing or curbing liquor laws, if you will note the budget, a good person in this building has recommended \$500,000 for more liquor for liquor stores so that Maine people can have more liquor. Now maybe the good Senator will probably oppose that bill.

(On motion by Mr. Farris of Kennebec, certain remarks were ordered expunged from the record)

I would hope that this Senate would go along with the majority report.

 \overline{I} would also request that the remarks of the good Senator from Aroostook be stricken from the record, saying that Washington had a bunch of thugs.

The PRESIDENT: The Senator is out of order.

The question before the Senate is on the motion of the Senator from Aroostook, Senator Christie, that the Minority "Ought not to pass" report of the committee be accepted. A division has been requested.

Mr. WHITTAKER of Penobscot: Mr. President and members of the Senate: I rise to support the motion of the Senator from Aroostook, Senator Christie, I should like to do so, briefly, on somewhat different grounds.

I am interested in the reference made here to the sale of liquor in Pullman cars. This is a past issue, I believe, at the present time.

I would like to suggest that this is legislation which should not be passed because it would permit the sale of alcoholic beverages on passenger boats, which, if I understand the situation correctly, would involve largely so-called sight-seeing boats. I understand that the amendment calls for sale on boats carrying not fewer than fifty passengers, but even this amendment does not appeal to me as sufficient to warrant support of the bill. If you will imagine the situation in which liquor would be sold on a passengercarrying boat, I am sure that you will realize that there would in most cases be a large number of young people and perhaps children involved in such boating activity. This would be comparable to the selling of liquor on a highway bus. It has been facetiously suggested to me that there might be some difficulty in this permission, if it were granted, that passenger-carrying boats in when they entered the territorial waters of a town might have to stop selling the liquor. I have re-

strained myself from arising every time a liquor bill is on the floor of this Senate, but this is one which I feel should be defeated.

The PRESIDENT: Is the Senate ready for the question? The question before the Senate is on the motion of the Senator from Aroostook, Senator Christie, that the Senate accept the Minority "Ought not to pass'' report of the committee. A division has been requested. All those in favor of the motion of the Senator from Aroostook, Senator Christie that the Senate accept the Minority "Ought not to pass" report of the committee will rise and stand in their places until counted.

A division was had.

19 having voted in the affirmative and 10 in the negative, the motion prevailed and the Minority "Ought not to pass" report of the committee was accepted.

On motion by Mr. Stilphen of Knox, the Senate voted to take from the table the 15th tabled and unassigned matter, (H. P. 589) (L. D. 827) House Report, "Ought not to pass" from the Committee on Bill, "An Act Relating to Sale of Publications of Department of Inland Fisheries and Game," which was tabled on March 27th by that Senator pending acceptance of report.

Mr. STILPHEN: Mr. President, I took notice that the table was getting a little heavy and that I had two items on the table here in the Senate, so I thought I would take one off today and one is automatically coming off next Wednesday. At this time I would like to move that this be recommitted to the Committee on Inland Fisheries and Game.

The motion prevailed and the bill was recommitted to the Committee on Inland Fisheries and Game.

On motion by Mr. Wyman of Washington, the Senate voted to take from the table Item 1-4, Bill, "An Act Relating to Excise Tax on Motor Vehicles Owned by Domestic Corporations, Partnerships and Charitable institutions," (S. P. 464) (L. D. 1291) which was tabled by that Senator earlier in today's session. Mr. WYMAN: Mr. President, I now move the pending question.

House Amendment "A" was read by the Secretary.

The Senate thereupon voted to recede and concur.

On motion by Mr. Brown of Hancock, the Senate voted to take from the table the 18th tabled and unassigned matter, (S. P. 403) (L. D. 1106) Bill, "An Act to Provide for Special Deputy Clerks of Court," which was tabled by that Senator on March 12th pending passage to be engrossed.

On further motion by the same senator the bill was passed to be engrossed and sent down for concurrence.

On motion by Mr. Stitham of Somerset, the Senate voted to take from the table the 6th tabled and unassigned matter, (H. P. 38) (L. D. 61) Bill, "An Act Providing for Transportation of Deer by Maine Members of Armed Forces," which was tabled by that senator on February 21st pending enactment.

Mr. STITHAM: Mr. President, the original purpose for my tabling this particular bill was that it was to be included in other legislation which we have today enacted as Item 8 24, so this subject matter is covered by the enacted bill. For that reason, I now move that this bill be indefinitely postponed as covered by other legislation.

The motion prevailed and the bill was indefinitely postponed.

On motion by Mr. Jacques of Androscoggin, the Senate voted to take from the table the 56th tabled and unassigned matter, (H. P. 299) (L. D. 393) Bill, "An Act Relating to Definition of 'Hotel' Under Liquor Law," which was tabled by that Senator on April 3rd pending assignment for second reading.

Mr. JACQUES: Mr. President, I was a little confused the other day when this bill was given its second reading. This bill came out of committee 9 to 1 "Ought not to pass." If this bill is enacted it would put 460 poor people out of work in the State of Maine. It would close up 65 establishments. We were told that by the Liquor Commission. For this reason, Mr. President, I move that this bill be indefinitely postponed.

Mrs. CHRISTIE of Aroostook: Mr. President and members of the Senate: I hate to rise a second time on a liquor bill today but I cannot refrain from making comment on this one.

This bill would require that onethird of the rental receipts and onethird of the amount received for food should be required in order for the business to be called a hotel. It seems to me that if a place of business cannot make one-third of its receipts from food or rentals it is not deserving of the name "hotel." I feel that one-third is a very small amount. In my opinion it should be more, but I feel that we should at least hold it to this line.

Mr. NOYES of Franklin: Mr. President, I have been informed by the Liquor Commission that some thirty or forty hotels in this state would be closed if we passed this law.

Mr. WHITTAKER of Penobscot: Mr. Presisdent, when the vote is taken I request a division.

Mr. LOVELL of York: Mr. President, may I inquire as to the status of this bill.

The PRESIDENT: The Senator may:

I think the Chair is prepared to inform the senator of the status, he having previously inquired.

The committee report was "Ought not to pass." It went to the House and the bill was substituted for the report and House Amendment "A' was adopted. In the Senate we accepted the "Ought not to pass" report of the committee. It was returned to the House and they insisted. When this bill was returned to the Senate it was tabled, and when it came off the table we should have either insisted or have asked for a committee of conference. Instead, we substituted the bill for the report, which was a procedural error. It is now off the table, having been tabled by the Senator from Androscoggin, Senator Jacques, pending assignment for second reading.

Does this answer the question of the Senator from York, Senator Lovell? Mr. LOVELL: Thank you, Mr. President. And I would hope that the Senate would go along with the unanimous "Ought not to pass" report in defeating this bill.

The PRESIDENT: The question before the Senate is on the motion of the Senator from Androscoggin, Senator Jacques, that the bill be indefinitely postponed. A division has been requested.

Mrs. CHRISTIE of Aroostook: Mr. President and members of the Senate: I want to correct one remark of the Senator from York, Senator Lovell. It was not a unanimous report.

A division was had.

Twenty having voted in the affirmative and nine in the negative, the motion prevailed and the bill and accompanying papers were indefinitely postponed.

On motion by Mr. Kimball of Hancock, the Senate voted to take from the table (S. P. 300) (L. D. 873) Bill, "An Act Providing for Adult Identification Cards Under Liquor Law," which was tabled by that Senator on March 14th pending consideration. (In Senate Passed to be Engrossed) (In the House Indefinitely Postponed)

Mr. KIMBALL: Mr. President and members of the Senate: I now move that we insist on our original action on this particular bill.

This bill is one that came out of our committee as unanimous report. It had a very complete support. It had the support of all elements in our meeting, including the so-called wets and the so-called drys, the liquor interests, and any other interests you like. It had the support of the Liquor Commission. It had support generally all the way through and went through safely here in the Senate and has come back to us with an indefinite postponement from the other body.

In inquiring why, I found that one of the major reasons that it came back was because they believed that the present automobile drivers' license on the new permanent status would cover this. This is not the feeling of, for example, the counsel of the Liquor Commission, that it would do this, because, for one reason, it does not include

a photograph as this suggests. One thing that particularly calls it to my mind is an item in today's that has been picked up for selling false identification cards under the military identification card grouping that he had prpared for minors who were using them in procuriing alcoholic beverages. The people who have licenses are most anxious not to sell to minors. They need some form of proper identification from those youngsters that is available to them on a free basis, put out by the Liquor Division, and the enforcement areas of that Liquor Commission believe that it is the one sure way that they can keep liquor very largely out of the hands of the under-age persons.

I move that we insist.

The PRESIDENT: The Senator from Hancock, Senator Kimball, moves that we insist on our action. Is this the pleasure of the Senate.

The motion prevailed and the Senate voted to insist.

On motion by Mr. Johnson of Somerset, the Senate voted to take from the table Item 1-2 on today's calendar, which was tabled earlier in today's session by that Senator, Bill, "An Act Relating to Employment of Minors Under Sixteen Years of Age," (S. P. 214) (L. D. 524) Senate Amendment "C" was read

by the Secretary.

Mr. REED of Sagadahoc: Mr. President and members of the Senate: This bill is one that has bothered me as it has gone through and I have said nothing up to this point, but if you will look at L. D. 524, you have deleted potato storage houses, you have deleted woods operations, and that leaves farm storage, construction activity and tree surgery. Now probably you think I would be interested in construction activity. It took quite a while to get that one boy I have and maybe I want to get him to work before he is sixteen. I cannot help but think that this type of legislation takes for granted, first of all, that the employer does not have too many brains, and, secondly, that the parent doesn't. Therefore Т would like to move that we concur with the House in indefinitely post-

.

poning this bill, and I ask for a division.

The PRESIDENT: The question before the Senate is on the motion of the Senator from Sagadahoc, Senator Reed, that the bill and all accompanying papers be indefinitely postponed. A division has been requested. Is the Senate ready for the question.

All those in favor of the motion of the Senator from Sagadahoc, Senator Reed, that the bill be indefinitely postponed will rise and stand in their places until counted. A division was had.

Twenty-three having voted in the affirmative and five in the negative, the motion prevailed and the bill was indefinitely postponed.

The adjournment order having been received from the House, the Senate adojurned until Tuesday next at 10:00 A.M.
