#### SENATE

Monday, January 6, 1964

In compliance with a Proclamation of His Excellency, Governor John H. Reed, the Senators convened in the Senate Chamber at four o'clock in the afternoon, Eastern Standard Time, and were called to order by the President.

Prayer by the Rev. Douglas H.

Robbins of Augusta.

The Secretary read the Proclamation:

> STATE OF MAINE PROCLAMATION BY THE GOVERNOR

WHEREAS, it appears advisable that the Legislature of this State should meet in special session for the following purposes:

To consider legislation relating to the apportionment of the House

of Representatives;

To consider legislation pertaining to the public assistance programs administered by the Department of Health and Welfare:

To consider legislation revising the Maine Employment Security

laws;

To consider any other legislation to promote the general welfare of

the State.

NOW, THEREFORE, I, John H. Reed, Governor of the State Maine, by virtue of the power vested in me as Governor, convene the Legislature of this State. hereby requiring the Senators and Representatives to assemble their respective chambers at Capitol at Augusta on Monday, the sixth day of January, 1964, at four o'clock in the afternoon in order to receive such communication as may then be made to them and to consider and determine on such measures as in their judgment will best promote the welfare of the State.

#### STATE OF MAINE

Office of the Secretary of State To Chester T. Winslow, Secretary of the Senate of the One Hundred and First Legislature:

In compliance with Section I of Chapter 10 of the Revised Statutes of 1954, I hereby certify that on November 5, 1963, a special election was held in the County of Knox for the purpose of filling a vacancy caused by the resignation of Carl M. Stilphen of Rockland. According to a tabulation of the returns of votes made by the Secretary of State and reviewed and accepted by the Governor and Council on November 20, 1963.

Albert W. Hoffses of Camden received 2,464 votes; Hugo A. Lehti-

nen Sr., of Saint George received 1,995 votes.

Albert W. Hoffses of Camden, having received a plurality of the votes cast, is apparently elected Senator therefor.

The President appointed Senator Sproul of Lincoln to escort newly elected Senator Hoffses of Knox to the Council Chamber to subscribe to the oath of office before the Governor and Council.

Subsequently, Senator Hoffses of Knox was escorted to his chair in the Senate Chamber, having subscribed to the oath of office before the Governor and Council.

#### ROLL CALL

The roll being called, the following Senators responded to their names: Atherton, Boardman, Boisvert, Brewster, Brooks, Brown, Campbell, Christie, Cole, Couture, Cram, Edmunds, Farris, Ferguson, Harrington, Hichborn, Hinds, Hoffses, Jacques, Johnson, Kimball, Letourneau, Lovell, Marden, Noyes, Philbrick, Pike, Porteous, Reed, Sproul, Stitham, Whittaker, Wyman.

33 Senators having answered to the roll call, the Secretary declared that a quorum was present.

On motion by Mr. Edmunds of Aroostook

ORDERED, that a message be conveyed to the House of Representatives informing that body that a quorum of Senators is present for the consideration of such business as may come before the Senate.

Which was read and passed, and Mr. Edmunds of Aroostook conveyed the message.

Subsequently, a message was received from the House of Representatives through Representative Tyndale of Kennebunkport, informing the Senate that a quorum is present for the consideration of such business as may come before the House.

On motion by Mr. Cole of Waldo

ORDERED, that a message be sent to His Excellency, the Governor, informing him that in obedience to his Proclamation a quorum of Senators is assembled in the Senate Chamber for the consideration of such business as may come before the Senate.

Which was read and passed.

The President appointed Senators: Cole of Waldo, Wyman of Washington, and Jacques of Androscoggin to convey the message.

The Committee retired and subsequently reported that they had delivered the message with which they were charged.

On motion by Mr. Hoffses of Knox

ORDERED, that a message be sent to the House of Representatives proposing a Joint Convention to be held forthwith in the Hall of the House of Representatives for the purpose of extending an invitation to the Governor to attend the Convention and present such communication as he may be pleased to make.

Which was read and passed.

The Secretary conveyed the message.

Subsequently a message was received from the House of Representatives, through Mr. Pease, its Clerk, concurring in the foregoing proposition for a Joint Convention.

The Senate then proceeded to the House of Representatives where a Convention was formed.

#### In Senate

The Senate was called to order by the President.

On motion by Mr. Edmunds of Aroostook, out of order

ORDERED, the House concurring, that unless received by unanimous consent in both branches, no bill or resolve be considered at this Special Session except those designated Legislative Documents Nos. 1601 to 1664 inclusive, and such bills or resolves as may be returned by or recalled from the Governor.

This order shall not apply to such bills or resolves as are intended only to facilitate the business of the Special Session (S. P. 681)

Mr. WHITTAKER of Penobscot: Mr. President, I should like to speak against passage of this order at this time. Is it permissible to debate this issue?

The PRESIDENT: The Senator may debate the order.

Mr. WHITTAKER: Mr. President and members of the Sen-ate: There are a group of peo-ple in Penobscot County, and I dare say in other counties of the State, who are much interested in legislation which would not be permitted before this body if this order is passed. I refer to a bill which I sponsored in the regular session of the legislature concerning discrimination in rental housing. There has been a great deal of interest in this matter very recently; there have been developments, in my opinion since the close of the regular session which warrant reconsideration of this matter in the special session. Opportunity was given to me to present this matter to the Committee on Reference of Bills, and what I have to say is not to be thought of as criticism of this committee. It was a difficult decision which they made, according to press reports, and the vote was four to three against inclusion of this particular bill in the special session. When I came here today I did not realize that this particular order would be presented today. It was my opinion, wrongly of course, that the matter would be presented on Wednesday and that that would be the first day of business. When I have finished my comments I am going to suggest that if it is the will of any of you that this matter be postponed until next legislative day so that I, and perhaps others who are interested in this particular matter, may have an opportunity to present for your consideration, as the Senate of the State, the question of whether or not there are emergency situations which warrant reconsideration of this matter at this time. I realize that the hour is late, yet I must speak now or forever hold my peace. May I take then just a few moments to review the history of this particular bill in which I am interested. It was passed, as you recall, in this body, but was defeated on final passage in the other body by a vote of 66 to 58, with 26 members recorded as absent. Now there has been publicity given recently by a member of the other body to the effect that the conference committee on this particular bill has never submitted its report to this legislature. This is essentially true but I am not inclined myself to try to revive the bill through the suggested procedure of calling for a report of the conference committee. I believe that the substance of this bill is of sufficient emergency nature so that it warrants fuller consideration by this body than could possibly have been given by the Committee on Reference of Bills in a one-day Again, this is no criticism of the committee. They handled over 100 bills in one day and made decisions concerning them. but obviously in such a situation it was not possible for the committee to consider all of the details involved in all of the bills submitted. May I then, in support of the idea which I am attempting to present to you, make this further statement:

The issue of civil rights in the United States is more crucial to-day than it was even last June. The climate of public opinion in favor of legislation in this field has been especially evident since the assassination of President John

F. Kennedy. I believe that the Maine Legislature should be given an opportunity in the special session to review L. D. 1169 in the light of developments since the close vote of June 18th. I hope to convince you that the proposed law to eliminate discrimination in rental housing qualifies as emergency legislation in a nation where every day increasing racial tension threatens to ignite a social explosion.

An emergency exists whenever advertised rental housing is denied to an applicant on the basis of race, color, religious sect, creed, class, denomination, ancestry or national origin. So far as Maine is concerned there is ample evidence that such emergencies do occur frequently. On March 25, 1963, the Maine Advisory Committee to the United States Civil Rights Commission held an open meeting in Portland to hear complaints about discrimination in rental housing. The record of the hearing contains 52 pages of testimony on the existence of such discrimination in the Portland and Auburn-Lewiston areas. On December 12, 1963, the Bangor-Brewer Council of Churches issued a public pronouncement deploring racial discrimination in the Bangor-Brewer community; the statement said in part: "We call upon local landlords and real estate agents to eliminate race from the criteria used in determining the suitability of prospective tenants, and urge the residents of our community to welcome persons of every race as neighbors.'

The issue of civil rights constitutes a national emergency and was recognized as such by President John F. Kennedy. It is possible that his strong stand against racial discrimination was one factor in the circumstances which resulted in his assassination. President Lyndon B. Johnson, in his first address to the United States Congress, gave top priority to the passage of a civil rights bill. His words are pertinent to the situain Maine. Said President Johnson: "We have talked long enough in this country about equal rights. We have talked for 100 years or more. It is time now to write the next chapter, and to write it in the books of law. "I urge you," said the President, "to enact a civil rights law so that we can move forward to eliminate from this nation every trace of discrimination and oppression that is based upon race or color. There could be no greater source of strength to this nation both at home and abroad."

And then, finally, I want to make this point perfectly clear: elimination of discrimination is not a party issue. I speak as a Republican here today, but Republicans and Democrats have a joint responsibility to remove this evil from our American society. Party affiliation had no bearing upon the overwhelming vote of Maine citizens when they recently adopted - and this was done since the regular session — an amendment to the State Constitution whereby "No person shall be denied the enjoyment of his civil rights or be discriminated against in the exercise thereof." In my opinion the 101st Maine Legislature should be given an opportunity to apply this general constitutional principle to the specific problem of discrimination in rental housing. Therefore I urge you to make possible such an opportunity. It has often been true that "as Maine goes, so goes the nation." The special session affords Maine the privilege of national leadership in the passage of civil rights legislation. Such action would not only relieve an emergency situation within State but would be a fitting memorial to President John F. Kennedy.

Therefore, Mr. President, I must oppose passage of the order at this time, and I should hope that one of my colleagues might be moved to table this until the next legislative day.

The PRESIDENT: The question before the Senate is on the motion of the Senator from Aroostook, Senator Edmunds, that the cloture order received a passage.

Mr. JOHNSON of Somerset: Mr. President, I move that the order

be tabled until the next legislative day.

Mr. EDMUNDS of Aroostook: Mr. President, I request a division.

A division of the Senate was had.

Nine having voted in the affirmative and twenty-three opposed, the motion to table did not prevail.

Thereupon, the order received a passage and was ordered sent forthwith to the House for concurrence.
