Tuesday, January 26, 1965

The House met according to adjournment and was called to order by the Clerk.

Prayer by Brigadier William O. Wilbur of the Salvation Army, Augusta.

The members stood at attention during the playing of the National Anthem.

The CLERK: The Chair recognizes the gentleman from Milbridge, Mr. Kennedy.

Mr. ANDERSON: Mr. Speaker, Ladies and Gentlemen of the House: I think this Resolution was one of the finest gestures this House has ever offered. I commend the gentleman from Lewiston, Mr. Jalbert.

WHEREAS the members of this 102nd Legislature who had the honor of serving with him feel a very personal loss in his passing, and recall the years that the Sewall family were in the Blaine House as some of the happiest years of public service;

NOW THEREFORE, BE IT RE-SOLVED that the State of Maine mourns the loss of a beloved and valued leader, and the members of the 102nd Legislature lament the passing of one of Maine's outstanding citizens;

In his passing, the City of Bath, and the State of Maine, have lost one of their truly outstanding citizens. It is with deep regret that I now move that this Resolution receive passage in concurrence.

Whereas, the State Probation Parole Board performs a most essential function of State Government: and

Whereas, the following legislation is vitally necessary for such functions to be carried out in an efficient and effective manner: and

Whereas, in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of Maine, and require the following legislation as immediately necessary for the preservation of the public peace, health and safety; now, therefore.'

Further amend said Bill by adding at the end, the following:

'Emergency clause. In view of the emergency cited in the preamble, this Act shall take effect when approved.'

Committee Amendment was adopted and the Bill assigned for third reading tomorrow.
