Thursday, January 28, 1965

As you know, I am to be sworn in on Friday, January 29th, as a Complaint Justice in the M a i n e District Court. Attorney General Dubord has ruled that this position and that of Representative to the Legislature are incompatible, therefore it is with deep reluctance that I hereby submit my resignation as a Representative to the 102nd Maine Legislature, effective immediately.

Mr. KNIGHT: Mr. Speaker, Ladies and Gentlemen of the House: Regretfully this will be the last time that I will have the privilege of speaking to you as a member of the 102nd Legislature. Tomorrow I will take the oath as a Complaint Justice in the District

Court at Rockland. It is not possible for one to hold the position of Representative to the Legislature and at the same time hold a judicial position.

It has been my privilege to be a member, not only of this 102nd Legislature but of the previous three Legislatures. I will remember the 99th, 100th, and 101st Legislatures for many reasons, including foremost, the many friendships that I have made. The thing that impresses me most with this, the 102nd Legislature, is the spirit of enthusiasm. This is an essential element for a productive session. Now I wish you all success in the legislative days ahead and may these days bring happy memories for you. (Applause, the members rising)
