WHEREAS, funds for vocational rehabilitation within the Department of Education are depleted by present programs: and

WHEREAS, there is a waiting list of 800 disabled persons who could be put back into the working ranks to become self-support-

ing; and

WHEREAS, a transfer of funds from other divisions within the Department of Education could alleviate this emergency; and

WHEREAS, this has been done in previous years, to meet other

needs; and

WHEREAS, the Department is in favor of this transaction; now,

therefore be it

ORDERED, that the Governor and the Executive Council be ordered to authorize this change to meet this grave emergency facing handicapped persons of our state awaiting re-training for our work forces; and be it further

ORDERED, that the Governor and Council authorize the transfer of \$5,000 of unused funds in other divisions, which will be matched by \$10,000 federal funds to boost our state economy.

The SPEAKER: The Chair recognizes the gentleman from Houl-

ton, Mr. Berman.

Mr. BERMAN: Mr. Speaker, I have looked over this order which has been reproduced and distributed under the direction of the Clerk, and I certainly think that the subject matter is worthy of consideration. However, our would suggest that this order might pose a basic constitutional question; namely, whether this House of Representatives may properly order the Executive authority to make a change which is within Executive jurisdiction, and for that reason, I would suggest that we look into this matter carefully before voting on it.

The SPEAKER: The Chair recognizes the gentleman from Perham, Mr. Bragdon.

Mr. BRAGDON: Mr. Speaker, if I would be in order, I would

move that this order be referred to the Committeee on Appropriations and Financial Affairs.
