Mr. LIBHART: Mr. Speaker, I rise in regard to item 7 on page 3, Bill "An Act relating to Free Public Access to Waters Stocked with Fish Raised by State," House Paper 735. I would like to ask reconsideration of the assignment of this bill to the Committee on Inland Fisheries and Game and suggest that it be referred to the Committee on Judiciary.

The SPEAKER: The gentleman from Brewer, Mr. Libhart, moves that we reconsider our action whereby this bill was referred to the Committee on Inland Fisheries and Game. Is this the pleasure of the House?

The motion prevailed.

The SPEAKER: The Chair now recognizes the gentleman from Milbridge, Mr. Kennedy.

Mr. KENNEDY: Mr. Speaker, through the Chair I would like to inquire of the gentleman from Brewer, Mr. Libhart, his reasons for changing the assignment of this bill.

The SPEAKER: The gentleman from Milbridge, Mr. Kennedy, poses a question to the gentleman from Brewer, Mr. Libhart. He may answer if he so desires.

Mr. LIBHART: Mr. Speaker, my purpose is that — I have not read the bill because it has not been printed, but I would take from its title that it is primarily concerned with the right to access either over public or private lands and has nothing to do actually with our fishing laws. If this is the case, then, it belongs in Judiciary rather than in the Fish and Game.

The SPEAKER: The question before the House now is the motion of the gentleman from Brewer, Mr. Libhart, that this matter be referred to Committee on Judiciary, ordered printed and sent up for concurrence. Is this the pleasure of the House?

Whereupon, on motion of Mr. Carroll of Limerick, the Bill was tabled pending reference and specially assigned for the next legislative day.

Mr. Kittredge of South Thomaston was granted unanimous consent to briefly address the House.

Mr. KITTREDGE: Mr. Speaker, Ladies and Gentlemen of the House: Towards the end of yesterday's session I made a motion to reconsider an order which had been brought before the House. In making this motion I was motivated by principle and not by partisan politics. The principle involved was simply that I do not believe matters pertaining to money should be acted on by this House before they have been reduced to writing, printed and promulgated to the membership. Now

in order to prove that this was my motivation, I would respectfully invite one of my Democrat colleagues to join with me after today's session in sponsoring legislation to revise the salary of the Clerk of the House by law rather than by order.

"'Any youth whose parent or guardian maintains a home for his family in an administrative unit that maintains, or contracts for school privileges in, an approved secondary school in which the average daily membership, as reported in the preceding year, is less than 100 students and who has met the qualifications for admission to the high school in his town, may elect to attend some other approved secondary school in the State to which he may gain admission for the purpose of studying or of completing a sequence of courses in mathematics, science, a foreign language or the social studies not offered or contracted for by the administrative unit of his legal residence. Except in case of change in the legal residence of the student to a different administrative unit, transfer from one secondary school to another may be made only at the beginning of the school year."

Mr. GRAHAM: Mr. Speaker, I move the acceptance of the Minority Report.

The SPEAKER: The gentleman from Freeport, Mr. Graham, moves we accept the Minority "Ought to pass" Report. The gen-

tleman may proceed.

Mr. GRAHAM: Mr. Speaker, this is permissive legislation, not mandatory. School conditions Pownal are deplorable. There are five one-room schoolhouses; water, no toilets. Forty-three children in four grades are crammed into one room in several cases. The Town of Pownal has tried to get into a school district with every surrounding town and been rebuffed. Pownal is making the biggest tax effort in Cumberland County and twice the effort of some towns. Only by allowing Pownal to become a one-town school district can that town be able to build one decent school. Neither the so-called equal effort tax plan in education nor the Maine School Building Authority can help Pownal to build a decent school. I therefore believe that this bill is absolutely essential.

The SPEAKER: The question before the House is the motion of the gentleman from Freeport, Mr. Graham, that we accept the Minority Report. Is this the pleasure of the House?

Thereupon the Minority "Ought to pass" Report was accepted, the Bill read twice and assigned the next legislative day.
