Mr. KITTREDGE: Mr. Speaker, I move that the Minority Report "Ought to pass" be accepted by the House.

The SPEAKER: The gentleman from South Thomaston, Mr. Kit-

tredge, now moves that we accept the Minority "Ought to pass" Report.

The Chair recognizes the gentleman from Portland, Mr. Edwards.

Mr. EDWARDS: Mr. Speaker, I call for a division of the House.

The SPEAKER: The gentleman is in order. He may proceed.

Mr. JALBERT: Mr. Speaker and Members of the House: At a very early date of the session I attempted to table and asked for a division on the timing of a tabling motion. I did it because the motion had a nine to one "Ought not to pass" Report on it. Very obviously, in my opinion, whereas we are on timing, it is very seldom that if you can't convince only one member of the committee, that you are going to convince a hundred and fifty other members of the House.

I am speaking on time, based on the fact that we now are here and we have got plenty of time to do some of these things. Т am speaking again on time, that later on when it gets nice and sunshiny and it's time for planting and for this and that we may wish we had not gone through such a procedure. So that my reason for tabling until Thursday to speak on time is merely to say that this thing is going down anyway, so why not do it now. save some time and save some money that is involved in the printing of a tabling motion.

In order for that explanation to straighten itself out so that somebody won't come up to me and say why don't you want to be a gentleman, I have straightened that situation out here and now. I now withdraw my motion.

The SPEAKER: The Chair will announce the vote.

Seventy-two having voted in the affirmative and fifty-four having voted in the negative, the tabling motion did prevail. The Reports and Resolve were tabled pending the motion of Mr. Kittredge of South Thomaston to accept the Minority "Ought to pass" Report and specially assigned for tomorrow.

HOUSE AMENDMENT "A" to H. P. 8, L. D. 8, Bill, "An Act Clarifying Excise Taxes and Fees for Camp Trailers." Amend said Bill by striking out all of the last underlined paragraph and inserting in place thereof the following:

"A-1. Camp trailers. For the privilege of operating a camp trailer upon the public ways, each camp trailer to be so operated shall be subject to the excise tax provided for house trailers, except that the minimum tax shall be \$5.""

# Finally Passed Constitutional Amendment

Resolve Proposing an Amendment to the Constitution to Eliminate Voting Restrictions on Paupers (H. P. 9) (L. D. 9)

Was reported by the Committee on Engrossed Bills as truly and strictly engrossed. This being a Constitutional Amendment and a two-thirds vote of the House being necessary, a division was had. 124 voted in favor of same and 9 against, and accordingly the Resolve was finally passed, signed by the Speaker and sent to the Senate.

Is it now the pleasure of the House that this matter be referred to the Committee on Appropriations and Financial Affairs, ordered printed and sent up for concurrence?

The motion prevailed.
