HOUSE

Friday, February 12, 1965

The House met according to adjournment and was called to order by the Speaker.

Prayer by the Rev. Mr. Robert Canfield of Gardiner.

The journal of yesterday was read and approved.

Eulogy to the Great Emancipator, The Immortal Abe Lincoln.

Mr. RICHARDSON: Mr. Speaker, Ladies and Gentlemen of the House: This is the first time in the two terms that I have served in this honorable body that I have seen strictly un-American and pro-foreign legislation introduced for our consideration. This bill in essence favors foreign imports of fish to the detriment of our American fishermen. I have had dozens of letters and calls from those good American fishermen, received since the hearing on this bill, opposing it. I do not believe that the Members of this House want to promote legislation which is bad for the American fishery, and I therefore at this time move that this bill and all its accompanying papers be indefinitely postponed.

The gentleman The SPEAKER: from Stonington, Mr. Richardson, now moves that this bill and accompanying papers be indefinitely postponed.

The Chair recognizes the gentleman from Lubec, Mr. Pike.

Mr. PIKE: Mr. Speaker I am afraid there is a real misunderstanding about this bill. It is now legal, under our present law, to pack foreign fish in Washington County. This comes from a Court decision last December. The power to control the packers for quality and so forth, rests with the Department of Agriculture, which, under the present law only operates - this license operates from April 15 to December 1. During the period between those dates it has no power of suspension or revocation of licenses. This law merely gives the Agriculture Department its ordinary power to suspend or revoke during that period. It has nothing to do with the catching of fish whatsoever. If passed, it will not change a single thing about our American fishermen or foreign fishermen. If not passed, it will merely mean that the Agriculture Department does not have its inspection powers between those several dates.

I therefore hope that the motion to indefinitely postpone does not prevail.

The SPEAKER: The Chair recognizes the gentleman from Brewer, Mr. Libhart.

Mr. LIBHART: Mr. Speaker, Ladies and Gentlemen of the House: We have another bill coming up when Mr. Mills returns, L. D. 104, and I will be offering an amendment to it at that time. I agree with my colleague, the gentleman from Lubec, Mr. Pike, that L. D. 103 would do no violence to anything we might do with regard to L. D. 104. I can see no damage being done if we pass this bill now, and I agree with him that there is some misunderstanding as to what L. D. 103 does, and I think he has correctly stated what it will do, and even though I will be with my colleague, the gentle-man from Stonington, Mr. Rich-ardson when we talk about 104, I hope we will defeat this motion of his

The SPEAKER: The question before the House is the motion of the gentleman from Stonington, Mr. Richardson, that "An Act relating to License for Sardine Pack-ers," Legislative Document 103, be indefinitely postponed. Mr. Pike of Lubec asked for a

Ninety-three having voted in the affirmative and twenty-eight having voted in the negative, the motion prevailed. Sent up for concurrence.

The Chair laid before the House the fourteenth tabled and today assigned matter:

HOUSE REPORT — "Ought to pass" as Amended by Committee Amendment "A" — Committee on Liquor Control on Bill "An Act Providing for Adult Identification Cards Under Liquor Law." (H. P. 149) (L. D. 172)

Tabled — February 11, by Mrs. Carswell of Portland.

Pending — Motion of Mr. Poulin of Skowhegan to reconsider indefinite Postponement of Report and Bill.

The SPEAKER: The Chair recognizes the gentleman from Moscow, Mr. Beane.

Mr. BEANE: Mr. Speaker and Ladies and Gentlemen of the House: The Committee on Liquor gave long and careful consideration to this bill and finally reported it out unanimously "Ought to pass." I would like to present to you some of the reasons why I presented the bill and why I think it is a good bill.

In 1964 there were 305 total licensee hearings. There were 164 licensee hearings involving minors. A little more than 53 percent of the total hearings involved licensees or their agents concerning minors. This is not a pretty picture. Let me give you some figures for 1964 concerning minors in state courts on various liquor charges. Illegal possession — 404, illegal consumption — 2, illegal transportation — 146, procuring liquor for minors — 53.

About 35 percent of the entire commission enforcement division's official duty hours were expended on this minor problem. Just picture if you can, the number of enforcement manpower hours that would be expended on this problem if all agencies could account for their official hours.

I feel that any enforcement agency, any person in charge of school records, marriage records, church records, state, city and town records, will assist when requested for date on birth records of those requesting the ID cards.

I do not claim that this system will be foolproof, but will greatly assist in enforcing our liquor laws, and if our minor problems are cut in half or say even one-third, it will be worth every effort expended to perfect the ID system.

Let me say at the outset our first step is to prevent minors from getting liquor. I feel we are on the right track.

For those, and there are those who may have the idea that this system is only another safeguard or a protection for the licensees, please let me be clear in this matter. The licensee will have no excuse to violate for he only has to ask the youthful customer for the state ID card. No sympathy will be extended to the licensee who fails to ask for the ID card. The bill itself is pretty much self-explanatory.

There are at least six other states utilizing ID cards to curb minors with liquor and all report it is very successful and becoming more and more acceptable.

The ID card with a picture will be laminated in such a manner as to prevent alteration which, if attempted, can easily be detected.

The issuance of a state ID card will assist in tightening up what was a loose end in the enforcement field of our minor problem with liquor.

This is an important step which is being advanced to this body. I feel that the entire Legislature has a tremendous responsibility in arriving at a decision concerning this bill, for there is not one community in the state who has not had this problem to contend with.

I have prepared an amendment which is on your desk which should remove the undesirability of L. D. 172. I hope the motion to reconsider does prevail.

The SPEAKER: The Chair recognizes the gentleman from Brewer, Mr. Libhart.

Mr. LIBHART: Mr. Speaker, Members of the House: I think difficulties yesterday that our were primarily directed towards the proposed amendment to this bill and to the fact that the bill itself did not give the judge who would be hearing the case any discretion whatsoever in imposing a fine. I think Mr. Beane's amendment is a good amendment. I think that we must also, if we reconsider, I think that we must also not accept the committee amendment. The committee amendment would, for example, if I were asked to produce an ID card and I did not produce one, make prima facie evidence that I was under twenty-one, and regardless of how much I would like this to happen, this bill can't do it.

I would favor the bill provided the new amendment is adopted and the old amendment defeated.

The SPEAKER: The Chair recognizes the gentleman from Lubec, Mr. Pike. Mr. PIKE: Mr. Speaker, Members of the House: I am afraid that my thunder has been stolen. I should be immensely complimented if missing an i den ti ty card I were proved to be under twenty-one, but I think it would be a little on the ridiculous side. So, I think that amendment is just wrong in principle and wrong in practice.

The SPEAKER: Is the House ready for the question?

The Chair recognizes the gentleman from Moscow, Mr. Beane.

Mr. BEANE: Mr. Speaker, Ladies and Gentlemen: If this motion to reconsider prevails, then I will make a new motion to substitute the bill for the report.

The SPEAKER: The question before the House now is in the motion of the gentleman from Skowhegan, Mr. Poulin, to reconsider our action whereby we indefinitely postponed this bill and its accompanying papers. Is the House ready for the question? All those in favor that we reconsider our action whereby this was indefinitely postponed say aye; those opposed, no.

A viva voce vote being taken, the motion prevailed.

The SPEAKER: The Chair understands now that the gentleman from Moscow, Mr. Beane moves that we substitute the Bill for the Report. Is this the pleasure of the House?

The motion prevailed.

Thereupon the Bill was read twice and assigned the next legislative day.

The Chair laid before the House the fifteenth tabled and today assigned matter:

Tabled — February 11, by Mr. Crommett of Millinocket.

Pending — Passage to be Enacted.

The Chair recognizes the gentleman from Millinocket, Mr. Crommett.

Mr. CROMMETT: Mr. Speaker, I move that Legislative Document 157 and all its accompanying papers be now indefinitely postponed. The SPEAKER: The gentleman from Millinocket, Mr. Crommett, now moves that Legislative Document 157 and its accompanying papers be indefinitely postponed. Is it the pleasure of the House?

The Chair recognizes the gentleman from Skowhegan, Mr. Poulin.

Mr. POULIN: Mr. Speaker, I believe Mr. Brown was a Representative at the hearing of the Fish and Game Committee. It was explained to them at the time the reason they wanted this, there was a mistake made on publication. The way the bill reads now, the Commissioner would be authorized to do just as he wants. Why he wants this, I don't know.

The SPEAKER: The question before the House is on the motion of the gentleman from Millinocket, Mr. Crommett, that this bill and its accompanying papers be indefinitely postponed.

The Chair recognizes the gentleman from Millinocket, Mr. Crommett.

Mr. CROMMETT: Mr. Speaker, Members of the House: Legislative Document 157 is my bill and through the courtesy of the Department of Inland Fish and Game they helped me to prepare this bill, and known only to God and the Department, they also offered an amendment which doesn't mean anything. In fact, it defeats the purpose. Now I understand that Mr. Poulin, the gentleman from Skowhegan, has a bill that will do that which I intended for my bill to do, and with an amendment to his bill if it is not already incorporated will do exactly what I wish to do. Now rather than to have this carried through, I think it will save a little bit of money to indefinitely postpone it.

The SPEAKER: The Chair recognizes the gentleman from Glenburn, Mr. Cookson.

Mr. COOKSON: Mr. Speaker, I think the gentleman from Millinocket, Mr. Crommett is entirely right in his action here and I wish to support him. I think it is going to be accomplished by other legislation.

The SPEAKER: The question before the House now is on the motion of the gentleman from Millinocket, Mr. Crommett that this bill and its accompanying papers be indefinitely postponed. Is the House ready for the question? Is it the pleasure of the House that this bill and its accompanying papers be indefinitely postponed? All those in favor say aye; those opposed, no.

A viva voce vote being taken, the motion prevailed. Sent up for concurrence.
