Mr. BREWER: Mr. Speaker, in view of the fact that the Attorney General has requested a little more time to render a decision that has been requested of him, I would request the gentleman

The Chair recognizes the gentleman from Ellsworth, Mr. Anderson.

Mr. ANDERSON: Mr. Speaker, Ladies and Gentleman of the House: I wonder how many of colleagues have thoroughly mv looked over this bill and realize its implications. The Education Department is very unhappy with it, but of course they are very unhappy with a great many bills. But in this case, I think their concern is justified. Up to now this bill has had clear sailing. However, from study I found it to be a shared time bill to subsidize private education. This bill in effect subsidizes private schools indirectly about \$58 per every course taken per pupil, per year. Other states have tried this; they find that first, shared time is unconstitutional according to the general understanding of the first amendment. Second. the administrative problems are insurmountable. Third, shared time has a detrimental effect on public schools, also a detrimental effect on parochial schools. Shared time is not a solution to the public and parochial school controversy over federal aid to education. These conclusions have been published by the Research Division of the National Education Association. Therefore, Mr. Speaker, I ask for indefinite postponement

of this bill and request a division.

The SPEAKER: The question before the House now is on the motion of the gentleman from Ellsworth, Mr. Anderson, that this bill and its accompanying papers be indefinitely postponed.

The Chair recognizes the gentleman from Limerick, Mr. Carroll.

Mr. CARROLL: Mr. Speaker, this bill was heard by your Education Committee and this bill received an unanimous "Ought to pass" report. It seems to me that we are back at the same old place doing the same old tricks again. Now this bill is a good bill and we have heard the pros and cons on this bill. This bill should be passed because this part-time-this so-called shared time, we go right back to the same old thing all the time. This isn't parochial, this is helping private schools. We are trying to educate the children of the State of Maine and I don't care what school they go to. I think that these children are entitled to have all the facilities of this State at their disposal. They have to go out and compete with all other children all over the world and we want to make this opportunity for them so that they can have part-time courses, they can go to another school and get what their school does not offer. I feel that this bill should be passed and it should not be tabled.

The SPEAKER: The Chair recognizes the gentleman from Madawaska, Mr. Levesque.

Mr. LEVESQUE: Mr. Speaker and Ladies and Gentlemen of the House: I think Mr. Carroll has pointed out something, that the Committee on Education has heard this bill and at no time during the hearing on this matter was there any indication on anybody's part that this was going to be in any way affecting the first amendment of the Constitution. This bill is perfectly in order and there is absolutely no doubt that this is constitutional and that if this is the only thing that the State of Maine is going to help to do that would be un-

constitutional by helping any of these students to get a fair share of their education, and only you as ladies and gentlemen of this House will know that we are not doing a hundred per cent effort to educate all of our students. So I believe that if we can do this little fair share on our part to make sure that all the students regardless of what school they are going to should get this fair share. This is something that we owe to them. Thank you.

The SPEAKER: Is the House ready for the question? The question before the House is on motion of the gentleman from Ellsworth, Mr. Anderson, that this bill and its accompanying papers postponed. All be indefinitely those in favor of this bill and its accompanying papers being indefinitely postponed will kindly rise and remain standing until the monitors have made and returned the count.

A division of the House was had.

One having voted in the affirmative and one hundred twenty-six having voted in the negative, the motion for indefinite postponement did not prevail.

Thereupon, the "Ought to pass" Report was accepted in concurrence and the Bill read twice.

Committee Amendment "A" was read by the Clerk as follows:

AMENDMENT COMMITTEE "A" to S. P. 59, L. D. 120, Bill, "An Act Relating to Part-Time School Attendance."

Amend said Bill by adding at the end thereof the following:

"Sec. 3. R. S., T. 20, § 3721, amended. The last paragraph of section 3721 of Title 20 of the Revised Statutes is amended bv adding at the end, a new sentence, as follows:

'Pupils attending school on part-time basis shall be counted as .2 of a pupil for each class period which they attend."

Sec. 4. R. S., T. 20, § 3722, amended. The 3rd paragraph of the Revised Statutes is amended by adding at the end, a new sentence, as follows:

'Pupils attending school on a part-time basis shall be counted

as .2 of a pupil for each class period which they attend.'

Sec. 5. R. S., T. 20, § 3723, amended. The 2nd paragraph of section 3723 of Title 20 of the Revised Statutes is amended bv adding after the 2nd sentence, a new sentence, as follows:

'Pupils attending school on a part-time basis shall be counted as .2 of a pupil for each class which they attend.'

Committee Amendment "A" was adopted in concurrence and the Bill assigned for third reading the next legislative day.

Committee Amendment "A" was adopted and the Bill assigned for third reading the next legislative day.

The SPEAKER: In reference to House Paper 89, Legislative Document 98, An Act Relating to Pensions for Certain Retired Teachers, on February 17, we reconsidered our action whereby this had been engrossed on February 12. At that time on February 17 when we reconsidered our action, the rules should have been suspended and they were not. Is there any objection now to the action that we took on February 17? The Chair hears none.

The Chair laid before the House the matter tabled earlier in today's session by Mrs. Carswell of Portland:

Bill "An Act relating to State Retirement Benefits for Certain Teachers," H. P. 788, L. D. 931.

Mrs. Carswell of Portland offered House Amendment "A" and moved its adoption,

House Amendment "A" was read by the Clerk as follows:

HOUSE AMENDMENT "A" to H. P. 788, L. D. 931, Bill, "An Act Relating to State Retirement Benefits for Certain Teachers."

Amend said Bill, in the Title, by adding at the end before the period the following 'and Increasing Pensions for Certain Retired School Superintendents'

Further amend said Bill by inserting after section 1, the following:

"Sec. 1-A. R. S., T. 5, § 1121, sub-§ 2, ¶ G, additional. Subsection 2 of section 1121 of Title 5 of the Revised Statutes is amended by adding a new paragraph G to read as follows:

'G. Paragraph C shall apply to all superintendents employed in any public school who have been retired under an order issued by the Governor and Council and are now receiving benefits, providing such benefits are less than those authorized by said paragraph C.'"

The SPEAKER: The Chair recognizes the gentleman from Augusta, Mr. Katz. Mr. KATZ: Mr. Speaker, may

Mr. KATZ: Mr. Speaker, may I ask a question through the Chair to any member of the Committee, whether or not the appropriation which is attached to this bill is expanded by House Amendment "A"?

The SPEAKER: The gentleman from Augusta poses a question to any member of the House who may answer if he so desires.

The Chair recognizes the gentlewoman from Portland, Mrs. Carswell.

Mrs. CARSWELL: Mr. Speaker and Members of the House: first should explain how this happened. The Committee on Retire-ments and Pensions had a bill No. 100 and one of the members on the Committee thought that L. D. 931 would take care of 100, so we took his word for it. Later on when I got home I studied the bill and I saw that it would not take care of L. D. 100. This was superintendents and there are about four, so the sponsor of L. D. 100 is Sanford Jack Prince of Harpswell. I explained it to him and told him that the Committee was in favor of 100; however, they thought that another bill had taken care of it. So, Т told him that I would put an amendment in to take care of this omission.

The SPEAKER: The Chair recognizes the gentleman from Harpswell, Mr. Prince.

Mr. PRINCE: Mr. Speaker, Members of the House: Mrs. Carswell, the gentlewoman from Portland, has explained, I think, perhaps all that is necessary to say about this L. D. There are three or four aged superintendents in the State of Maine that in 1957 automatically received twelve hundred dollars in the retirement system. In '59 there was an amendment made and again another mistake which was supposed to include these aged teachers, so that any teacher that taught thirty-five years was increased to \$1550. Now all that this amendment is doing is putting these three or four aged superintendents in the category with the teachers that have taught the thirty-five years. Thank you.

years. Thank you. Thereupon House Amendment "A" was adopted, the Bill passed to be engrossed as amended and sent to the Senate.
