The SPEAKER: The Chair at this time would like to recognize in the balcony of the House members of the Intermediate Youth Group of the Riverview Congregational Church of South Gardiner who are accompanied by their leader, Mr. Ivan Boynton. They are the guests of the gentleman from Gardiner Mr. Hanson.

On behalf of the House the Chair welcomes you and we hope that your visit will be both educational and enjoyable. (Applause)

The SPEAKER: The Chair at this time would like to recognize in the rear of the House Brigadier General Clair H. Thurston, who is the Commanding General of the Maine State Guard and holds the rank of Brigadier General. He is retired from the United States Army and he is from Knox. Maine. He retired from the Army in 1962 after 30 years of service. He is a veteran of five major campaigns of World War II and four campaigns of the Korean War. He holds thirty-three decorations and citations awarded by the United States and foreign governments, including the Distinguished Service Cross.

The Chair would request the Sergeant-at-Arms to escort to the rostrum the Honorable Brigadier General Clair H. Thurston.

Whereupon, the Honorable Clair H. Thurston, Brigadier General, was escorted to the rostrum by the Sergeant-at-Arms amid applause of the House, the Members rising.

The SPEAKER: Is there objection if the gentleman has a few words to say to the House? The

Chair hears none. The Brigadier General may proceed.

BRIGADIER GENERAL THURSTON: Thank vou Speaker. Ladies and Gentlemen of the Maine Legislature: It is a privilege and a pleasure and a distinct honor for me and the organization I represent to be recognized by this body. I would like to take just a moment of your time to briefly report to you the progress we have made in the establishment of the Maine State Guard which you gentlemen authorized a few years ago. As you know, when the Berlin crisis came up, you authorized the establishment of a Maine State Guard as an adjunct and a supplemental military force to support the State of Maine in any emergency. That was activated on the 28th day of October of this year.

In four months we have, I am proud to say, been able to recruit almost a complete cadre for the Maine State Guard. We now have four battalions organized in the State, one in Portland, one in Lewiston, one in Bangor and one in Caribou. There is one more battalion to go and that is in the Waterville area. Our brigade headquarters and headquarters company is all organized in the Augusta area. I expect, gentlemen, to reach cadre strength by the middle of April and I am happy to report to you at that time I will promise you we will have a force in being that will be able to be used at the discretion of the Maine Government in any emergency.

This force, gentlemen, was established as I do not have to tell you, to fulfill the role of protection of the people of the State of Maine. A glance at the headlines, we are all aware, will show a need of forces in being. There is no time to organize once a crisis hits us. I would like to leave you with this thought-it may not be in the final analysis the role of dropping megatons on the enemy or how many megatons he drops on us that will decide the issue in an all out nuclear war. God forbid that it ever comes. But, if it does come, the ability of a nation and a state to stand up and take care of itself, to function and continue orderly government, maintain law and order, to live and exist, may be the deciding factor in a war. I leave you with that thought, gentlemen. I thank you for your support in maintaining and organizing the Maine State Guard. Thank you. (Applause)

The SPEAKER: On behalf of the House the Chair is most happy and the Chair thanks the gentleman for appearing before this body and we are honored to have such a distinguished guest. (Applause)

Thereupon, Brigadier General Thurston was escorted to the rear of the Hall of the House by the Sergeant-at-Arms.

WHEREAS, Representative Catherine Carswell requested an investigation of conditions in, and surrounding, licensed nursing homes, boarding homes, and children's homes in Maine, from the Attorney General, and

WHEREAS, circumstances would indicate that a further investigation of this matter is necessary for the protection and welfare of our citizens to determine whether the licensing procedures of the Department of Health and Welfare are adequate to protect these citizens and to correct any abuses existing, now, therefore, be it

ORDERED, that the Speaker of the House, the Majority Floor Leader and Assistant Leader; the Minority Floor Leader and Assistant Leader, along with Representative Carswell, are hereby constituted a special interim committee to study nursing homes, boarding homes, and children's homes; their operations, regulation and licensing; with the power to call summons witnesses records and to administer oaths: said committee to report its findings and recommendations to the 102nd Legislature; said Committee to have legislative immunity.

The SPEAKER: The Chair recognizes the gentleman from York, Mr. Erwin.

Mr. ERWIN: Mr. Speaker, Members of the House: With all due respect to the gentlewoman from Portland, Mrs. Carswell, this is an extraordinary order, and for the moment, if I may, I would like to speak to this order, to point out what I have seen in the few short minutes that I have been able to look at it.

In the first place the order supposedly is an order investigating licensing procedures, but it does a great deal more than investigate licensing procedure. It is obviously going to be a study in depth of nursing homes, boarding homes, children's homes, their operations, regulations and licensing. Now this normally, if the procedures of past legislatures are carried out, would be a major task for the Legislative Research Committee. This is a select committee. It is called an Interim Committee, and then it is stated in the order that it's to report to the 102nd Legislature; and I suggest that the Speaker and all of the Majority and Minority Leaders and Mrs. Carswell will be absent for the rest of the session on this particular investigation.

I think this perhaps needs a little bit more thinking and a little bit more careful language. Therefore, I am going to suggest that if perhaps the lady would like to table this order so we might clarify the objectives, it would be more helpful than a sudden automatic passage of something quite as different as this one seems to

The SPEAKER: The Chair recognizes the gentlewoman from Portland, Mrs. Carswell.

Mrs. CARSWELL: Mr. Speaker, Members of the House: Where the tabling matter is only a suggestion I believe that I can debate this.

The SPEAKER: The question before the House is the passage of the order. The gentlewoman may proceed.

Mrs. CARSWELL: Mr. Speaker, Members of the House: This investigation has been going on for months now, close to two months we'll say. I have cleared this order with the Attorney General. There is a special investigator working on this and where it has been cleared with the Attorney General, I feel that with the investigator working with the Committee it will not take a major amount of the Committee's time. This has also been cleared with the Speaker of the House, the Majority Leader and Assistant Leader, the Minority Leader and Assistant Leader, and I hope this matter does not become tabled.

The SPEAKER: The Chair recognizes the gentleman from Brownville. Mr. Ross.

Mr. ROSS: Mr. Speaker, Members of the House: As one of those involved in this order, all I can say is that all I know is what I read in the papers. If the conditions are as intolerable as the papers have made them out to be, I think something should be done immediately and I will support the order.

The SPEAKER: The Chair recognizes the gentleman from Cape Elizabeth, Mr. Berry.
Mr. BERRY: Mr. Speaker, Mem-

bers of the House: When the gentleman from York, Mr. Erwin, rises and brings up some legal matters, I for one would listen to him. If there is perhaps no precedent for extraordinary powers for a committee of this nature such as immunity, subpoeniing of witnesses, I think perhaps in view of the statement of the gentle-woman from Portland, Mrs. Cars-well, that the matter is already being investigated, that this order perhaps could well stand to be tabled for a day or two and remove if necessary these powers which perhaps it doesn't need if it already is investigating the matter. I would suggest that someone table this until the next legislative day and we can decide this over the weekend.

The SPEAKER: The Chair recognizes the gentleman from Brewer, Mr. Libhart.

Mr. LIBHART: Mr. Speaker, I move that this order be tabled until March 2.

The SPEAKER: The gentleman from Brewer, Mr. Libhart, now moves that this matter lie upon the table assigned for March 2.

Mrs. Carswell of Portland requested a division..

The SPEAKER: The gentle-woman from Portland, Mrs. Carswell, requests a division. All those in favor of this matter lying upon the table assigned for March 2 will kindly rise and remain standing until the monitors have made and returned the count.

Fifty-two having voted in the affirmative and sixty-eight having voted in the negative, the motion did not prevail.

Indefinitely Postponed

Mr. Roberts from the Committee on Inland Fisheries and Game reported "Ought not to pass" on Bill "An Act relating to Wearing Fluorescent Clothing When Hunting" (H. P. 698) (L. D. 936)

Report was read.

The SPEAKER: The Chair recognizes the gentleman from Bowdoinham, Mr. Millay.

Mr. MILLAY: Mr. Speaker, I would like to make a motion that the House does not accept the "Ought not to pass" Report and I would like permission to debate the matter briefly.

The SPEAKER: The Chair understands that the gentleman from Bowdoinham, Mr. Millay now moves that we substitute the bill for the report. The gentleman may proceed.

Mr. MILLAY: Mr. Speaker. and Gentlemen of the House: It's not that I expect this bill to pass, but I do think that certain things should be pointed out before we pass over it with routine procedures. I would like to point out that this law was passed in Massachusetts three years ago and since that time there has been not one single hunting accident in the case of being mistaken for game. In the State of Maine we have had not one single accident involving fluorescent clothing where people were mistaken for game.

Now the three main objections to this bill is one, that it interferes with our constitutional rights. I believe that this bill would certainly advance the safety of the people that are hunting in the woods. It is fundamental law that no constitutional guarantee is violated by such an exercise of the police power of the State when manifestly necessary intending to secure general and public benefits.

I believe hunting is a sport. My wife in the back of the room will certainly testify I do more of it than most, and the real enjoyment should come from just being able to participate. As in any sport it isn't whether we win or lose, but how we play the game. winning becomes more important than we are not willing to take good common sense safety measures, I say it is no longer a sport. So a few more deer escape by noting a flash of orange, it may mean that our children have a few more deer to hunt in their time. I think the idea of having game here in years to come is far more important than the idea that we must shoot a few more.

I am a registered guide and I would rather a deer got away than shoot a single human being. If it takes a little of the enjoyment out by being afraid that we may be shot while pursuing one of our favorite sports, I'd say the measure is justified and should be passed. I would like to see a division on this thing mainly to get the feeling of the House. I realize it will very likely not pass, but I would like to know how many of the members

of the House are really in favor of this measure. Thank you.

The SPEAKER: The gentleman from Bowdoinham, Mr. Millay has requested a division.

The Chair recognizes the gentleman from Belgrade, Mr. Sahagian. Mr. SAHAGIAN: Mr. Speaker, if I am in the right to speak on

this bill, I would like to briefly.
The SPEAKER: The gentleman
is in order. He may proceed.

is in order. He may proceed.
Mr. SAHAGIAN: Mr. Speaker,
Members of the House: This act,
L. D. 936, relating to wearing fluorescent clothing when hunting, this document, legislative document which calls for wearing fluorescent clothing when hunting affects every individual in our state. Many times we feel as legislators we can attempt correcting a situation by affecting all of our people at once. This is just such a bill. This bill would require every deer hunter in our State to wear fluorescent clothing. and in opinion, I think that that is just what this bill would do. opinion further, I have a question about the constitutionality of such a Ladies and gentlemen, you cannot legislate one's life in this State whereby you tell him what type of clothing he must wear when hunting deer in our Maine woods, and I have had a great deal of opposition from my area about this L. D. 936 and I would be remiss if I did not bring this to your attention and ask each and everyone of you to consider what this bill would do to individual rights of men. Thank you.

I would like to move for indefinite postponement of this bill with all its accompanying papers.

The SPEAKER: The question before the House now is on the motion of the gentleman from Belgrade, Mr. Sahagian, that this bill and all its accompanying papers be indefinitely postponed.

The Chair recognizes the gentleman from Skowhegan, Mr. Poulin.

Mr. POULIN: Mr. Speaker, Members of the House: This is in rebuttal. I go along with the idea, it's a good idea to have people wear certain clothing to identify themselves, but you've got lumbermen and different people who walk

through the woods that are not In other words, you hunters. would make them fair game if you made a mistake and shot one while he wasn't wearing the right cloth-The idea in itself is a good idea, but I don't believe you can make it compulsory unless you include any person going in any woods should have to wear their clothing hunting or not. This bill just says people hunting.

The SPEAKER: The Chair recognizes the gentleman from Ellsworth, Mr. Anderson.

Mr. ANDERSON: Mr. Speaker, Ladies and Gentlemen of the House: It has been said that the low percentage of accidents in Massachusetts was due to wearing of fluorescent clothing. I will remind you that in Massachusetts the season is much shorter, they use shotguns and the shotgun pellet will not carry further than a hundred yards; but down here in the State of Maine with our high-powered rifles they will go for miles. I support the motion for indefinite postponement.

SPEAKER: The The Chair recognizes the gentleman from

Bowdoinham, Mr. Millay.

MILLAY: Mr. Speaker. Members of the House: I would request a division on the indefinite postponement action to get the feeling of the House. I would rebut in this respect, that in Massachusetts the accidents that occurred the previous four years were four, two and three, showing that they did have accidents. That's about all.

Mr. Sahagian of Belgrade re-

quested a roll call.

The SPEAKER: Is the House ready for the question? The question before the House is on the motion of the gentleman from Belgrade, Mr. Sahagian, that this bill and its accompanying papers be indefinitely postponed, and the gentleman has requested the yeas and nays.

For the Chair to entertain a motion for a roll call vote it must have the expressed desire of onefifth of the members present. All those desiring a roll call vote will please rise and remain standing until the monitors have made and returned the count.

A sufficient number did arise.

The SPEAKER: Obviously less than one-fifth of the members having arisen a roll call vote is not in order.

A division has been requested. All those in favor of this Bill "An Act relating to Wearing Fluorescent Clothing When Hunting.' L. D. 936 and its accompanying papers being indefinitely postponed will please rise and remain standing until the monitors have made and returned the count.

A division of the House was had.

One hundred one having voted in the affirmative and thirty having voted in the negative, the motion prevailed.
