WHEREAS, both resolves require that the apportionment of Senators shall be on the basis of the last Federal Census, and

WHEREAS, the Legislature has determined, for the purpose of this Order, that the last Federal Census shows the population of the respective counties of this State be as set forth in Exhibit A, attached hereto and incorporated herein, and

WHEREAS, it appears to the members of the House of the 102nd Legislature that certain provisions of the foregoing resolves present important questions of law and the occasion is a solemn one;

NOW, THEREFORE, Be it Ordered, that in accordance with the provisions of the Constitution of the State, the Justices of the Supreme Judicial Court are hereby requested to give this Legislature their opinion on the following questions:

Report of Committee on Elections

Mr. Bishop from the House Committee on Elections to which was referred returns of votes cast for Representatives to the Legislature and Communication from Secretary of State relative to Special Elections, have had the same under consideration and ask leave to report that Thelma B. Cornell of Orono, Roland A. Gauthier of Sanford, Chester L. Burnham of Naples and Robert H. O'Gara of Westbrook were duly and legally elected members of the House of Representatives and entitled to seats therein.

Report was read and accepted and the members listed therein declared members of the House.

Mr. Martin from the Committee on State Government reported "Ought to pass" on Bill "An Act relating to Location of Legislative Conference Prior to the Convening of the 103rd Legislature" (H. P. 1214) (L. D. 1682) Report was read and accepted, the Bill read twice and tomorrow assigned.

The SPEAKER: The Chair recognizes the gentleman from Old Town, Mr. Binnette, and inquires for what purpose does the gentleman arise?

Mr. BINNETTE: Mr. Speaker, in regard to L. D. 1682, I believe at the last session that we had a similar document and that we turned it down. I therefore move for indefinite postponement of this bill.

The SPEAKER: The Chair recognizes the gentleman from Madawaska, Mr. Levesque.

Mr. LEVESQUE: Mr. Speaker and Members of the House: I think probably the gentleman from Madawaska, Mr. Binnette, is not quite informed as to what the contents of this bill is. It is only for the purpose that in case the renovation of the House is not ready for the first week in December at the end of this year, in order not to be in a bind with the construction or renovation of the House, this legislation was necessary in order to be assured that we were not trying to usurp the powers of the committee. If the House is renovated and ready, then the plans originated by the committee will be the same and the legislative conference will be in Augusta as planned.

The SPEAKER: The Chair understands that the gentleman from Old Town, Mr. Binnette, moves that we reconsider our action whereby this bill was assigned for third reading.

The Chair recognizes the gentleman from Enfield, Mr. Dudley.

Mr. DUDLEY: Mr. Speaker and Members of the House: On three very decisive occasions we decided at the previous session that we would like to have this pre-legislative conference in Augusta. True, what the gentleman from Madawaska, Mr. Levesque, has just told you, it does put it in the hands of the Legislative Research where it leaves it to their discretion.

I think we have already said, or I have before this body on many occasions, that if we couldn't have it here in Augusta, I see no need for it at all. I was here when we didn't have a pre-legislative conference at all and I was here when we had them in Augusta, and in Augusta we did find it very convenient; we met a lot of people and learned how to cope with new members and so forth, and we thought it was very handy. But frankly, having it in Orono, to me and to many others, I know, felt as though it was nothing but a super lobby job and I can get lobbied enough here in the Halls, and for that reason, I hope the House will go along with Mr. Binnette, the gentleman from Old Town, and if we can't have it here in Augusta we don't need it at all, and it costs it seems to me about \$30,000, and I am sure I didn't gain in that short time any knowledge or education so to speak, in Orono, and I think this \$30,000 could be better spent educating the Indians or some other method; anything. rather than just taking us up there and giving us a super lobby job. So I hope that the House

will go along and indefinitely postpone this bill, and if we can't have it here in Augusta, we won't have it at all and save \$30,000.

The SPEAKER: The Chair recognizes the gentleman from Milbridge, Mr. Kennedy.

Mr. KENNEDY: Mr. Speaker, Ladies and Gentlemen of the House: I hope that we won't do anything here today that will obstruct the pre-legislative conference.

Now if this is left in the hands of the leadership and the Research Committee, and the House is available at that time, I am sure they know the consensus of the membership of the House and would hold it in Augusta. Now it is even possible that we could still hold it in Augusta if the State Armory was available or other facilities so that it could be here. I hope that this measure is not defeated.

The SPEAKER: The Chair recognizes the gentleman from Lewiston, Mr. Jalbert.

Mr. JALBERT: Mr. Speaker, I would like to state it is my opinion that these conferences are invaluable, whether they be held here or in Orono. I am one of those that steadfastly has wanted them to be held here, but as the gentleman from Madawaska, Mr. Levesque stated, we can't have it here if the Hall of the House is not available.

Another feature is that the price tag to my knowledge has always been not at all in excess of \$10,000. I would strongly urge the gentleman from Old Town, Mr. Binnette, to withdraw his motion.

Thereupon, on motion of Mr. Levesque of Madawaska, tabled pending the motion of the gentleman from Old Town, Mr. Binnette, to reconsider assignment for third reading and tomorrow assigned.

Mr. Starbird from the Committee on State Government reported "Ought to pass" on Bill "An Act relating to Legislative Expenses When Legislature not in Session" (H. P. 1191) (L. D. 1659)

Report was read and accepted, the Bill read twice and tomorrow assigned.
