Joint Resolution

WHEREAS: the distinguished Senior Senator from Maine, the Honorable Margaret Chase Smith, entering upon her fourth consecutive term in the United States Senate, and

WHEREAS: by virtue of her exceptional record, exemplified by her devotion to duty and her widely acknowledged ability, the Honorable Margaret Chase Smith has brought great credit and honor to her native State of Maine, and

WHEREAS: the Honorable Margaret Chase Smith not only was the first woman elected in her own right to the United States Senate, and the first woman to represent the Republican party in that body, but since the convening of the present Congress she has added to her reputaition by her unanimous election as Chairman of the Conference of All Republican Senators, thereby becoming the first woman in history to assume an official leadership position in the United States Senate, and since all of the accomplishments of Senator Smith further enhance the image projected by the great State of Maine; NOW THEREFORE.

BE IT RESOLVED, the House concurring, that the 103rd Legislature shall show its respect for the dignity accruing to our State by her successive accomplishments by having a portrait of Senator Margaret Chase Smith placed in a prominent place in the Maine State Capitol; and

That a committee shall be appointed by the President of the Senate and the Speaker of the House to obtain such a portrait of Senator Smith; and

That upon the occasion of the hanging of said portrait this committee shall conduct suitable exercises in honor of the occasion. (S. P. 225).

Enactor

The Committee on Engrossed Bills reported as truly and strictly engrossed, the following Bill:

Bill "An Act to Validate Proceedings Authorizing the Issuance of Bonds or Notes by School Administrative District No. 51." (H. P. 27) (L. D. 48)

The PRESIDENT: This being an emergency measure, under the constitution it requires the affirmative vote of two-thirds of the entire elected membership of the Senate. All those in favor of the passage of the bill to be enacted will rise and stand in their places until counted.

A division was had.

Thirty-three Senators having voted in the affirmative and none in the negative, thirty-three being more than two-thirds of the entire elected membership of the Senate, the bill was passed to be enacted, signed by the President and by the Secretary presented to the Governor for his approval.

Mr. KATZ of Kennebec: Mr. President, this is the first Enactor of this Session. I think that it is prophetic that it is a bill dealing with Education.
