Mr. Mills of Franklin: Mr. President, in moving for the passage of these bills in concurrence, I would like to speak just briefly, if I may, in regard to one of them, Item No. 7-3, Bill, "An Act Relating to Actions of Married Women for Loss of Consortium of Husband."

I would like to note, if I may, Mr. President, that this is a valuable right which is being given, if this bill is enacted, as it undoubtedly will be, because it is going along all right, to the women of this State, unsolicited and unsought-for. It is a bill which might well have been expected to come before this legislature many years ago during the days of the Suffragettes, and in our time we have had some very strong advocates of the right of women to sit in the halls of this legislature, but never before. I believe, has this proposition been suggested or requested; and the significant thing about it, to me, is that this is something that men are doing for women and the women are not asking for it at all. There is no pressure, no agitation. No one appeared at the committee hearing asking for it, but still it is a very valuable right.

To describe it briefly, I would say that in a law suit, say if a husband is injured and taken out of circulation and put in a hospital for some time, unable to be a companion to his wife, unable to be at home, the wife in the past has had no claim for damages for that loss, whereas the husband has always had it. I think it goes back to the time when the wife had no standing in court anyway and had no right to bring a suit. Down through the years, some of the courts in the country have given the wife this right by adjudication of the law courts; and just recently this matter was brought to the fore by an opinion of our Law Court, Justice Marden writing the opinion, in the case of Barry M. Potter and Sandra Potter vs. Sidney R. Schafter (161 Maine, Page 340), In that case, this right of recovery was sought and it was denied because Justice Marden pointed out very wisely that this is a matter needing legislative attention and if this right was to be given, it should be by act of the Legislature. I believe that is the source Representative Berman's bill, I believe Representative Berman to be the author of this bill. Justice Marden points out that in only one state in the Union has this been taken care of by legislation, such as we appear to be doing today, Oregon, I think he points out is the other state where this has occurred. Some other states have done this by judicial decree. But here, significantly I think, with all men participating, without any prompting from their wives or from their colleagues on the distaff side they are giving one of the great rights of recovery for our valuable consortium when and if they ever become injured, without solicitation and without any fanfare, and I do think it is a significant day in the legislation of this winter.
