In the Year of Our Lord One Thousand Nine Hundred and Sixty— Seven, Joint Resolution Expressing Sympathy upon the death of Stanley G. McCurdy

P. 523) on March 7 pending consideration of the Veto Message. The Veto Message was ordered placed on file. Sent down for concurrence.

The PRESIDENT: The question pending before the Senate is:

Shall this bill be a law not-withstanding the objection of the Governor? According to the constitution, the vote will be taken by the yeas and nays. A vote of "Yes" will be in favor of the bill; a vote of "No" will be in favor of sustaining the veto of the Governor. Is the Senate ready for the question?

Mr. HARDING of Aroostook: Mr. President and members of the Senate: I have been in the legislature long enough to know that at this point there are not many minds changed on matters of this nature. What we say here today does go beyond the halls of this Senate to the people of the State of Maine, and I think it is not only important that the Senators here know but that the people of the State know what is at stake in this matter.

As lawyers, we learn that hard cases make poor law, and in the legislature sometimes good friends make poor law. Now I think all of us here see the inefficiencies in the government about us, both in the executive branch and particularly in our own branch, and many times we would ask how they would occur. I would suggest to you that many times they occur in the same manner they would occur if this bill passed.

You have a distinguished gentleman who sponsored this particular measure, he feels sincerely about it, and I think his support came on the basis of friendship and his personality rather than on the merits of this bill.

The only argument that I have heard for this bill is that the Governor might be, possibly, politically motivated, and if the legislature appoints the Commissioner he would be closer to the farmers.

I tell you, members of the Senate, that I do, of course come from the County of Aroostook, and I have not had a single letter, a single telegram, a single phone call, or a single person approach me and ask for my support of this particular bill.

I would also point out to the members of this Senate that the same arguments which you are hearing for the support of this

measure would apply to the Department of Economic Development, Labor and Industry, the Liquor Commission and Highways, On any of those, you could say that if the Legislature appoints them they will be closer to the people, which would remove any political consideration. I say to you that those are not valid arguments and that we in this legislature, if we do our job here, we have got all that we can attend to without tryto manage these various departments; and I throw this out to you, sitting right here, you Senators: Do you have time, as it now is, to read each bill, to give each bill that comes before you the consideration you would like to give it? You could ask that question, but in answering it I ask you if you have time to supervise any of these departments that you suggest appointing the commissioner of? If we were to appoint the commissioners of all these departments, I would suggest that there would be utter chaos in State Government. Someone suggested — I had one Senator approach me today and he said, ``What you say is true in that regard, but this is just the Commissioner of Agriculture, and this will create just a little bit of difficulty, if it creates any difficulty at all." I suggest to you that we are here not to create more problems in State government but we are here to make State government more efficient. And the other Senator mentioned to me a quote from Thomas E. Dewey, who said, "The Governors of our states are the only executives in the entire nation who go to bed at night wondering what department head will stab them in the back the next morning.'

Now this is not a progressive measure, it is not a reform, it turns the clock back, a long, long ways back. Now no industry in the United States would conceive of a set-up where the stockholders of the company would appoint a department head for a given term and they have no right to fire him and the president has no control over him. And I suggest to you that there is no other State

in the Union that has such a system as this bill would propose to the legislature of electing the Commissioner of Agriculture.

Now the last time there was a suggestion made about Governor Reed's position on this matter. In order to clarify the record, I want to read to you a very short quote from the Kennebec Journal, from the Associated Press. This is the day on which he signed this bill which you are now asked to approve. This is what the news article says:

"Republican Governor John Reed signed into law Friday the only enacted governmental reform bill Democratic-conbacked by the trolled Legislature. Ninety days after the legislature adjourned, the office of the Agricultural Commissioner will be gubernatorial-appointed. The Commissioner is now elected by the legislature. The bill is amended so that the present Commissioner, Maynard C. Dolloff, can serve out his four-year term ending in 1968. There had been some speculation that Reed would veto the bill, but he said in his statement; 'The people of Maine look to the Governor for Leadership in all respects of State government administration. Obviously a governor does not have effective control when he cannot select the administrator.' He added: realize I differ with certain distinguished members of my party in the legislature by signing this measure. However, I must do what I am convinced will advance good government."

The kindest thing I can say about this bill is that its sponsor certainly had good intentions, he is a distinguished gentleman and a good friend of mine, but that does not change my views about the bill. I think it is a most unfortunate one.

Now I do not think that this body ought to leave to the other body the responsibility which is ours. Many here have told me privately, "Where we know it is going to be killed in the House we can go along with it here and we won't upset anybody. But this is not the way that we should meet our responsibilities. So I would ask that when your vote

be recorded that it will be a vote that you will be proud of in years to come, and I suggest that any party or any individual running on their record with a vote for this bill, they cannot pretend that this is a progressive vote. So I would hope that you would vote on the side that is for sound and business-like government and conform to the procedure which all other businesses have in United States and all other state governments, and that you will vote against this bill. I ask that you vote "No" when the roll call is taken.

Mr. JOHNSON of Somerset: Mr. President and ladies and gentlemen of the Senate: It is not my prerogative here to speak in favor or against this bill as a representative of the Republican Party. I would like to say this, speaking for myself: I would feel that the gentleman who introduced this bill, the good Senator from Aroostook, Senator Barnes - I would feel that this is really a personal tribute to this man in some respects. This gentleman comes from an area that is predominately, in fact really the only area in the State that is predominately an agricultural area. He has, over the years, not only been a part of agriculture but he has been a leader in the field of agriculture. He is representing the people up in his county to an extent that representatives of other areas would not be able to on a bill of this type. He has firm convictions that the people in the agricultural field would like this appointment retained within the legislative body and not by appointment by the Governor.

Speaking for myself, I would say that I believe that the good Senator from Aroostook, Senator Harding, is probably looking at a small part of the picture and we are looking at a big part of the picture. I think all of us here will agree that we have had over the years, a little picking at the Constitution here, a little picking there in the make-up of State government in the bills that have been put in here — we have a bill in here now to create a unicameral system of government and

to change the Constitution to do away with the council, we have a Department of bill for Transportation and so forth and so on. I think if we look at the whole picture you will see that if we take away different parts of our Constitution we weaken the whole structure, and that the whole structure should be examined and placed in the proper perspective. It is the same as with a building, if you take away a few bricks here and there you weaken the whole structure. I would feel that this is a bill that is requested by the people in the agricultural business.

Mr. RENY of York: Mr. President, I ask the indulgence of the Senate while I read a few paragraphs from an editorial which appeared last night in the Lewiston Evening Journal.

"Curtis made relatively the same major point in explaining his veto as we had made in explaining why we considered the attempt by the 103rd Maine Legislature to regain the appointment power over this office to be unwise and unjustified. The Governor noted the proposal violates the fundamental principal of separation of executive, legislative and judicial powers; that legislative naming of executive officers is contrary to current practice in the United States; that the Governor right-fully should determine who shall serve as his immediate sub-ordinates; that the powers of appointment and removal of Maine governors should be maintained at a level consistent with their responsibility.

These are along the same line in the way of argument as those given in the Public Administration Service study of 1956. The PAS report in essence said that Maine governors should be given more authority. One of the areas emphasized was that over certain appointments, including those of the agriculture commissioner, state treasurer and attorney general."

The Portland Press Herald and many of our leading newspapers have also expressed these same sentiments. I feel that we should not put the clock back. L. D. 41 is progressive legislation and it should be supported by all of us. Thank you.

Mr. STERN of Penobscot: Mr. President, a short while ago when this bill was previously debated I got up and made some remarks that probably indicated that it was an exercise of extreme and utter futility for me to apparently convince some of my Republican colleagues to join with some of us who believe that this is progressive legislation. I have changed my mind since then, I have looked over the members of the Senate and I feel that this should not be a partisan matter. I feel that there are some of us who have the courage of our convictions that we would not and should not consider this a partisan matter. I have seen evidences of my good friend and senatorial colleagues showing indications of extreme courage in proposing matters that they felt were right even though they might be unpopular and they might be criticized for it. I observed this only a short while ago, last week when Senator Sproul got up and proposed a matter that was unpopular and for which I am sure she received a lot of criticism. I joined with her and I received some criticism, but I believe despite the criticism I received it was a good bill and a just bill, and I joined her in proposing and encouraging and trying to promote the liberalization of the abortion laws.

Now I know that a lot of us perhaps will vote with the herd or vote in such a manner that we will not be criticized. I do see a ray of hope, I do feel that there are some of you that have the courage of their convictions and honestly believe that this bill is progressive. I observed in the Governor's communication didn't realize it before, but if I had any doubts they have been completely resolved - I notice in the communication by the Governor he says: "The Commissioner of Agriculture is not now elected or appointed by the legislature of single state of these United States." I assume, since I haven't seen the statement contradicted. that this is so. I sincerely feel

that this is progressive legislation. Usually I do not get up at all to talk about any other areas that I know nothing about; I usually confine my speeches to the law, which I consider myself as knowing something about, but I am breaking away from this and feel that I have been convinced and I suddenly appointed myself a committee of one as a welcoming committee to urge some of you to have the courage of your convictions, and I know that there are some of you who do feel that this is progressive legislation, and I do encourage you and I do welcome you to join with us so that it may be said that the Senate rather than the House was the first to sustain the Governor's veto

Mrs. SPROUL of Lincoln: Mr. President, I feel I should say something on this bill, especially after Senator Stern's reference a few moments ago. I was delighted to have his help in the bill last week, which certainly has proved con-troversial. I do hope that I have the courage of my convictions, and I still hope that I can act in that manner, but I have always voted against any measure which would take power away from the legislature, and I still feel that I would do the same thing. So, on that basis, despite Senator Stern's offer to welcome me into the fold, I still feel that the bill is a good one and I must vote on that basis.

Mr. MILLS of Franklin: Mr. President, just in case that the vote I am going to cast is taken as a response to a welcome into the fold, let me say that I certainly was pleased to hear the Republican floor leader say that this was not a party measure. It certainly is not, as it was described very early at the time that I made my decision sometime ago as to how I would vote today. It was in a spasm of regret over the vote that I cast earlier when the bill was going through. I resolved that I would not make that mistake again and vote contrary to my good judgment. My vote today will be "No" and it is not in any way an indication of my leaving the fold. I am so happy that our distinguished Republican floor-leader has already purged me of any such characterization. I was happy to hear him refer to the Constitution, a document that all of us have the greatest reverance concerning. The bill has not got a thing to do with the Constitution, as you know. The present situation is in keeping with our concept of a strong executive, and we have it in the federal government.

Reference has been made to agriculture and the farmers' opirion in regard to this bill, and I can say that I have been contacted in my home town, Farmington in Franklin County, regard to various measures before us pertaining to the farmers; Milk Control, Transportation of Live Stock, branding laws in regard to maple syrup, but not one farmer has mentioned this matter, not one farmer has shown any concern whatsoever about whether the legislature determine who shall be the Commissioner of Agriculture whether the Governor make or that determination. My wife comes Aroostook County and from haven't heard from any of her relatives either. So I can go back home to the farmers of Farmington and Franklin County with clear conscience and reported that I voted the way I felt I ought to vote. Thank you, Senator Johnson, for not expelling me for voting the way I want to vote.

The PRESIDENT: Is the Senate ready for the question? The question before the Senate is shall this bill be come law not-withstanding the objection of the Governor? The Chair will repeat, that a vote of "yes" will be in favor of the Bill and a vote of "no" will be in favor of sustaining the Veto of the Governor. The Secretary will call the roll.

On motion by Mr. Wyman of Washington, the Senate voted to take from the Table the 9th tabled and unassigned matter (S. P. 459) Bill, "An Act Requiring Approval of County Commissioners of Court Term Bills." Tabled February 28 by the same Senator pending motion by Senator Mills of Franklin to refer to Judiciary Committee. On further motion by the same Senator, the Bill was referred to the Committee on Judiciary in concurrence.

On motion by Mr. Barnes of Aroostook, the Senate voted to take from the table the 13th tabled and unassigned matter (H. P. 173) (L. D. 236) Bill, "An Act Relating to Inspection Certificates for Mechanics in Motor Vehicle Inspection Stations." Tabled March 2 by the same Senator pending consideration. On further motion by the same Senator, the Senate voted to recede and concur with the House.

On motion by Mr. Hoffses of Knox, the Senate voted to take from the table the 12th tabled and unassigned matter (H. P. 217) (L. D. 307) House Report — Ought to Pass as Amended by Committee Amendment "A" — Filing H-21 from the Committee on Inland Fisheries and Game on Bill, "An Act Relating to Use of Power Boats on Jordan Pond and Eagle Lake, Mount Desert Island, Hancock County." Tabled March 1 by the same Senator pending acceptance of report.

On further motion by the same Senator, the Senate voted to accept the Ought to Pass as amended report of the committee and the Bill was given its first reading. Committee Amendment "A" was read and adopted. On motion by Mr. Hoffses of Knox House Amendment "A" was indefinitely postponed in non-concurrence and the Bill, as amended, was assigned for second reading on the next legislative day.

D. 296) House Report — Ought Not to Pass from the Committee on Education on Bill, "An Act Repealing Prohibition of Use of Certain Names by Institutes Not Given Right to Grant Degrees." Tabled March 7 by that Senator. On further motion by the same Senator, the Senate voted to accept the Ought Not to Pass report of the Committee.
