## Authorization

trust  $\mathbf{or}$ company organized and doing business under the Laws of any state or territory of the United States of America, including the District of Columbia, and a national bank, duly authorized so to act, may be appointed and may serve in this State as trustee, whether of a corporate or personal trust, executor, administrator, guardian, conservator or committee for an incompetent person, or in any other fiducapacity, whether the appointment is by will, deed, court order or decree, or otherwise, when and to the extent that the state, territory or district in which such bank or trust company is organized grants authority to serve in like fiduciary capacities to a bank or trust company organized and doing business under the laws of this State and authorized to serve in like fiduciary capacities. S4162. Power of attorney; Secre-

tary of State

Before qualifying or serving in this State in any fiduciary capacity, as defined in section 4161, such bank or trust company shall file in the office of the Secretary of State a copy of its charter, certified by its secretary under its corporate seal, together with a certificate from the official having supervision of banks and trust companies where the bank was organized that it has authority to act in the fiduciary capacity for which it is registering, and a power of attorney designating the said Secretary of State or his successor in office as the person upon whom all notices and processes issued by any court of this State may be served in any action or proceeding relating to any trust, estate or matter within this State in respect of which such bank or trust company is acting in any such fiduciary capacity with like effect as personal service on such bank or trust company which power of attorney shall be irrevocable so long as any such liability shall remain outstanding against such bank or trust com-pany in this State. Upon receipt of such notice or process, it shall be the duty of the said Secretary of State forthwith to forward the same by registered mail to such bank or trust company at the address stated in the said power of attorney. Such bank or trust company shall file a certificate in the office of the Secretary of State in the same form as required by Title 13, section 592 and shall pay a filing fee as though registering under Title 13, chapter 19.'

The PRESIDENT: The Chair will state that it is, having been held at the request of the Senator.

Mr. CURTIS: Mr. President. I move that the Senate reconsider its action whereby it indefinitely postponed this bill, and I would further move that the bill be tabled and specially assigned for April 6th, pending motion to reconsider.

The PRESIDENT: The Senator from Penobscot. Senator Curtis. moves that the Senate reconsider its action whereby the Senate indefinitely postponed this bill. The Chair would assume that the Senator voted in the affirmative. The same voted in the affirmative. The item be tabled pending action on the motion to reconsider and that his motion be tabled until April 6th

Mr. FARLEY of York: Mr. President, yesterday I opposed the bill and I voted with the lady Senator from Lincoln.

The PRESIDENT: The Chair will remind the Senator that a motion to table is not debatable.

FARLEY: Mr. Through Chair, I would like to ask the Senator if he wouldn't set a date earlier than April 6th?

Mr. BERRY of Cumberland: I rise, Mr. President, to a point of order. I believe the pending question before the Senate is the motion of the Senator from Penobscot, Senator Curtis, that the Senate reconsider its action of yesterday. I do not believe that the

vote was actually taken.
The PRESIDENT: The Senator is correct. The motion to reconsider is debatable, but the present motion is to table that motion and that is not debatable, and the Chair so rules.

The Senator from Penobscot, Senator Curtis, hears the inquiry made through the Chair and may answer if he so desires.

Mr. CURTIS: I would be glad

to change that date, Mr. President. The PRESIDENT: Is it now the pleasure of the Senate that this item be tabled and specially assigned for April 6th?

The motion prevailed and the bill was tabled pending action on the motion by Senator Curtis to reconsider.

The adjournment order having been received from the House, on motion by Senator Ross of Piscataquis, adjourned until Tuesday. March 21 at ten o'clock in the morning.
