Mr. Berry of Cumberland: Mr. President, I move the rules be suspended and the bill be given its second reading at this time.

Mr. MILLS of Franklin: Mr. President, I think Senator Berry owes us an explanation for this rush. It may be necessary, but I do not think we should sit here and slam this thing through without at least an explanation from Mr. Berry.

Mr. BERRY of Cumberland: Mr. President. I apologize to the Senator from Franklin, Senator Mills, and I assure him I would do as I have done and always will do in the discharge of my duties as Chairman of the Appropriations Committee, and that is to explain matters of this nature, which I had intended to do after the subsequent motion I was going to make.

However, the bill before you, which is in your compendium of legislative documents and is the last bill which you will find in it, provides for the immediate appropriation of moneys as outlined here to complete contracts which have been let at the several institutions, namely: Aroostook State College — and this is in the legislative document - the completion of the Men's Dormitory in the amount of \$45,000; Gorham State College, completion of Upton \$25,877; Stevens Training Center, Hallowell, completion of Diagnostic and Treatment Building and Cottage, \$14,381, and at Central Maine Vocational-Technical Institute in Auburn, completion of a Dormitory-Cafeteria building, \$17,719.

Now these contracts were entered into by the Bureau of Public Improvements and these additional amounts are necessary to complete the contracts which the contractor in each of the several four instances agrees he can do at these stipulated prices if the Bureau of Public Improvements is in a position on April 1st to have these moneys available and to sign contracts; they will guarantee these figures.

These are in no way additional facilities; they are not an enlargement of programs previously authorized by the legislature. Your committee met yesterday with the Bureau of Public Improvements officials, and the emergency nature of the several items was such as required this action, which I assure you we of the committee do not thoroughly enjoy. We can assure you that these figures are necessary for the completion of these contracts and they need to be pushed through, quite frankly, in order to make these funds available on April 1st.

The PRESIDENT: The pending question is on the motion of the Senator from Cumberland, Senator Berry, that the rules be suspended and the bill be given its second reading at this time.

Mr. MILLS of Franklin: Mr. President, if I spoke in haste previously, I did not mean to show any personal feeling, because I have the greatest faith in the Senator from Cumberland, and I thank him very much for his lucid

explanation. I only express the hope that when these matters come along again that they appear on the calendar if possible. We will go a long ways on blind faith, but I am sure we would like to see these appear on the calendar if at all possible. Your explanation, Senator Berry, makes it clear in my mind.

Mr. KATZ of Kennebec: Mr. President, we had such a clear explanation, I wonder if Senator Berry might be able to tell us with reference to L. D. 436, of which L. D. 1549 is a redraft, the intended disposition of the remaining amounts of money. Is this just a temporary emergency, a partial solution to the problem or is it in lieu of the rest of the intent of L. D. 436?

The PRESIDENT: The Senator from Cumberland, Senator Berry, hears the inquiry and may answer

if he so desires.

Mr. BERRY: Mr. President and members of the Senate: We extracted from the original L. D. 436 those items of this emergency nature. Everything else in that bill will be considered by your committee and reported out as the merits of the individual matters indicate.

The PRESIDENT: The pending question is on the motion of the Senator from Cumberland, Senator Berry, that the rules be suspended and that this bill be given its second reading at this time.

The motion prevailed and the bill was given its second reading and passed to be engrossed.

Amend said Bill by striking out all of the 2nd paragraph in the emergency preamble (same in L. D. 201) and inserting in palce thereof the following paragraph:

'Whereas, under present law social security payments to beneficiaries of a deceased person cannot be paid to the deceased's legal representative without probating the estate; and'

Further amend said Bill in that part designated "S1557", subsection 1, by striking out in the 2nd line (first and 2nd lines in L. D. 201)) the underlined words "an individual" and inserting in place thereof the underlined words "a Maine resident"

Further amend said Bill by inserting after the underlined words "decedent and" in the 7th line from the end in L. D. 201) the underlined punctuation and words ', regardless of the truth or falsity of the statements made therein,'

Senate Amendment "A" was adopted and the bill was passed to be engrossed as amended.

The adjournment order having been received from the House, on motion by Mr. Ross of Piscataquis, adjourned until Tuesday, March 28 at ten o'clock in the morning.
