#### Senate Papers

With the approval of the Committee on Reference of Bills, pursuant to Joint Rule No. 10, Mr. Lund of Kennebec presented.

of Kennebec presented, Bill "An Act Authorizing Joint Rates Between Certain Transportation Carriers. (S. P. 609)

The PRESIDENT: This Bill has had the approval of a majority of the members of the Committee on Reference of Bills. According to Rule 10 of the Joint Rules, if at least one-tenth of the members present rise as objectors the document shall not be received. Is there objection to the late introduction of this Bill?

The Chair recognizes the Senator from Kennebec, Senator Lund.

Mr. LUND of Kennebee: Mr. President and Members of the Senate: I would like to speak very briefly on this bill which has been offered for late introduction, because I am aware that some of the lobbyists, the truckers at least, are attempting to block its introduction at this time.

If the issue had been known to the State of Maine in sufficient time, then this bill would have been referred to the Legislature in the normal course of events. But only about two weeks ago the Maine Supreme Court in reviewing a decision of the Public Utilities

Commission, stated that there was no statutory authority for Commission to prescribe joint rates between rail and motor carriers. The Commission feels that the public interest would be best served by having authority to prescribe such joint rates when they do not impair the existing transportation system. The Commission feels that this discretion within the Commission would better provide for coordination between different modes of transportation in State. I don't know anything about the merits of the bill, but in view of the very recent decision by our Court, I think it is a matter that should be heard by the Committee and decided on the merits by the Committee and by the Legislature. I would hope that this bill would have the opportunity, as other bills have had, for this evaluation and decision by the Legislature.

The PRESIDENT: The Chair recognizes the Senator from Aroostook. Senator Albair.

Mr. ALBAIR of Aroostook: Mr. President and Members of the Senate: I rise this morning in the hopes that this body will go along to permit this bill to have a hearing, as we have done in the past month or two here since cloture a month. I also am speaking to you on this matter as a small businessman in Aroostook County. I have operated a store for the last 20 years in Caribou and I am in a highly competitive field. The Bangor and Aroostook Railroad has served me very well, particularly in the more recent years, by providing overnight deliveries from suppliers in the Bangor and Portland areas. I know that I speak for many small businessmen in my area and throughout the County

Large inventories are beyond our reach, spacewise, as well as from an economic point of view. In fact, we have only two big industries on the B & A Line — potatoes, and pulp and paper. The rest of us make our living from small individual enterprises. We would find our business climate much more difficult if our railroad was not willing to adapt their service to our needs. This may surprise some of you members, but we

have pick-up and delivery service by our railroad. They send their around soliciting salesmen business. They cater to us in trying to get us to use their railroad for our "Less than Carload" lots or shipments. Now, I don't mean to imply that we don't have truck service available also, and it is good service. The thing that keeps the service good is clean and healthy competition. We don't want to lose this happy situation to a transportation monopoly. But this is exactly what will happen unless this Legislature clarifies the present law, because B & A will not continue in small shipments unless we do take some action.

Now I hold no animosity toward the Maine Central Railroad. I know they don't want this type of business and I am willing to let them run their own business, but I fail to see why they should try their level best to keep us from getting the service we want and need. They argue that the B & A isn't making enough money on their and delivery, pick-up thev so should be forced out. Did they never hear of public relations? Have they completely forgotten about responsibility to provide a needed service in the public interest? Let's not throw cold water on this little railroad that has tried so hard and so successfully to rid itself of the "Public be Damned" attitude of past ages.

Our bi-partisan Reference of Bills Committee has recommended that we let this bill in and that we refer it to the Public Utilities Committee, in exactly the same manner as several other bills have been handled. Won't you please give us a fair opportunity to try to demonstrate that this bill is worthy of the consideration of this entire Legislature. It is important to us and we will accept the Legislature's decision with malice toward none, but we don't want to have to lie down without a fair opportunity to present our case. I would also request a division on the vote.

The PRESIDENT: The Chair will state that the question is simply on whether or not there are objections to the extent of one-tenth of the members present. This is not a question that is subject to a division.

Will those Senators who object to the reception of the report rise and stand in their places until counted.

There being five Senators who have risen as objectors, and five being more than one-tenth of the members present, the Bill is not received.
