House Papers Joint Resolution

WHEREAS, Vaughan M. Daggett, who died on November 12, 1966, was a loyal and valued employee of the State H i g h w a y Commission for nearly thirty-eight years, serving the last eleven years as Chief Engineer; and

WHEREAS, his deep concern for the public interest reflected sterling qualities of character and mind; and

WHEREAS, h is engineering ability and integrity were always applied for the benefit of those he served — the citizens of Maine; and

WHEREAS, he did much to encourage the youth of our state to follow the engineering profession and thus aid the growth and progress of Maine; and

WHEREAS, he was responsible for the engineering of the Interstate Highway System in Maine; and

WHEREAS, one of his last official duties before his death was to cut the ribbon to open the 27.7mile section of I-95 south of Medway: now, therefore, be it

RESOLVED, that a copy of this Joint Resolution and an engrossed copy of Legislative Document Number 1531 to designate the bridges across the Penobscot River at Medway as the "Vaughan M. Daggett Memorial Bridges" be sent to the family of Vaughan M. Daggett (H. P. 1123)

The PRESIDENT: The Chair recognizes the Senator from Piscataquis, Senator Ross.

Mr. ROSS of Piscataquis: Mr. President and Members of the Senate: I would like to give you a brief history on some of these bear laws, and then I will make a motion.

In the first place, the Department of Inland Fisheries and Game wanted to make the bear a game animal, so in the 101st Legislature they came out with a bill closing the season on the black bear for January, February and March only. Well, I opposed that bill on the grounds that the bear closes that season himself because he goes to bed and hibernates, as everybody knows, and the bill was killed. So the next session in the 102nd they came out with the same bill. I appeared before the Committee and I said "If the Department is sincere in making the bear a game animal, let's make it one and let's close it until the first day of August whereby you are not shooting a mother bear before that time so the cubs die." I couldn't get it over until the first of August, so we did compromise on June 1st.

Shortly after that there was an editorial in the Bangor Daily News, and I might say that the editorial writer was certainly a prophet because he said, and I quote: "Bears are big business in Maine." And he said, "It was not until the last session of the Maine Legislature that the black bear was given any protection whatsoever, and then it was a limited closed season, something of a reprieve until the Legislature meets again and countless other bear bills make their appearance." Well, he didn't know how truly he was prognosticating the thing.

The Sebec Lake Fish and Game Club, with 323 members, which happens to be in my county, is unanimously in favor of leaving the bear situation just the way it is, June 1st. As I told you, it was a compromise date, and you do save some cubs because from that date on they should be fairly well able to take care of themselves.

As far as the trapping goes, at the present time the seasons are mixed up if we don't kill this bill, because the trapping season is now, under the new bill, to open June 1st, and this bill would open the hunting season May 15th, so you would have a conflict. Also, the Fish and Game Club would like the two dates to coincide, and I therefore move for the indefinite postponement of this bill and all its accompanying papers.

The PRESIDENT: The Senator from Piscataquis, Senator Ross, moves that we now indefinitely postpone the bill and its accompanying papers. Is the Senate ready for the question?

All those in favor of indefinite postponement say "Yes." Those opposed, "No."

A viva-voce vote being taken, the motion prevailed, and the Bill with all accompanying papers was indefinitely postponed in nonconcurrence.

C. "Federal aid highway system" shall consist of Highways selected or designated by the State Highway Commission and approved by the Secretary, Department of Transportation, in accordance with 23 U. S. Code Section 103.

D. "Compact areas" shall in section 2346 and this section mean an area within a municipality having a population over 5,000 where structures on land adjacent to the highway are nearer than 200 feet apart for a distance of $\frac{1}{4}$ of a mile."
