Mr. GOOD of Cumberland: Mr. President and Members of the Senate: This bill extends for the first time coverage to an employee under the Workmen's Compensation Law for serious facial or head disfigurement. Under this extension of the law the Commission may award, for the first time, up to \$1,500 for this type of injury as a result of his employment.

We feel that this Legislature, by enacting this bill, will be taking a step forward on behalf of our employees and also the employers and workmen of this State. Therefore, I move that the Senate accept the unanimous Ought to Pass Report of the Committee.
