SENATE

Thursday, January 9, 1969 Senate called to order by the President.

Prayer by Brigadier Alfred C. Davey of Augusta.

Reading of the Journal of yesterday.

ORDERED, the House concurring, that when the House and Senate adjourn, they adjourn to Tuesday, January 14, at 10 o'clock in the morning. (S. P. 27)

Out of Order and Under Suspension of the Rules:

On motion by Mr. Hoffses of Knox

ORDERED, that a message be sent to the House of Representatives proposing a Convention of both branches in the Hall of the House, for the purpose of extending to His Excellency, Governor Kenneth M. Curtis, an invitation to attend the Convention and make such communication as pleases him.

Which was Read and Passed.

On request of the President, Mr. Hoffses delivered the message and reported that he had performed the duty assigned to him.

Subsequently a message was received from the House, through Representative Harrison Richardson, concurring in the proposition.

The Senate then retired to the Hall of the House of Representatives where a Joint Convention was formed.

17-B. Ought not to pass referrals. Any bill or resolve, which bears a unanimous ought not to pass notation by the committee to which it has been referred, shall be delivered to the Joint Standing Committee on Reference of Bills, which committee shall notify the house of origin of the delivery of such bill or resolve. No further action shall be taken on such bill or resolve unless within 10 calendar days after notification on the informational calender a majority of the members of the house of origin sign a petition of discharge. Mr. MILLS: Mr. President, I think that the second don't consecutive day in which the whole Legislature has been the beneficiary of interesting souvenirs, at least, of our service here should be passed over without comment on it and without thanks to those who are responsible. I have in mind, of course, as all the Senators know and the members of the other body too, the very splendid gift that we all received yesterday from the trucking industry, the portfolios, which is a duplicate of two years ago.

Then I noticed this morning that we are favored with a tie clasp. The tie clasp is ominous, as you will note, but it got called two years ago, and I guess it is known in the trade as, "The Double Bottom." It is a trailer truck about 150 feet long going down a main highway, and I think we are expected to put it on our ties. Now, if it is going to have as much potency as those "500" things that I have seen on certain members, why, I am concerned.

I was over in Europe last year, last summer, and I saw a lot of double bottoms on the highways, even in the Alps, and I was quite impressed that my position might have been wrong two years ago when I voted aganst double bottoms. But I am going to watch the souvenirs as they come along day after day from the industry, and can only hope that the railroad people will be able to come up with counter fodder for us. Thank you.
