Mr. CONLEY of Cumberland: Mr. President and Members of this august body: Yesterday when I attempted to table this bill unassigned it was because I wanted to find out what the appropriation of \$2,500 was going to be used for. I am sorry I didn't clear the tabling matter with the majority floor leader, but I have found out since that time that the Attorney General has done a great deal of work as far as drafting of legislative documents, and that he had to hire additional help. I understand he has done a very articulate job, and I would now move the pending question.

Thereupon, this being an emergency measure and having received the affirmative vote of 27 members of the Senate, was Passed to be Enacted and, having been signed by the President, was by the Secretary presented to the Governor for his approval.
