Mr. ANDERSON: Mr. President, I rise to briefly pay tribute to the memory of Abraham Lincoln.

"He little knew that evening

That God stood by his side ---

He did not need to know

For he was ready.

Greed, selfishness and lust

Were all unknown to him.

His trail was wide,

Well marked with milestones,

Truth, honesty and love of fellowmen.

Strong and tender, brave and wise, He shaped the destinies of men.

He was a teacher and a builder. He taught his people

In that chaotic era,

That figures were to earn

An honest living, not to be distorted.

Bent to further selfish ends;

That English was a pure expression,

Of the soul,

Not simply words that readily

Lent themselves to lustful purposes.

He was so big, so calm, so strong, It almost seemed that

He might live forever,

That time could never dim the eyes That saw only goodness in all things.

Or still the tongue that Spoke no evil words.

"So, in the hush of early hours. He did not need to know, Prepare for that dim trail That leads beyond the lives of men. Little dreamed the world, So soon, that it would stand Beside his bed and watch him Break the slender ties that Bound him to this life He loved so well.

"His destiny was in the stars.

The color of the ground was in him.

The Red Earth, the rich, red earth That nurtured the towering oak. And, like the monarch of the forest Beset by raging tempest, He went down with a great shout That echoed from the hills And Left an empty space -Against the sky.'
