The SECRETARY: This Bill was introduced on February 12, 1969, and the Committee on Reference of Bills suggested that the Bill be referred to the Committee on State Government. Tabled on February 12, pending Reference.

The PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Berry.

Mr. BERRY of Cumberland: Mr. President, I don't discuss this matter with any thought at all that any one committee would give my bill any preferential treatment. I do feel that we should not deviate from the recommendation of the Reference Committee unless there are some obvious inequities here.

This Bill does not really bring up what I think, as a layman, I would call judicial matters. It is a procedural change in the organization of a department of State Government. It seems to me that the Committee on Reference of Bills had pretty good justification for sending this to the Committee on State Government, and I would hope you would vote against the motion of the Senator from Franklin, Senator Mills, and then we would concur.

The PRESIDENT: The Chair recognizes the Senator from Kenne-

bec. Senator Katz.

Mr. KATZ of Kennebec: Mr. President, I must concur in the remarks of Senator Berry. It is my thinking that this should go to the Committee on State Govern-

The PRESIDENT: The Chair recognizes the Senator from Cumber-

land, Senator Kellam.

Mr. President and Members of the Senate: It would appear to me quite obvious that this is a Judiciary matter, and I would recommend that we follow up the suggestion of the Senator from Franklin, Senator Mills.

The PRESIDENT: The Chair recognizes the Senator from Ox-

ford, Senator Beliveau.

Mr. BELIVEAU of Oxford: Mr. President, I move that this item lay on the table unassigned.

The PRESIDENT: The Senator from Oxford, Senator Beliveau, moves that Senate Paper 243, Bill, "An Act Relating to Full-time State's Attorneys," be placed on the table unassigned.

Chair would inform the Senator from Cumberland, Senator Berry, that a tabling motion is not debatable.

For what purpose does the Senator rise?

Mr. BERRY of Cumberland: I wish to make a motion, Mr. President.

The PRESIDENT: The Chair would inform the Senator that a motion to place a matter on the table unassigned takes precedence over any other tabling motion until it is disposed of, at which time another motion may be made.

The Chair recognizes the Senator from Kennebec, Senator Katz. Mr. KATZ of Kennebec: President. I ask for a division.

The PRESIDENT: The Senator from Kennebec, Senator Katz, has

asked for a division.

The question before the Senate is on the motion of the Senator from Oxford, Senator Beliveau, that Bill. "An Act Relating to Fulltime State's Attorney," be placed on the table.

As many as are in favor of the motion will rise and remain standing until counted. Those opposed will rise and remain standing un-

til counted.

A division was had, Sixteen Senators having voted in the affirmative and fourteen Senators having voted in the negative, the motion prevailed and the Bill was tabled pending the Motion of Senator Mills of Franklin that the Bill be referred to the Committee on Judiciary.

#### (Off Record Remarks)

Mr. Reed of Sagadahoc was granted unanimous consent to briefly address the Senate.

Mr. REED: Mr. President and Members of the Senate: Yesterday I listened with considerable interest on Lincoln's Birthday to the remarks of the Senator from Hancock, Senator Anderson, and I must admit that I certainly concur with them. I also am an admirer of Lincoln and I feel that probably he was the greatest President this country really ever produced. But I didn't stand here this afternoon to talk about someone in the past, but I wish to say a few words about someone who is very much alive. He is very much among us and, in fact, I might say he is very much in command of us at this time. If you don't believe it, just step out of line.

I would also mention, as I sit here thinking about this man, the first time I ever met him. I don't know whether he remembers this but it was back, I believe, in 1961 or '62, and it was a pre-legislative conference. At that time they were held in Orono, and that particular evening the banquet was held at the Bangor House in Bangor. I walked through and they had these round tables that seated some dozen or fifteen or sixteen people, and I saw this empty seat. There was a group of young legislators there who seemed to be

having a good time so I went over and sat down. We introduced ourselves and had a great time and had a lot of laughs. I think we ridiculed just about everyone and everything we could think of. After it was over, the fellow sitting next to me, whom I had just met. became serious for a moment and he started to look all over the diningroom as if he was trying to find someone. Finally he looked at me and he said "Gee. I have heard a lot about Democratic legislators. but I haven't met one or I haven't ever seen one. Have you?" When I informed him that I was one he just threw up his hands and said "Oh my God, no."

Well, a lot of water has gone over the dam since then and I have seen this man win, I have seen him lose, and I have seen him come back. It is always a pleasure to see someone like this involved in State Government and, understand, tomorrow is his birthday. It is also, of course, Valentine's Day. And I think maybe there is a little irony in the fact that while at the other end of the corridor they are debating about a birthday that this Senate in a very peaceful manner can be unanimous in its thought and wishes in wishing to our Senate President a very happy birthday. Maybe he will remember it as his centennial birthday - this I don't know. But it does give me a great deal of pleasure on behalf of the Senate to present to him this small token of our appreciation for all that he has done for us in the past and I might add, hopefully, that he may do for us in the future.

So, if the Sergeant-at-arms would please come forward I will give him this gift.

Thereupon, the Sergeant-at-arms approached the rostrum and presented the birthday gift to the President of the Senate, amid the applause of the Senators.

The PRESIDENT: The Chair is extremely happy that there was no objection to the request for unanimous consent by the Senator from Sagadahoc, Senator Reed. Thank you very much, Bud, for those kind remarks, and thank you all for the gift.

Mr. Violette of Aroostook was granted unanimous consent to address the Senate.

Mr. VIOLETTE: Mr. President and Members of the Senate: While we are on the subject of birthdays, it has also been called to my attention that one of the members of our own body is today celebrating a milestone birthday in his life, so I thought it would be fitting if one of us did bring this to the attention of the Senate.

Senator Letourneau, the dignified and debonair Senator from York County is today celebrating his sixty-fifth birthday. I am sure he probably does not appreciate the fact that I advise the Senate of his age because he does look considerably younger.

I first knew Senator Letourneau when I became a member of the House in 1947, and I would say that since that time he has rendered dignified and very good service as a legislator to the State of Maine.

I hope that you, Mr. President, would extend for the Members of the Senate the greetings and best wishes of the Senate to Senator Letourneau on this day.

The PRESIDENT: The Chair is very pleased to extend to Senator Letourneau the best wishes of the Senate, and it is still very difficult to believe it is his sixty-fifth birth-day.
