Mr. MARTIN of Piscataquis: Mr. President, I move to accept the Majority Ought to Pass Report.

The PRESIDENT: The Senator from Piscataquis, Senator Martin, moves that the Senate now accept the Majority Ought to Pass Report of the Committee.

The Chair recognizes the Senator from Washington, Senator Wyman.

Mr. WYMAN of Washington: Mr. President and Members of the Senate: I feel obliged to oppose that motion. Your Committee on State Government heard this bill. There were proponents of the bill who say that such a tax is a nuisance tax and it does not bring in enough revenue to pay for the trouble it takes to collect it.

On the other hand, the opponents to it claim that it is, perhaps not a major source, but a valuable minor source of income. The City of Augusta, if I remember correctly, said they take in \$19,000 from this tax.

The proponents of the bill say it is just too much of a nuisance to collect it. But the tax collector in Augusta said that when they go around to view the homes to find out such information as they need to have to value the homes, and to find out if they have dogs for a dog tax, and to find out about a poll tax, that they do this all at the same time and, without any appreciable additional expense, they pick up this some \$19,000.

In the small towns that are struggling hard for tax moneys, particularly in view of the school situation, I know they pick up some additional money. So, for that reason, I oppose this motion of the good Senator from Piscataquis, Senator Martin.

The PRESIDENT: The Chair recognizes the Senator from Piscataquis, Senator Martin.

Mr. MARTIN of Piscataquis: Mr. President and Members of the Senate: There are many towns at present who are currently not placing an assessment on television sets and musical instruments. It is a very unfair item to assess. It is difficult to assess a TV according to its fair value.

I believe that the good Senator from Washington, Senator Wyman, will agree with me that our constitution tells us that all property within a town shall be assessed in proportion to its fair value. It is impossible to place an assessment on a TV that is fair. It gives a very small return to the towns and it is very difficult to collect in some cases.

The PRESIDENT: Is the Senate ready for the question? The question before the Senate is the motion of the Senator from Piscataquis, Senator Martin, that the Senate accept the Majority Ought to Pass Report of the Committee. As many as are in favor of accepting the Ought to Pass Report of the Committee will say "Yes": those opposed, "No".

A viva voce vote was taken and the Chair being in doubt ordered a division. A division was had. 19 Senators having voted in the affirmative, and nine Senators having voted in the negative, the motion prevailed.
