Mr. ANDERSON of Hancock: Mr. President, I move indefinite postponement of L. D. 491 and all accompanying papers, and I would speak briefly to the motion.

This carried an appropriation of \$40,000 for the fiscal year ending June 30, 1970 and the sum of \$40,000 for the fiscal year ending June 30, 1971. Now, this document has been defeated twice before, once in the 103rd and once in the 102nd.

Now, I want it clearly understood that I am not against voting machines, but I am against this method of supplying them. This is exactly how new bureaus get started. They start snowballing and the first thing you know the communities would want f i r e engines and snowplows, and what have you, and that is the way the thing would go.

I feel that if the communities want these voting machines they can get a good deal from their local banks, a good fair interest rate. We are already in the real estate business and in the TV business, so please, I ask you, let's not get into the banking business.

Mr. President, when the vote is taken I move it be taken by a division.
