WHEREAS, the City of Auburn, first organized as a Town on February 24, 1842, has been long known as a community of fine homes, educational institutions, municipal facilities and thriving business concerns, having greatly expanded in these directions during the past several years; and

WHEREAS, the 47th Legislature, on February 12, 1868, enacted a bill granting Auburn a city charter, and the townsmen of Auburn, on February 22, 1869, voted to adopt incorporation under said charter; and

WHEREAS, February 22, 1969 marked the start of Auburn's 100th year as a city, which centennial it is now observing; now, therefore, be it

ORDERED, the Senate concurring, that the 104th Maine Legislature designate the year 1969 as Auburn's Centennial Year as a city, and commend its officials and all its citizens for the success of this community, which they have achieved together, and also extend to each its sincerest hopes and best wishes for continued success upon entering its second century; and be it further

ORDERED, that duly attested copies of this Joint Order be transmitted forthwith by the Secretary of the Senate to the Mayor and City Manager of the City of Auburn to commemorate the occasion.

The PRESIDENT: The Chair recognizes the Senator from Kennebec, Senator Katz.

Mr. KATZ of Kennebec: Mr. President, I would like to call the Senate's attention to this bill. Earlier in this session the Senate passed to be engrossed a measure which I sponsored which would seek to bind the presidential electors to vote for the candidate of their own party.

This bill does something that I think no other state in the country has done yet, and I think it is a very, very good piece of legislation. Actually it is our first attempt

to go in the direction of popular election of the president of the United States.

While Congress is groping with the problem of how to do it on a national basis, you will notice that this bill actually makes it possible for one candidate to get three of Maine's electoral votes and the other candidate of the other party to get one electoral vote. From the Republican point of view, this means that in a Democratic sweep we still can salvage one of the electoral votes, and the opposite is also true. I note this came out of committee unanimously Ought to Pass, so probably it is a good thing for both parties.

The PRESIDENT: Is it the pleasure of the Senate to accept the Ought to Pass Report of the Committee?

The PRESIDENT: The motion before the Senate is the motion of the Senator from Penobscot, Senator Sewall, that Item 8-14, Legislative Document 732, be placed on the Special Appropriations Table. Is the Senate ready for the question?

The Chair recognizes the Senator from Cumberland, Senator Berry.

Mr. BERRY: A point of information, Mr. President: I would inquire as to the purpose of the emergency. I don't think I am debating the matter; this is a matter of parliamentary inquiry. Are we tabling something of an emergency nature which is against the purpose of the bill?

The PRESIDENT: If you are stating that question as a parliamentary inquiry, I would answer in this way: Many emergency items that have an appropriation on them go on the Appropriations Table until money is found or until agreement is reached as to whether they are going to be funded or not.

On motion by Mr. Katz of Kennebec, the Senate voted to reconsider its action of earlier in today's session whereby on non-concurrent matter, Bill, "An Act Relating to the Division of the State into Regions for the Purpose of

Regional Development." (H. P. 829) (L. D. 1068), the Senate voted to Insist.

Thereupon, on further motion by the same Senator, the Senate voted to Recede and Concur.
