SENATE

Tuesday, January 6, 1970 In compliance with a Proclamation of His Excellency, Gov. Kenneth M. Curtis, the Senators convened in the Senate Chamber at nine o'clock in the morning, Eastern Standard Time, and were called to order by the President.

Prayer by the Rev. Elmer N. Bentley of Augusta.

The Secretary read the Proclamation:

STATE OF MAINE PROCLAMATION By the Governor

WHEREAS, legislative leaders and I have agreed that it is advisable that the Legislature of this State should meet in a special session for the purpose of considering the following emergency legislation:

An Appropriations Bill, including funds for the Department of Indian Affairs and the Department of Mental Health and Corrections, increases in judges' salaries, inthe salaries creases in employees of state institutions who suffered a reduction in pay because of recent working hour changes, and adjustments in the biennial appropriation of several agencies; Appropriations Surplus including funds for a Spruce Bud Worm Control Program, Camp Waban, a Kidney Dialysis Pro-School Subsidies, Andro-County Mental Health scoggin Facility and miscellaneous repairs and emergencies for the Adjutant General, Department of Aeronautics, Department of Mental Health and Corrections, University of Maine, Department of Veteran's Affairs, and Parks and Recreation: a Highway Bond Issue; and other matters judged by the Legislature as necessary to the welfare of the State.

WHEREAS, I further deem it necessary to consider the following items:

Funds for state assumption of 50% of the cost of health insurance plans for state employees, increased enrollment at the University of Maine, a management analysis section in Finance and

Administration, and the Services for Aging unit of Health and Welfare; Creation of a Consumer's council; An interest free loan for construction of the Portland Ferry Terminal; Construction of the first phase of a medical - psychiatric unit at the Boys Training Center; Establishment of a Human Rights Commission: Allocation of bond money for water pollution abatement projects; Government reorganization and efficiency measures; A coastal protection act; Control of solid waste; Annual Sessions; Creation of a State Forest Authority: Changes in laws affecting the State Department of Education, the University Maine, County Attorneys, Sea and Shore Fisheries, the conveyance of land in South Portland, the poor, the retirement system, municipal, state and private employees. Liquor Commission, Maine Police Academy, Maine Housing Authority, personnel system, technical provisions of state tax laws, property tax administration and wildlands tax adjustments, county government, home rule, municipal revenue bonds and non public elementary school assistance.

NOW, THEREFORE, I, Kenneth M. Curtis, Governor of the State of Maine, by virtue of the power vested in me as Governor, convene the Legislature of this State, hereby requesting the Senators and Representatives to assemble in their respective chambers at the Capitol at Augusta on Tuesday, the sixth day of January, 1970, at nine o'clock in the morning, in order to receive communications and to consider and enact such measures as in their judgment will best promote the welfare of the state. (SEAL)

Given at the office of the Governor at Augusta and sealed with the Great Seal of the State of Maine, this Twenty - second day of December, One Thousand Nine Hundred and Sixty - nine, and of the Independence of the United States of America, the One Hundred and Ninety - fourth.

Which was Read and Ordered Placed on file.

The PRESIDENT: The Secretary of the Senate, Jerrold Speers, resigned during the summer months in order to accept a position in Washington. Pursuant to Senate Rule No. 5, on December 17th the Chair appointed Harry N. Starbranch to serve as Secretary until the legislature convened in this special session. It is now up to the Senate to elect a new Secretary. The Chair awaits nominations.

The Chair recognizes the Senator from Kennebec, Senator Katz.

Mr. KATZ of Kennebec: Mr. President, I would like to place in nomination the name of Harry N. Starbranch to be the Secretary of the Senate.

Starbranch has received degrees in Business Administration and Law at the University of Connecticut. He served on active duty for eight years in the Air Force, and is a member of the Maine National Guard, assigned to headquarter units in Augusta. He is a member of the Maine and Kennebec Valley Bar Associations. While with the Attorney General's Department for more than two years, Mr. Starbranch was assigned primarily to the Insurance and Banking Departments. I notice in the press that he has recently joined a local law firm of substantial repute.

I have had a chance to observe Mr. Starbranch in the preparation for the session, and I think you will agree with me as we get going that he is eminently qualified for this post. Mr. President, I nominate for Secretary of the Senate Harry N. Starbranch.

The PRESIDENT: The Chair recognizes the Senator from Knox, Senator Hoffses.

Mr. HOFFSES of Knox: Mr. President, I would like to second the nomination of Harry N. Starbranch as Secretary of the Maine Senate.

The PRESIDENT: Harry N. Starbranch has been nominated and seconded as Secretary of the Senate. Are there further nominations?

The Chair recognizes the Senator from York, Senator Logan.

Thereupon, on motion by Mr. Logan of York, nominations were declared closed.

On further motion by the same Senator,

Mr. Hoffses of Knox was authorized to cast one ballot on the part of the Senate in favor of Harry N. Starbranch of York for Secretary of the Senate. This was done, and Harry N. Starbranch of York was declared duly elected Secretary of the Senate for the political year 1970.

At the request of the President, Mr. Hoffses escorted the Secretary-elect to the Council Chamber for the purpose of taking and subscribing to the necessary oaths of office to qualify him to enter upon the discharge of the duties of the Secretary of the Senate.

Subsequently, Mr. Hoffses reported to the Senate that he had attended to the duty assigned to him, and that Harry N. Starbranch had, before the Governor and Council, taken and subscribed to the oaths of office required to qualify him for the discharge of the duties of the Secretary of the Senate.

There being no objection, the President appointed Senator Holman of Franklin to the Joint Standing Committees on Judiciary and Towns and Counties.

There being no objection, the President then appointed Senator Quinn of Penobscot as Chairman of the Judiciary Committee to fill the vacancy created by the resignation of Senator Mills of Franklin.

31 Senators having answered to the roll call, the President declared that a quorum was present.

The Secretary conveyed the message.

Subsequently, a message was received from the House, through Representative Benson of Southwest Harbor, informing the Senate that a quorum was present for the consideration of such business as might come before the House.

ORDERED, that a message be sent to His Excellency, the Governor, informing him that in obedience to his Proclamation, a quorum of Senators is assembled in the Senate Chamber for the consideration of such business as may come before the Senate.

The PRESIDENT: The Chair recognizes the Senator from Oxford, Senator Beliveau.

Mr. BELIVEAU of Oxford: Mr. President and Members of the Senate: I note that this order would require that the calls emanate from Augusta to points within the limits of the State of Maine. I don't know whether their language is similar to the order that we passed at the beginning of the regular session of the 104th, and was wondering whether or not this was a very unrealistic and impractical order. If we are going to have the use of a credit card, certainly we are not going to come down to Augusta to place a phone call; we are going to be placing them from our districts.

I would like to see this item tabled so we could prepare an amendment to it that would permit us to place the calls from our districts to Augusta or to anywhere within the State of Maine.

The PRESIDENT: The Chair recognizes the Senator from Kennebec, Senator Katz.

Mr. KATZ of Kennebec: Mr. President, I would inform the Senator that the wording is exactly the same wording as the regular session and all previous regular and special sessions, and I would

hope that the Senate can live with it as it is written.

The PRESIDENT: The Chair recognizes the Senator from Penobscot, Senator Quinn.

Mr. QUINN of Penobscot: Mr. President and Members of the Senate: I consider the point raised the Senator from Oxford. Senator Beliveau, well taken. Many times when you are in your home district you want to contact some of the heads of departments for information, and there is a question of whether you can do it under this order because the call would be emanating from your home district to Augusta rather than from Augusta to some other point.

The PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Berry.

Mr. BERRY of Cumberland: Mr. President, I move this item be tabled until tomorrow.

The PRESIDENT: The Senator from Cumberland, Senator Berry, moves that Joint Order 4-5 be tabled until the next legislative day.

The Chair recognizes the Senator from Kennebec, Senator Katz.

Mr. KATZ of Kennebec: Mr. President, questioning the timing of the motion, I wonder whether justice couldn't be served by tabling it until later in this morning's session. My understanding is that we will be getting some papers from the House and we will be here for a while.

The PRESIDENT: Does the Senator care to amend his motion? Thereupon, on motion by Mr. Berry of Cumberland, tabled until later in today's session, pending

passage.

Mr. Levine of Kennebec was granted unanimous consent to address the Senate.

Mr. LEVINE: Mr. President and Members of the Senate: As you all know, the City of Waterville and the State of Maine lost a good citizen and public servant. All of you knew Richard Dubord. He served as Mayor of Waterville, as Attorney General, and he used to be in Augusta as a lobbyist.

There are a lot of things all of you know about Richard Dubord.

There are a few little things that most of you might not know, and I would like to mention them. At the last session Richard Dubord was lobbying for a bill that was introduced by the small loan companies. At the last end of it I was fighting this bill and I was losing out. When they were debating this bill in the other branch I was called some names. I didn't mind that, but I just wanted to tell you what kind of a heart he had and what kind of a man Richard Dubord was. Richard advised me then that I lost; that the only way of stopping this bill would be for the Governor to veto it. There was a gentleman very close to the Governor who was standing right near me there, and I didn't know that he had any interest in it, but he told me "The Governor is not going to veto this bill." That evening I met Richard Dubord in one of the rooms here at the Senator Motel and he told me that that gentleman approached one of the lobbyists and said that if they hired him he would see to it that the Governor didn't veto the bill. With that kind of ammunition I went to see the Governor and I told him that if he didn't veto this bill I would see to it that everybody else would find out about it. I was accused by one of the members of the Senate of being a henchman by forcing the Governor to do something that he didn't like to do. I felt that I had done my duty that I was elected for.

Richard Dubord told me that if he had been in the Senate he would have voted the same way I did; that in his heart he was for the little fellow, for the underdog, he called it - at that time that is what he said, the "underdog." So I would like to ask the Senate to stand up for one minute of prayer in memory of Richard Dubord, a great public servant.

(Thereupon, the members of thesenate arose and observed a minute of silence in tribute to Richard Dubord.)

Mr. LEVINE: Mr. President and Members of the Senate: We just had an election in Waterville. The people who live in central Maine must have read the paper. We had the most likeable person for mayor

that any city could have, Mayor Marden. Most of you know Bob Marden, but the mayor, I think, was even a more likeable fellow than his brother. He had great ambitions, but he made on e mistake: He raised taxes the first year from 29 mills to 31. The second year he raised taxes from 31 to 37½ mills. I will see to it tomorrow morning, Wednesday morning, that all of you Senators have copies of the papers in Waterville and what it was all about. There were no personalities involved. Representative Carey is a very respectable man, and so was Mr. Marden, but I guess the people in Waterville decided that they don't want any higher taxes, and Mayor Marden and the whole slate of Republicans that imposed the heavy tax on the citizens of Waterville lost out. I just wanted to remind the Senators that we are coming before the jury, any of us who are going to run for any office, we will be coming before the voters, and we should have it in mind. Thank you for listening.

Mr. Logan of York moved that the Senate reconsider its action of earlier in today's session whereby Bill, "An Act to Create a Commission to Prepare a Consumer Credit Code," (S. P. 560) (L. D. 1635) was referred to the Committee on State Government.

Thereupon, on motion by Mr. Katz of Kennebec, tabled until later in today's session, pending the motion of Mr. Logan of York to reconsider.

On motion by Mr. Katz of Kennebec,

Recessed pending the sound of the bell.

After Recess

Called to order by the President. On motion by Mr. Katz of Kennebec.

WHEREAS, it appears to the Senate of the 104th Legislature, convened in Special Session, that the following are important questions of law and that the occasion is a solemn one; and

WHEREAS, there was introduced before the 104th Legislature at its

Regular Session, H.P. 21, L.D. 24, RESOLVE, Proposing an Amendment to the Constitution Providing for Convening of the Legislature at Such Times as the Legislature Deems Necessary; and

WHEREAS, both the House and Senate passed said Resolve by a vote of 2-3 of each body and said Resolve has been signed by the Speaker of the House of Representatives and by the President of the Senate; and

WHEREAS, said Resolve provides for the submission of said proposed constitutional change to the Inhabitants of the State; in accordance with Article X of the Constitution of Maine; and

WHEREAS, said Resolve was presented to the Governor for his consideration on the 27th day of June, 1969; and

WHEREAS, the regular session of the 104th Legislature adjourned, without day, on July 2, 1969 before the Governor could consider the merits of the proposed constitutional amendment; and

WHEREAS, under the Constitution of Maine if the Resolve is a matter which requires the consideration of the Governor, he may sign or veto said proposed constitutional change within three days of the convening of the first special session of the 104th Legislature; and

WHEREAS, constitutional questions have been raised as to whether said Resolve should have been presented to the Governor for his consideration, and it is important that the Legislature be informed as to the constitutionality of said presentation to the Governor:

Governor;
NOW, THEREFORE, BE IT ORDERED, that the Justices of the Supreme Judicial Court are hereby respectfully requested to give to the Senate, according to the provisions of the Constitution, on its behalf, their opinion of the following questions.

Did the Legislature err in sending Legislative Document 24, RESOLVE, Proposing an Amendment to the Constitution Providing for the Convening of the Legislature at Such Times as the Legislature Deems Necessary, to the

Governor for his approval, instead of sending it forthwith to the Secretary of State to prepare for the referendum provided in said Resolve?

Does the Governor have the power of veto over said Legislative Document 24, RESOLVE, Proposing an Amendment to the Constitution Providing for the Convening of the Legislature at Such Times as the Legislature Deems Necessary, which is a proposed amendment to the Constitution of the State of Maine?

Which was Read.

The PRESIDENT: The Chair recognizes the Senator from Somerset. Senator Cianchette.

Mr. Cianchette of Somerset: Mr. President, I move that this order lie on the table until the next legislative day.

The PRESIDENT: The Senator from Somerset, Senator Cianchette, moves that this order be placed on the table specially assigned for tomorrow pending passage.

The Chair recognizes the Senator from Kennebec, Senator Katz.

Mr. KATZ of Kennebec: Mr. President, I wonder if the Senator would withdraw his motion for just a moment so that I may make an explanation.

The PRESIDENT: The Senator has posed a question to the Senator from Somerset, Senator Cianchette, which he may acknowledge if he so wishes.

Mr. CIANCHETTE of Somerset: I would be pleased to withdraw it for the moment.

The PRESIDENT: The Chair recognizes the Senator from Kennebec, Senator Katz.

Mr. KATZ of Kennebec: Mr. President and Members of the Senate: Time is of the essence in this particular case. If you will recall, during the regular session of the legislature the question as to whether or not a constitutional amendment should properly be referred to the Governor, having been passed by both houses of the legislature, for his signature was raised. Of course, this constitutional amendment then goes to the people for their action on it. At that time we were conscious of

the fact that the Governor had not yet signed or vetoed the measure. And he has until the third legislative day when we reconvene to do this. It is a solemn question, and this matter has been discussed with the Minority Leadership of this body and with the Governor. I think all parties are in agreement that this matter should be referred to the Law Court for whatever decision they care to make. It is my understanding that the Law Court is aware of the question that is being propounded, and it would be very helpful if the matter could go to them without delay in view of the timeliness limit of the Governor's veto.

The PRESIDENT: The Chair recognizes the Senator from Somerset, Senator Cianchette,

Mr. CIANCHETTE of Somerset: Mr. President and Members of the Senate: My reasons for asking for the order to lay on the table is the fact that I do not concur in orders such as this being read, although in most instances it is proper, but I feel that all members of this body should have an opportunity to read with some leisure an order of such length and importance as this. I recognize what the Senator from Kennebec has said, however I still feel that in any instance, I am sure that this order did not come out of the clear blue, and I feel that this membership deserves the right to have this printed and distributed to them before passing such an order.

The PRESIDENT: The Chair recognizes he Senator from Kennebec Senator Katz.

Mr. KATZ of Kennebec: Mr. President, I think the Senator from Somerset knows I concur full well. that all during the regular session I slow down surprises in the session. This was a surprise to us. I would inform the Senator from Somerset that it was our understanding that this would have been introduced at the other end of the corridor. It was not, and during the interim — as a matter of fact I signed this just briefly - and that is the reason why you haven't been extended the same courtesies that I have felt should be extended all during the regular session.

The PRESIDENT: Is it now the pleasure of the Senate that this order receive passage?

Thereupon, the order received
