# SENATE

Wednesday, January 7, 1970 Senate called to order by the President.

Prayer by the Rev. Canon Roger S. Smith of Augusta.

Reading of the Journal of yesterday.

Out of order and under suspension of the rules, the Senate voted to consider the following matter:

Ought to Pass Mr. Conley for the Committee on Liquor Control on Bill, "An Act Relating to Definition of Hotel Under Liquor Law." (Emergency) (S. P. 582) (L. D. 1709)

Reported that the same Ought to Pass.

The PRESIDENT: Is it the pleasure of the Senate to accept the Ought to Pass Report of the Committee?

The Chair recognizes the Senator from Cumberland, Senator Berry.

Mr. BERRY of Cumberland: Mr. President, in moving to accept the Committee Report, I should like briefly to explain to the Senate that this bill will correct the situation whereby twenty-seven licensees of hotels have been held up with their liquor license due to a flaw in the legislation which was passed by the 104th whereby we increased the number of rooms for a hotel to qualify from ten to fourteen, and inadvertently omitted the grand-father clause. These licensees since January 1st have been living in hopes that this would pass forthwith. Arrangements have been made for pre-engrossment, and it would be the hope, I am sure, of that this legislation everybody would go right through and be on the Governor's desk for signature today.

The PRESIDENT: Is it now the pleasure of the Senate to accept the Ought to Pass Report of the Committee?

Thereupon, the Ought to Pass Report of the Committee was Accepted and the Bill Read Once.

Under suspension of the rules the Bill was given its Second Reading and Passed to be Engrossed.

Under further suspension of the rules, sent down forthwith for concurrence.

To the Honorable Members of the Senate and House of Representatives of the 104th Legislature

I have studied Senate Paper 151, Legislative Document 432, An Act Increasing Salaries and Duties of Liquor Commissioners Other Than the Chairman, and have decided to return it to the Legislature without my signature.

This legislation would further entrench an administrative structure for the Maine State Liquor

Commission which the Legislature is being asked to alter at this Special Session. I have proposed, Promote  $\mathbf{in}$ Act to mv Governmental Reorganization and Efficiency, the abolition of the 3 member State Liquor Commission and its replacement by a single administrator who would be a Bureau Chief in the Department Finance and Administration. of Such a change would eliminate the fragmentation of responsibility and the cumbersome decision-making which the 3 member process commission inevitably involves. Additionally, the change would eliminate the salaried positions.

L. D. 432 moves in the opposite direction. It requires that the two commissioners other than the Chairman devote 3 working days per week to their duties and it specifically involves them in a large number of purely administrative matters. An agency simply cannot be run by three people. Administrative responsibility must rest with a single individual who has the authority to make decisions and who can be held accountable for the consequence of decisions.

If there were any justification for retaining the 3 member commission, it would be because of its value as a policy-making and quasi-judicial body, rather than its administrative importance. Even this value is very dubious because of changes enacted by the 104th Legislature which largely eliminate the iudicial functions of the commission. But L. D. 432 focuses entirely on the administrative duties of the commission and enlarges them beyond necessity. I therefore request that my action disapproving L. D. 432 be sustained.

S. P. 151 - L. D. 432 - An Act Increasing Salaries and Duties of Liquor Commissioners Other Than the Chairman.
