HOUSE

Tuesday, January 19, 1971
The House met according to adjournment and was called to order by the Speaker.

Prayer by the Rev. Mr. Ondon Stairs of Augusta.

The members stood at attention during the playing of the National Anthem by the Freeport High School Band.

The journal of the previous session was read and approved.

The SPEAKER: The Chair would make some appointments this morning. The Commission on Interstate Cooperation: Messrs. Hardy of Hope, Susi of Pittsfield, and Dudley of Enfield, who are continuing members. Committee on Campaign Reports: Baker of Orrington Messrs, Marstaller of Freeport and Carey of Waterville. To the Maine Education Council the Chair is delighted to appoint the gentleman from Dixmont, Mr. Millett, who is Chairman of the House Committee on Education.

Whereupon, this being an emergency measure and a two-thirds vote of all the members elected to the House being necessary, a total was taken. 123 voted in favor of same and 3 against, and accordingly the Bill was passed to be enacted, signed by the Speaker and sent to the Senate.
