#### HOUSE

Wednesday, January 20, 1971 The House met according to adjournment and was called to order by the Speaker.

Prayer by the Rev. Mr. Bruce Meyer of Augusta.

The journal of yesterday was read and approved.

At this point, Mrs. Baker of Orrington, escorted by Mr. Millett of Dixmont, entered the Hall of the House.

Mr. Millett reported that he had performed the duty with which he was charged and that Mrs. Baker had taken and subscribed the oaths necessary to qualify her to enter upon her official duties. (Applause, members rising)

Whereupon, Mrs. Baker o f Orrington was assigned to seat number 45 and appointed to serve on the Joint Standing Committee on Judiciary.

#### **Orders**

Mr. Bragdon of Perham presented the following Order and

moved its passage:

WHEREAS, the legislative power is vested in two distinct branches, a House of Representatives and a Senate, each to have a negative on the other, and both to be styled the Legislature of Maine by Article IV, Part First, Section 1 of the Constitution of Maine; and

WHEREAS, each branch is a separate but equal coordinate part of the Legislature; and WHEREAS, the 104th Legislature appropriated by Chapter 121 of the Private & Special Laws of Maine, 1969, to the 105th Legislature, unallocated between the Senate and the House, the sum of \$1,525,636 to be used for the purpose of operating the 105th Legislature;

WHEREAS, it has come to the knowledge of this body that the other body has and is practicing extravagances in depleting the legislative appropriation a bove referred to by single action on its part as indicated by its action in passing a Senate Order on January 12, 1971, without the concurrence of this body, that the Senate officers be paid in advance on account of compensation:

NOW, THEREFORE, BE IT ORDERED BY THE HOUSE, to direct the State Controller and the Department of Finance and the Treasurer of the State of Maine to desist from the disbursement of moneys from said joint legislative appropriation, except those sums presently governed by statute, or any sums approved by concurrent action of both branches of the Legislature; and

BE IT FURTHER ORDERED, that copies of this Order be sent forthwith to the Commissioner of Finance, to the State Controller, and to the State Treasurer.

The Order received passage.

#### Third Reader Indefinitely Postponed

Bill "An Act relating to Open Season for Fishing" (H. P. 39) (L. D. 71)

Was reported by the Committee on Bills in the Third Reading and read the third time.

The SPEAKER: The Chair recognizes the gentleman from Lincoln, Mr. Porter.

Mr. PORTER: Mr. Speaker and Ladies and Gentlemen of the House: I am going to take an unusual action on this bill this morning, and I would like to explain it.

L. D. 71 is a department bill that I asked to sponsor, because I believe in it thoroughly and completely. I took it before the Fisheries and Wildlife Committee and it came out of committee unanimously "ought to pass." However, it has run into opposition.

L. D. 71 does three things. First it changes the opening of the fishing season from April 1 to April 15. I have found no opposition to this change. I think it is good. I think it ought to become law.

The second paragraph changes the method of fishing for bass, and there is opposition to this. If you will read the part that is struck out you will find that, as the present law, L. D. 71 was to change that paragraph, so that the bass fishing would coincide with the trout fishing.

The objections to that paragraph were voiced in this bill, and now some of the opponents want this put back in again.

Let me explain a little bit about the black bass. The bass, unlike the trout and salmon, spawn in the spring. They come in in shallow water, very oftentimes around the wharves and docks. And they clear off a spot, two or three feet across, digging out all the dead leaves and branches, and clean the bottom of the lake right down to clear sand.

Then the female deposits her eggs. And if you can see that, you will find that there is a bass swimming nearby protecting that nest. The do-gooders object to catching that bass. They will tell you a heart-rending story about catching this poor bass who is tending that nest, and therefore it should not be caught.

There is some information that they either do not know or do not accept. It is true that the female bass makes the redd and deposits the eggs. Then the female joins the women's liberation act, and goes off with the girls; and it is the male that guards the redd. And as you see the bass guarding that redd, that is not the female, that is the male. He is keeping house.

Some people object to catching that male bass. Biologists tell us that that male guarding that nest, very faithful in his duties, will immediately eat up the spawn as soon as it hatches. And I think the biologists could prove to you that there would be more bass in the pond or lake if that male bass were caught.

However, there is objection to this, and I don't want to lose the whole bill, so I am going to take unusual action.

The third thing that L. D. 71 does is to change the fishing season on brooks and streams. Under the present law the brooks and streams close August 15, the rivers close September 15, and lakes and ponds close September 30. L. D. 71 was to extend the fishing season in brooks and streams until September 15.

When I mention the word brook you think of a little trickle of water running through the forest or through a meadow, very small. When I use the word stream you think of a somewhat larger body of water flowing towards the sea. When I say river, you think of a much larger body of water.

But if you look at your map of the State of Maine you will find that many of our rivers are ever so much smaller than many of our streams. So it is legal to fish in a small river in September, but illegal to fish in a stream. I thought this made sense. I still do. But there are objections to it.

Therefore, Mr. Speaker, in order to save this good part of the bill, and to try over again, separating L. D. 71 into three component parts and presenting it to the Legislature at a later date, I now move that L. D. 71 be indefinitely postponed.

Thereupon, the Bill was indefinitely postponed and sent up for concurrence.
