Pending-Passage.

The SPEAKER: The Chair recognizes the gentleman from Lewiston, Mr. Jalbert.

Mr. JALBERT: Mr. Speaker and Members of the House: Under another order as presented by the good gentleman from Perham, Mr. Bragdon, which would indicate that the Joint Standing Committee on Appropriations and F in an c i a 1 Affairs, after submission to them, indicates their acquiescence to the passage of the salaries as between the two branches of the Legislature, the members of the working family so to speak. The Appropriations Committee did meet at the request of the Senate and House Chairmen on Thursday, and agreed to the passage of this order and the amounts as set forth in salaries for the staffs of both branches. It certainly would not be my prerogative, nor my intention, to take any issue at all with the item that was on the Senate bi-weekly salary which called for a security state trooper at \$310 on a bi-weekly basis. It is my understanding also that these people, these individuals would be taken off the bus inspection programs and would be within our midst.

I noted that under the list as submitted by our very capable Clerk of the House that no such an item for a state trooper was indicated in her submission as the payroll to the Appropriations Committee to be agreed upon. And I would commend our House Clerk, Mrs. Johnson, for her good thinking in this area. So that subsequently this order that is before us now as presented again by the good gentleman from Perham, Mr. Bragdon, would have us vote in Joint Order as to whether or not we want to have a state trooper looking after the individuals in this august body.

It behooves me that we do now have such an individual in the Senate. We have also, justifiably, a very capable individual in the person of Sergeant Don Nichols, who is in the Governor's office. And incidentally, we know that the Governor and Council are in session most of the time while we are in session also.

We also have a security chief in our midst in the person of Chief Joseph Farrand of my native city of Lewiston. And I can attest to his ability to cope with a situation, because he was acclaimed by testimonial and over the years of service as one of the finest police chiefs in New England. And I personally can attest to his ability.

Being a meek person I would rather think that we should have somebody sitting in on the inside watching over me than somebody sitting on the outside watching over us. And for that reason, and the fact also that this would have a price tag of \$310 bi-weekly, I presume. I am appreciative of the fact that we have had this person amongst us for three weeks. I don't think it should ever have been done, and I again agree with Mrs.

Johnson, our esteemed Clerk, that it should be done in this fashion. I don't see that this man should have worked for nothing. He should be reimbursed certainly for that. But it should end there.

I have checked this out with the gentleman from Perham, Mr. Bragdon, who has put in the order. He apparently is not too elated about the order, and apparently has indicated to me that he was not all fired up about it and would not raise too great objection to the motion that I will make, which is that this order be indefinitely postponed. And when the vote is taken I move it be taken by division. The SPEAKER: The Chair

The SPEAKER: The Chair recognizes the gentleman from Eastport, Mr. Mills.

Mr. MILLS: Mr. Speaker and Ladies and Gentlemen of the House: I am in full accord with the remarks of Representative Jalbert, and I would pose a question to the Chair in this fashion, to whosoever may want to answer. What is the reason for placing a state trooper in the House of Representatives? What is the emergency?

The SPEAKER: The gentleman from Eastport, Mr. Mills, poses a question through the Chair to anyone who may answer if they choose. The pending question before the House is the motion of the gentleman from Lewiston, Mr. Jalbert, that this House Joint Order be indefinitely postponed. All in favor of indefinite postponement will vote yes; those opposed will vote no.

A vote of the House was taken.

138 having voted in the affirmative and none having voted in the negative, the Joint Order was indefinitely postponed.

The Chair laid before the House the second tabled and today assigned matter:

On motion of Mr. Lee of Albion, referred to the Committee on Business Legislation, ordered printed and sent up for concurrence.

Mr. Carey of Waterville was granted unanimous consent to address the House.

Mr. CAREY: Mr. Speaker and Ladies and Gentlemen of the House: Much has been said about the youthful look that the Legislature has taken on in this session. After this session is over the younger members will obviously be graded on their efforts here as to performance and the leadership that they provide. Some will show signs of brilliance, and of course others will be unfairly graded because they tend to bide their time and sit and listen.

Saturday night, as usual, was a big night in the City of Waterville,

the city where things happen. The Maine Jaycees held their annual selection of the three outstanding young men in the State, and this was after the field had been narrowed to 14 men.

I take great pride, Mr. Speaker, in telling you that one of those three men is a Waterville native. And I know that the House will take even greater pride in knowing that the man of whom I speak is also a member of this House. and Ladies Mr. Speaker and Gentlemen of the House, the gentleman I speak of is our own Representative Earl Smith. (Applause)
