Mr. SUSI: Mr. Speaker, I move that we concur and would speak to my motion.

The SPEAKER: The gentleman from Pittsfield, Mr. Susi, moves that this Order be passed in concurrence. The gentleman may proceed.

Mr. SUSI: Mr. Speaker and Members of the House: This order and the ensuing order both propose payment from surplus of indebtedness which the State of Maine has already incurred. An alternative method to deal with these obligations which is being considered by some at this time is the issuance of bonds for this same purpose.

I would call it self-indulgence in the highest form for an individual to do this. I believe it is no different in state government. I strongly urge that we support this order, give it passage, and pay our honest bills with the money we have in hand now, and then decide what new spending we shall undertake in the light of how much we have left after we have paid our bills which we have already

incurred. To do differently would be being less than honest with ourselves and with the people of the State of Maine. Thank you.

RESOLVED: That, we, the Members of the One Hundred and Fifth Legislature of the State of Maine, now assembled, do hereby recognize and pay tribute to the Disabled American Veterans Organization upon its Fiftieth Anniversary and declare the date of March 3, 1971 as a special day to honor the Disabled American Veterans; and be it further
