To Governor Kenneth M. Curtis and Members of the One Hundred and Fifth Legislature

In compliance with statutory requirements, I submit herewith the annual report of the State Auditor for the fiscal year ended June 30, 1970. The financial data presented herewith are based upon the accounting records maintained in the Bureau of Accounts and Control.

### Scope of Examination

have made an extensive examination of major pertinent transactions; such as, appropriations and dedicated revenues. carrying balances, transfers and reserves; verified cash balances by direct communication with depositories; securities in custody of the State Treasurer were inspected; other securities were verified by direct correspondence with the custodial banks. Verified other assets and liabilities by such other auditing procedures as were considered necessary in the circumstances, and tested major sources of revenue on a selective basis. We did not make a detailed examination of all recorded transactions on the general books of the State for the year. We did, however, make a detailed examination of accounting records, procedures and internal controls, and verified financial transactions on a selective basis in our postaudits of the activities of the major State departments during the year. The results of these audits, together with comments, exceptions, and recommendations are contained in our individual audit reports submitted to the respective departments.

### Auditor's Opinion

Based on the scope of our examinations, it is our opinion that. except for the exclusion of certain trust and operating fund transactions and balances recorded and controlled locally by State agencies reflected herein. and not accompanying financial statements present fairly the financial position of the operating funds of the State of Maine at June 30, 1970, and the results of their operations for the year ended. fiscal then conformity with generally accepted governmental accounting principles applied on a consistent basis.

The SPEAKER: The Chair recognizes the gentleman from Standish. Mr. Simpson.

Mr. SIMPSON: Mr. Speaker, I would ask if the House is in possession of L. D. 298.

The SPEAKER: The Chair would answer in the affirmative.

Mr. SIMPSON: Mr. Speaker, I would rise to move that this body reconsider its action of yesterday in which we indefinitely postponed this measure, and I would like to speak to my motion.

The SPEAKER: The gentleman from Standish, Mr. Simpson,

moves that the House reconsider its action of yesterday whereby the Report and Bill were indefinitely postponed on Bill "An Act Providing for Adult Identification Cards under Liquor Law," Senate Paper 119, L. D. 298. The gentleman may proceed.

Mr. SIMPSON: Mr. Speaker and Ladies and Gentlemen of House: Yesterday you had before you a bill which would provide for adult identification cards under liquor control. This particular bill has been consistently tabled throughout the course of this session since we have had it in our possession. I do not feel that the people in this body really fully understood what was taking place yesterday, and I would hate to see a bill of this significance go down in defeat without having its debate on this floor within its merits or non-merits.

I would therefore ask that you support me and that this bill be reconsidered and open for debate.

Mr. Vincent of Portland

requested a division.

The SPEAKER: The pending question is reconsideration. Is it the pleasure of the House to reconsider our action of yesterday whereby the Report and Bill were indefinitely postponed? All in favor say aye; those opposed say nay.

A viva voce vote being taken,

the motion prevailed.

The pending The SPEAKER: question is indefinite postponement. Chair recognizes the

Mr. gentleman from Norway, Henley.

Mr. HENLEY: Mr. Speaker, I move this be tabled for two legisla-

tive days.

The SPEAKER: The gentleman from Norway, Mr. Henley, moves this matter be tabled until two legislative days pending the motion to indefinitely postpone. Is this the pleasure of the House?

(Cries of "No")

The SPEAKER: The Chair will order a vote. If you are in favor of tabling this matter for two legislative days you will vote yes; if you are opposed you will vote no.

A vote of the House was taken.

66 having voted in the affirmative and 70 having voted in the negative, the motion did not prevail.

The SPEAKER: The Chair recognizes the gentleman from

Standish, Mr. Simpson.

Mr. SIMPSON: Mr. Speaker and Ladies and Gentlemen of the House: I think that the question here is very simple and I would ask you to ask yourselves if you were in a position of a store owner or in a position of an individual working in a store, and a young man or a young woman of today's age, in the category of 18, 19, 20, 21 or 22 years of age were to approach you and ask to purchase liquor, could you, by looking at these people, say yes, you are 20, or you are 21, or you are 22? I think this is the question that this particular bill wants to prevent.

Up until just recently the State Liquor Commission provided adult identification cards for adults that were old enough to purchase liquor. When this person entered into a store, the store owner had the right to refuse the sale of liquor to these people if they did not have such a card. That card was paid for by the State. Subsequently, the moneys were taken away, and the identification cards were removed. This bill would require that those persons reaching the age of 20 and over who would like to have the privilege of purchasing liquor purchase an adult identification card from the Liquor Commission for the price of one dollar. That would not be any money that would be paid by the state. The Liquor Commission has the backing, will support this, and I feel that we owe this to our store owners in the State of Maine, and the people working in those stores that they have some type of legal way to make sure that they are selling liquor to an adult and not to a minor.

I would hope that you would support me, and that this not be indefinitely postponed, but that we concur with the Senate.

The Chair The SPEAKER: recognizes the gentleman from Portland, Mr. Vincent.

Mr. VINCENT: Mr. Speaker and Ladies and Gentlemen of the This bill has only been House: tabled once since it has been in the House, and I think it has been held up in committee quite a bit. So it hasn't been on the table all that long.

A brief history of what we had last session. We had some liquor ID's on the books last session which were abolished. And last there, around the state provided the fee for liquor ID's

of 55 cents per person.

The request this time is for a dollar to be paid for all adults. There are no provisions in this particular bill to cover tourists or summer residents, of which we get thousands in the state during the summer. I feel that the proper place for any photographic type identification would be in Motor Vehicles where they can be handled on drivers' licenses, and be available to all people, and that they be an aid for cashing checks, or if you were stopped for a traffic violation it would certainly be a help to the State Police.

At present anyone that wishes state identification could presently go to any police barracks and obtain the adequate identification needed. It isn't mandatory that anyone have this identification, which means that a person wouldn't necessarily have to have it to go in to purchase beverages at any

given place.

At present we are overburdened with identification. Most people carry a driver's license, Selective Service card, Social Security cards. numerous other identifications. And I feel that this would be one more area of just additional identification, for the sake of identification.

At present you pay \$5 for a driver's license, and it isn't worth anything as far as the Liquor Commission is concerned in the area of identification. If you are paying \$5 for a piece of paper it should be adequate for identification, and we shouldn't have to pay an additional dollar for liquor identification.

For these reasons I hope that you will go along with the indefinite postponement. Thank you.

The SPEAKER: The pending question is indefinite postponement. If you are in favor of indefinitely postponing the Report and Bill you

will vote yes; if you are opposed you will vote no.

A vote of the House was taken.

46 having voted in the affirmative and 89 having voted in the negative, the motion did not prevail.
