#### HOUSE

Thursday, March 25, 1971

The House met according to adjournment and was called to order by the Speaker.

Prayer by the Rev. Mr. Herbert Reid of Fairfield.

The journal of yesterday was read and approved.

Mr. Orestis of Lewiston was granted unanimous consent to address the House.

Mr. ORESTIS: Mr. Speaker and Members of the House: It is with great pride that I rise to note a special day in the hearts of many Maine citizens. Today is the 150th anniversary of the Greek Proclamation of Independence.

Maine's Greek citizens throughout the state are marking this day as an event never to be forgotten. Throughout the state, Greek families and the various Greek Orthodox communities are celebrating this day with appropriate services.

As the only member of this House of Greek descent it is a pleasure to bring this to your attention. Yesterday, I was happy to gather with Greek citizens from all over the state in the Governor's office for the signing of a proclamation honoring this day, and I wish to take this opportunity to read it to you:

"State of Maine

### PROCLAMATION

WHEREAS, March 25, 1971 is the 150th anniversary of the proclamation of freedom of Greece, and the beginning of the nation's struggle for independence; and

WHEREAS, Greece, a nation small in physical size, has been a veritable giant in the legacy of civilization which it has given to the world. In the annals of democracy and culture, there are few names greater than the Greek names of Plato and Aristotle, Euclid and Phidias, Sophocles and Homer, Demosthenes and Pericles; and

WHEREAS the struggles for Greece for liberty were made from early times against a background of beauty in line, thought and sound seldom again equalled by man; and

WHEREAS, since in the nineteenth century, and again in the twentieth, the Greek people struggled against tyranny and oppression with a yearning for liberty and Independence closely akin to that yearning which prompted this nation to throw off the yoke of oppression; and

WHEREAS, since today Americans of Greek blood or birth are continuing their tradition of leadership, and are enriching our nation and our state by their activities, both as individual citizens and through their church, fraternal service, veteran and other organizations; and

WHEREAS, the Greek Orthodox communities of the State of Maine have decided to commemorate this important occasion with ecclesiastical rites and with appropriate programs in the respective communities;

NOW, THEREFORE, I Kenneth M. Curtis, Governor of the State of Maine, do hereby proclaim March 25, 1971, as

GREEK INDEPENDENCE DAY in the State of Maine and urge its fitting observance by our citizens, as an expression of our appreciation of Greek contributions to liberty and the arts.

Given at the office of the Governor at Augusta, and sealed with the Great Seal of the State of Maine, this Eighteenth day of February, in the Year of Our Lord, One Thousand Nine Hundred and Seventy-one, and of the Independence of the United States of America, the One Hundred and Ninetyfifth.

Mr. MAHANY: Mr. Speaker and Members of the House: I would like to acknowledge Maine Potato Week and call to the attention of my colleagues the importance of this industry which represents a contribution of some \$500,000,000 to the economy of the State of Maine.

We give credit to all our in-dustry organizations and particularly the potato industry tax program administered by the Maine Potato Commission. We make no claim to perfection but are proud of the fact that we make an active contribution toward the development and promotion of our product both fresh and processed.

Our competition may use a wide range of promotional phrases from time to time to describe their product but none, we feel, come close to our claim that "The Maine Difference is flavor."

Mr. Mills of Eastport was granted unanimous consent to address the House.

Mr. MILLS: Mr. Speaker and Members of the House: After the address by our representative from Aroostook, Mr. Mahany, I would

pose a question to the gentleman through the Chair. I notice on the potatoes that I have received this morning that they are starting to sprout, and this is only March. I wonder if he can answer how this happens.

The SPEAKER: The gentleman from Eastport, Mr. Mills, poses a question through the Chair to the gentleman from Easton, Mr. Mahany, who may answer if he chooses.

The Chair recognizes that gentleman.

Mr. MAHANY: Mr. Speaker and Members of the House: The only answer I can give the gentleman, Mr. Mills, is, it is getting close to springtime and the potatoes are getting anxious to be placed in the ground to produce another crop. To hurry that small minor sprout along, of course, they have been washed, and perhaps laid here somewhere a day or two where it is a little too warm for proper ventilation and temperature.

The SPEAKER: The Chair recognizes in the rear of the Hall of the House the representative of the Maine Potato Industry, Miss Brenda Baker. The Chair would ask the gentleman from Easton, Mr. Mahany, to escort Miss Baker to the rostrum so that the Members of the House may see her, and she may make such remarks as she might desire.

Thereupon, Miss Brenda Baker was escorted to the rostrum by Mr. Mahany of Easton, amid the applause of the House, the members rising.

Mr. MAHANY: Mr. Speaker and Ladies and Gentlemen: It gives me great pleasure to introduce to you Miss Brenda Baker, our living image for our potato. (Applause)

Miss BRENDA BAKER: Mr. Speaker, it is indeed my pleasure to be here this morning, and I wish to thank you for the privilege of letting me come here and represent the Maine Potato Industry.

This is Maine Potato Week, as you know. It started March 17, is going through March 27, and those beautiful packages of Maine russets that you found are compliments of the Maine Potato Commission and the Maine Department of Agriculture.

I won't keep you long. I know you have a busy agenda. So I thank you very much for having me.

Thereupon, Miss Baker was escorted from the Hall by Mr. Mahany of Easton. (Applause)

the SPEAKER: The Chair recognizes the gentleman from Westfield Mr. Good.

Mr. GOOD: Mr. Speaker, I move we accept the Majority "Ought not to pass" Report.

The SPEAKER: The gentleman from Westfield, Mr. Good, moves that the House accept the Majority "Ought not to Pass" Report. The Chair recognizes the gentleman from Brunswick, Mr. Mc-Teague.

Mr. McTEAGUE: Mr. Speaker and Ladies and Gentlemen of the House: I would speak in opposition to Mr. Good's motion. The bill before us is L. D. 590, which is amended by Committee Amendment "A" filed under H. P. 462, and it is before you today.

The area of regulation involved here is the area of industrial homework, making goods that are customarily made in plants or factories at home. This exists in a number of industries, but it is particularly prevalent, and becoming more prevalent, in the shoe industry.

The bill, with the Committee Amendment, does not seek to abolish industrial homework in any way. It seeks rather to empower the Commissioner of Labor, if she finds, after hearing, that undesirable or abusive conditions are existing, to regulate industrial homework.

The need for regulation stems from the fact that industrial homework can, under certain circumstances, lead to unsanitary and unhealthful conditions both for the home worker and the consumer of the product; and furthermore, can subvert the enforcement of the Minimum Wage Laws and the Child Wage and Hour Laws. It also can have an undesirable effect upon the ability of people to make a living in the normal fashion working in shops or plants.

There are some very important exceptions from the ability of the Commissioner to regulate, which is set forth in Committee Amendment "A". Number one, this bill would not allow the Commissioner to in any way regulate industrial homework done on behalf of a charitable organization. There are certain religious and other charitable organizations that, as part of their programs, do have work done at home. This bill would in no way affect them.

This bill also contains a blanket exemption in the case of handicapped people. It is recognized that a person may have a handicap that precludes him from the possibility of working outside the home, and yet he may be able, if materials are provided to him at home, to work at home, and this is desirable. So this bill would in no way affect that.

Many states - I don't have the exact number, but I know that, for example, the Commonwealth n f Massachusetts and many states throughout the Union, do regulate industrial homework. Maine has absolutely no regulation whatsoever in this area. I feel it would be a worthwhile step not to ban industrial homework outright, but to provide for its regulation in order to maintain the enforcement of the Child Labor Laws, which you can't really enforce in regard to industrial homework. You don't know if the person sewing on a pair of shoes at home is eight years old or 88. There is no way to tell by inspection.

There are problems in the area of sanitation. You cannot control the sanitary conditions in a thousand home workshops as well as you can in ten factories. And there have been problems in the area of enforcement of Minimum Wage.

So I hope that this matter will be given consideration today and that you will vote to reject the motion of Mr. Good, and to accept the minority report so that you will have a chance to consider the bill with the amendment before you.

Mr. Speaker, when the vote is taken, I ask that it be by a division.

The SPEAKER: The Chair recognizes the gentleman from Machias, Mr. Kelley.

Mr. KELLEY: Mr. Speaker and Ladies and Gentlemen of the House: As one of the signers of the Majority "Ought not to pass" Report, I would like to make a few comments on this particular bill. First of all, this bill strikes at one of the fundamental privileges of Maine people; namely the privilege of working or producing something in your own home in an attempt to either supplement your income, or an attempt perhaps even to create your own business.

The previous speaker has just mentioned that this bill would at-

tempt to correct some of the inequities in homework, and as against people whom he says work in the normal fashion. Which would seem to indicate that those homeworkers work in an abnormal fashion; and I don't believe that this is true.

More than that, I don't think that the red herring of unsanitation and unhealthful working conditions is of any great importance. Neither do I think that the Child Labor Laws are abused.

Furthermore, if a person wishes to work in their own home, I can't see why this home should be entered at any time by some member of a new commission who would poke about the home to see if Child Labor Laws were being abused, and if the work was being produced under unhealthful or unsanitary conditions.

I think, ladies and gentlemen, that this is a red herring. I think you will find that the crux of the matter is simply that up until now the homeworker hasn't been unionized, and this is an attempt to start him on that road, to keep him under more or less control. And this is a foot-in-the-door piece of legislation. No one is so naive as to think that two years hence, or four years hence, this bill won't be even more restrictive.

This bill was given a good hearing; as you can see an overwhelming majority of the committee voted that it should not pass. And I would hope that every member of this House would support the "Ought not to pass" Report. Thank you.

The SPEAKER: The Chair recognizes the gentleman from Auburn, Mr. Emery.

Mr. EMERY: Mr. Speaker and Ladies and Gentlemen of the House: This bill, if it passed as is, would cause a lot of consternation in my area. There are a lot of people down there that have small children that work for a living handsewing shoes at home. And as was mentioned by the gentleman from Machias, Mr. Kelley, I think this is a step in the door for further regulation. I also think that we don't need any more people trying to invade the privacy of the home as guaranteed by the Fourth Amendment of the United States Constitution. I also think we have enough red tape on the books, and this is only some more. Thank you.

The SPEAKER: The pending question is on the motion of the gentleman from Westfield, Mr. Good, that the House accept the Majority "Ought not to pass" Report on Bill "An Act to Regulate Industrial Homework," House Pa-per 462, L. D. 590. A division has been requested. All in favor of accepting the Majority "Ought not to pass" Report will vote yes; those opposed will vote no.

A vote of the House was taken. 104 having voted in the affirma-tive and 29 having voted in the negative, the motion did prevail. Sent up for concurrence.
