Papers from the Senate

From the Senate: The following

WHEREAS, there is serious public concern as to the administration and operation of our mental institutions; and

WHEREAS, there is continuing evidence of inability to recruit and retain professional and nonprofes-

sional staff; and WHEREAS, there is substantial evidence of sagging morale among dedicated employees to the extent there is reason to believe patient care may suffer; and

WHEREAS, Baumgarten the 1968 brings serious Report of to problems light. recommendations for change; and

WHEREAS, the public responsibility towards patients in the care and custody of these institutions demands compassionate care of the highest quality and the full protection of the constitutional and civil rights of those committed to our care; now, therefore, be it

ORDERED, the House concurring, that a Special Joint Select Committee of Inquiry be appointed to study, review and analyze the operations, rules, regulations, procedures and programs of the Department of Mental Health and Corrections as they pertain to our mental institutions to ascertain that department appropriations are being administered in an effective and productive manner for the welfare of the citizens of Maine: and be it further

ORDERED, that said committee shall consist of 3 members of the Senate appointed by the President of the Senate and 7 members of the House appointed bv Speaker of the House Representatives who shall serve without compensation, but shall be reimbursed for their actual expenses incurred in the formance of their duties under this Order; such sums to be paid out of the Legislative Appropriation; and said committee shall elect its chairman and such other officers as it deems desirable: and be it further

that this special ORDERED. committee report its findings and recommendations forthwith to the 105th Legislature: and be it further

ORDERED, that all departments and agencies of State Government shall cooperate with the committee and are directed to provide such technical and other assistance as the committee deems necessary or desirable to carry out the purposes of this Order, including but not limited to personnel and staff as a part of their regular employment; and be it further

ORDERED, that the special committee shall have the authority to employ professional and clerical assistance as they deem necessary within the limits of funds provided; and be it further

ORDERED, that there is allocated to this special committee from the Legislative Appropriation the sum of \$5,000 to carry out the purposes of this Order. (S. P. 528)

The SPEAKER: The Chair recognizes the gentleman from

Lewiston, Mr. Jalbert.

Mr. JALBERT: Mr. Speaker and Members of the House: First I would like to state that I have nothing but very strong personal feelings for the author of this order, both legislatively speaking and as a personal individual. However, this particular order has a \$5,000 price tag on it; it would set up a special committee while we are now even in session of the Legislature, to make a thorough study of this problem, and I think it ought to be done. By the same token, we have presently a Joint Committee on Health and Institutional Services that is meeting at any time that it is necessary.

I feel that we will be here for a lengthy period. I feel that somewhere along the line this committee could be allowed to do its work. and part of its duties would be the proper functioning, after their deliberations, of the Mental Health and Corrections Department.

I can recall back a few years ago when a fantastic amount of subcommittees were set up, and in my humble opinion very little was accomplished through it. As an individual, and as Chairman of the Legislative Finance Committee, I made an in depth study of problems concerning the mental health and corrections institutions, particularly on the level of the mental health prob-Many times during the night I could be seen in the halls of the Pineland State Hospital, State Hospital, Augusta Bangor.

I submitted a report that was presented to the Legislative Research Committee, and with the help that I had, several of the arguments that I set forth were implemented, and several inconsistencies and errors straightened out.

I do not by any means say in making my motion that everything is A-OK as far as our institutions are concerned. That is not so. But my arguments are: one, that this here is an order that calls for a \$5,000 price tag: we have committee now that is existing that could be doing this work while we are in session; third, if their work was not continued, then other areas could be looked into, preferably in my opinion in the area of the Legislative Research Committee.

For those reasons, Mr. Speaker and members of the House, I now move the indefinite postponement of this order.

The SPEAKER: The gentleman from Lewiston, Mr. Jalbert, moves that this Order be indefinitely postponed.

Mr. Cooney of Webster requested a division.

The SPEAKER: The Chair the gentleman recognizes Orono, Mr. Curtis.

Mr. CURTIS: Some of us would like to investigate this a little bit closer. I move this be tabled for two legislative days.

The SPEAKER: The Chair would advise the gentleman that he did debate his tabling motion.

Tim Dorr of North Windham sports his patch, something of a status symbol in the area, as he talks with Warden Donis Wheaton and Raymond Curtis."
