Mr. Hoffses of Knox presented the following Joint Resolution and moved its adoption:

STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND SEVENTY-ONE JOINT RESOLUTION MEMORI-ALIZING CONGRESS TO PRO-VIDE FOR INTERGOVERN-MENTAL SHARING OF FEDER-AL INCOME TAX REVENUE

We, your Memorialists, the Senate and House of Representatives of the State of Maine in the One Hundred and Fifth Legislative Session assembled, most respectfully present and petition your Honorable Body as follows:

WHEREAS, a resolution of our nation's myriad and diverse problems is contingent upon a viable partnership between the Federal Government and strengthened State Governments; and

WHEREAS, the Federal Government, by its extensive reliance on the graduated income tax as a revenue source, has virtually preempted the use of this source from state and local governments, thereby creating a disabling fiscal imbalance between the Federal Government and the state and local governments; and

WHEREAS, increasing demands upon state and local governments for essential public services have

compelled the states to rely heavily on highly regressive and inelastic consumer taxes and property taxes; and

WHEREAS, federal revenues based predominantly on income taxes increase significantly faster than economic growth, while state and local revenues based heavily on sales and property taxes do not keep pace with economic growth; and

WHEREAS, the fiscal crisis at state and local levels has become the overriding problem of intergovernmental relations and of continuing a viable federal system; and

WHEREAS, the evident solution to this problem is a meaningful sharing of federal income tax resources; and

WHEREAS, the United States Congress, despite the immediate and imperative need therefor, has failed to enact acceptable revenue sharing legislation; now, therefore, be it

That we, RESOLVED: your Memorialists, recommend and urge that the Congress of the United give States immediate a n d favorable consideration to intergovernmental sharing of Federal Income Tax Revenue; and be it further

RESOLVED: That a copy of this Memorial, duly authenticated by the Secretary of State, be transmitted forthwith by the Secretary of State to the President of the Senate and the Speaker of the House of Representatives in the Congress of the United States and to the members of the said Senate and House of Representatives from this State, (S. P. 148)

The PRESIDENT pro tem: The Chair recognizes the Senator from Aroostook, Senator Harding.

Mr. HARDING of Aroostook: Mr. President and Members of the Senate. I realize that what we do today on this resolution will not have very much effect upon the people of Maine, and probably just about as much effect upon the Congress. However, this resolution expresses a thought and request which is so repugnant to my idea of what is responsible insofar as state government is concerned, and what is irresponsible insofar as our requests are concerned, that r don't feel like sitting here and acknowledging, by letting this thing go under the hammer, that this expresses my views, because it does not.

Now, I think that under the second Whereas here, where it says "Whereas the Federal Government, by its extensive reliance on the graduated income tax as a revenue source, has virtually preempted the use of this source from state and local governments ", that it isn't true. I mean, we have a graduated income tax here in the state and it is up to us: if we want to raise it we can raise it. We don't have to look to the federal government, already in deficit spending, to send us part of the money which they collect.

I think that also in the Bangor Daily News today there is a column which expresses so well my views on this that I would just like to read them to the Senate for your consideration. This particular sentence is so apropos - it says, "The Federal Government has grown fat and overpowerful because of default at the local level." I couldn't agree with that thought more. It asks this question: "Why should the Federal Government be paying to educate pre-schoolers in West Virginia or educationally deprived teenagers in Tennessee, or to build dormitories on a campus in Oregon because the states and the other units of local government would never do it?" It goes on to say that the only reason for the growth of the federal government the is abdicating of the responsibilities on the local level.

This provision that is asked for in this puts the local and state governments in the position of being like orphans, of saying that we don't have the courage or the guts to pass the taxes to do these things, so we ask you to take the courage that we should have and collect the taxes for us, and don't have any strings attached and send the money back, and then let us

like good children spend it as we like to spend it. Now, those things are just never to be; you are asking for the never-never world, because congressmen are not going to go out on the political limb and face possible defeat by raising high taxes so that you can spend the money in any way you want. This is just not the way things work.

So I just don't feel like sitting here and seeing this resolution go through, with the no-stringsattached type of revenue sharing. and suggesting that I endorse it. because it makes me heartsick now to see how the state governments have surrendered their responsibilities. And for us to take this final step and say, "Yes, go ahead and collect the taxes for us, will you please, because we don't have the guts to do it, but we would like to spend the money after you collect it," I cannot endorse such a suggestion. And for whatever it may be worth, I want to express my personal opposition to this type of thing which the State of Maine would request of the Congress of the United States. Thank you.

The PRESIDENT pro tem: The Chair recognizes the Senator from Kennebec, Senator Katz.

Mr. KATZ of Kennebec: Mr. President and Members of the Senate: Along the same lines I would like to express my support of the concept of this memorial.

I wish I were good at remembering figures. I wish I could tell you how many good legislators and good governors all around the United States have been defeated in seeking re-election because they have had the guts to try to meet things at the local level.

In particular, I would like to tell you a little something a bout Governor Tiemann of Nebraska, a man who did exactly what the Senator from Aroostook, Senator Harding said we didn't have the courage to do. Senator Tiemann became governor of a state that was dragging its heels, and he got out and fought. He said "These are the things that the state needs." He was defeated in his bid for re-election by a very substantial margin because he had the courage to do what he felt was necessary.

I wish I could remember and tell the Senate the percentage of increase in expenditures by state and local governments over a period of time and compare them to reactions by the federal government. I wish I could quote the figures that indicate how many hundreds and hundreds of per cent the bonded indebtedness of local communities, of states, and other political s u b d i v i s i o n s have increased in recent years.

I think the State of Maine has lots to be proud of. We have had the courage to do things at the state level that needed doing. We have had the courage to increase the flow of educational support to the towns and cities by eighty-one per cent in just two legislative sessions. We are attempting courageously to meet the problems of the environment at a time when the federal government is creating programs that they are not funding. I think there is an imbalance.

My only misgiving is that there are lots of things that the State of Maine should be doing to clean its own house before it gets federal support. And I can think, of course. of the administration and the laws pertaining to the property tax in the State of Maine which are in a shambles. And I can think about the lack of development o f program review and program evaluation at the state level, and would hope that the flow of Т federal money would not reduce our incentive to do the things that we should be doing to help ourselves. But there just isn't enough money generated from our tax sources to do the job, and I for one am firmly convinced that the time has come to exercise our sovereign rights and to ask, and even demand, that a greater share of the resources of the country be used by the states for their own problems.

I disagree vehemently with Senator Mansfield last night on TV when he said very, very clearly that as far as he was concerned Washington could do it better. The PRESIDENT pro tem: The Chair recognizes the Senator from Knox, Senator Hoffses.

HOFFSES of Knox: Mr. Mr. President and Members of the Senate: As the sponsor of this resolution, and as the Chairman of the Interstate Cooperation Commission, I would like to defend revenue-sharing proposal. this at mentioned ā caue-As us the other day of my party members, 93 per cent -– and I repeat - 93 per cent of the total personal income tax which is levied upon the people of this country is collected by the federal government. Now, when such a staggering amount of money is collected by our federal government, I ask you in all sincerity what is there left for the states.

As the good Senator from Aroostook has indicated, we do have a state income tax. And I think that it is in the hearts and the minds of every one of these legislators that if they are to impose an increase on our state income tax to meet some of the financial problems of this state that they well know what the net results are going to be when they run for reelection.

Now, the federal government has over the years preempted and assumed the responsibilities of the states. Maybe we are responsible for not holding those responsibilities within our own states, but it is easy, it is the easy route, to let someone else assume those financial responsibilities, and we all are guilty of that act.

Now, through the National Legislative Conference, through the Council of State Governments, through the Conference of Governors, it is the strong wish and desire that the states once again assume their responsibilities and their rights. It is only if we do take back those responsibilities, and those financial responsibilities as well, are we going to continue as individual states. Otherwise we might as well give up and let "Daddy", the big uncle down in Washington, run our whole lives.

I, for one, believe in home rule and I think that we, the people in the State of Maine, are qualified to spend our money in the best interest of all of the people of the State of Maine. And I disagree with those in our federal system who seem to think that we have the knowledge and the ability to earn the tax dollars, but when they go down to Washington that we do not have the intelligence and the ability to spend that same money when it comes back to the individual state.

Now, ladies and gentlemen, there are virtually nine states in this country that are bankrupt, and untold numbers of cities which are bankrupt from the responsibilities which have been heaped upon them, and in many cases by this same federal government which wants to tax us for ninety-three per cent of our tax dollars, but doesn't want to give any of it back to us.

We all know some of the programs which the federal government has advocated, and we have accepted, and then the federal government moves out from under. and we are saddled with the financial responsibility of continuing those programs or scuttling them. And we all know what the results would be if we scuttled those programs, the hue and cry would be something terrible. So we have to assume that financial responsibility which the federal government has helped to place upon our shoulders.

the good Senator from As Kennebec said, that he was not aware of the increase of the which is imposed indebtedness upon the states. I would like to inform this Senate that the increase in the past six years, the state indebtedness of all of the states in this country, has increased \$140 billion dollars. Now, how long are we going to continue to tax ourselves, to bond ourselves, and continue to give to the federal government the amount of taxes which we are giving to them, and they not giving back to us because we don't have the knowledge and the ability to spend those tax dollars wisely, but we do have the knowledge and ability to create the economy that the government can tax?

I certainly hope the members of this Senate and of this Legislature will wholeheartedly and overwhelmingly endorse this resolution so that we can exert some pressure; not the amount of pressure that a Constitutional Convention would exert, but at least the people in Congress will know what our situation is.

Mr. President, I would respectfully ask for a roll call on this resolution.

The PRESIDENT pro tem: The Chair recognizes the Senator from Kennebec, Senator Levine.

Mr. LEVINE of Kennebec: Mr. President and Members of the Senate: I feel that this resolution is a very good one for the people of the State of Maine, and it is the right time for presenting this resolution. As we all know, the war is coming to an end in Southeast Asia, and there will be a lot of money saved, the money that is being spent for defense. And if the States don't try to get their share of this money it will be spent in some other way. It would give us an extra burden, and we would have to tax the people in the State of Maine with a tax that we can't afford. So, I back this resolution.

The PRESIDENT pro tem: The Chair recognizes the Senator from Somerset, Senator Johnson.

Mr. JOHNSON of Somerset: Mr. President and Members of the Senate: I have listened with great interest to the remarks of my good, distinguished s e a t m a t e, Senator Harding, and I think that he will agree with me that over the years that he and I have been members of this body he has in some cases, and perhaps it could have been many, whereby he has pushed bills in this Legislature, and one of the sales points that I remember was the fact that the federal government would match it fifty-fifty, and that involved us in many areas.

However, in the other area, on this memorialization to Congress, I have put in three of these in my time and I have yet to see any results. So, I do wonder whether a memorialization to Congress would have any effect except to be read by different people. And I am not sure just how I would vote on it but those are my remarks.

The PRESIDENT pro tem: A roll call has been requested. In order for the Chair to order a roll call it must have the affirmative vote of one-fifth of the members of the Senate. All those in favor of ordering a roll call will please rise and stand in their places until counted.

Obviously more than one fifth having arisen, a roll call is ordered. The question before the Senate is the motion of the Senator from Knox, Senator Hoffses, that the Joint Resolution be adopted. If you are in favor of adopting this Joint Resolution you will vote yes; if you are opposed you will vote no.

The Secretary will call the roll.

The PRESIDENT pro tem: The Chair recognizes the Senator from Cumberland, Senator Carswell.

Mrs. CARSWELL of Cumberland: Mr. President and Members of the Senate: The Health and Welfare Department has five offices in the City of Portland scattered all over the city, to the tune of forty-three thousand dollars a year rent.

Now, I feel that this is not in the interest of economy or good service to the taxpayer. A person needing child and family services goes to the east end of the city, practically, to get service there, then must go downtown to get eye care and special services, must go up toward the west, up on State Street, to get alcoholic rehabilitation services, and I could go on and on to tell you that but by the time the person gets the total services that that person needs he is pretty well tired out. And I guarantee there is perhaps quite a bit of duplication. So, I would hope that somebody would table this bill until February 9th, so we can see whether or not the Health and Welfare Department is going to do something about organizing its services in one location.

The PRESIDENT pro tem: The Chair recognizes the Senator from Washington, Senator Wyman.

Mr. Wyman of Washington then moved that the Bill be tabled and specially assigned for February 9, 1971, pending Acceptance of Either Report.
