WHEREAS, the private and special laws of 1941, chapter 69 created the Maine Turnpike Authority for purposes of providing an expressway from a point at or

near Kittery to a point at or near Fort Kent, Aroostook County; and

WHEREAS, the Federal Government and the State of Maine have set up a system of interstate highways: and

WHEREAS, pursuant to said Act an expressway was built between Kittery and Augusta; and

Kittery and Augusta; and

WHEREAS, a portion of the Maine Turnpike has been designated for inclusion in said interstate highway system; and

WHEREAS, payment of tolls on said highway places a burden on users of that section of designated highway; and

WHEREAS, existing tolls create congestion on Route No. 1 and other alternate routes; now, therefore, be it

ORDERED, the House concurring, that the Legislative Research Committee be directed to study, review and analyze the operations of the Maine Turnpike Authority, its financial structure and the feasibility of reverting the Maine Turnpike to the State of Maine; and be it further

ORDERED, that the committee report its findings and recommendations at the next special or regular session of the Legislature; and be it further

ORDERED, that all departments and agencies of State Government shall cooperate with the committee and are directed to provide such technical and other assistance as the committee deems necessary or desirable to carry out the purposes of this Order, including but not limited to personnel and staff as a part of their regular employment; and be it further

ORDERED, that there is allocated to the committee from the Legislative Appropriation the sum of \$3,000 to carry out the purposes of this Order; and be it further

ORDERED, that the committee shall have the authority to employ professional and clerical assistance as they deem necessary within the limits of funds provided.

The PRESIDENT: The Chair recognizes the Senator from Knox, Senator Hoffses.

Mr. HOFFSES of Knox: Mr. President and Members of the Senate: I feel that perhaps there should be a little explanation to this bill before we consider it further.

The question has been raised as to federal regulation governing this particular matter. I would point out that the federal law applies only to the shooting of migratory birds with rifle or handgun. It makes no stipulation as to the shooting at anyone's decoys. This particular piece of legislation would spell that out, and would further spell out the meaning of "near a hunter's decoys."

Now, I would further point out that anyone who feels that this might create a situation whereby an individual could practically seal area where migratory waterfowl are frequenting bу placing decoys strategically around the area, this would not apply to the use of shotguns with legal shot which are allowed in the pursuit of migratory waterfowl. With that brief explanation, I would move the pending question.

The PRESIDENT: Is it now the pleasure of the Senate that this bill be passed to be engrossed in

concurrence?

The motion prevailed.

recognizes the Senator from Kennebec, Senator Katz.

Mr. KATZ of Kennebec: Mr. President and Members of the Senate: This bill is identical to one that the 104th Legislature passed that was considered by the Committee on Education. I move this bill be referred to the Committee on Education.

The PRESIDENT: The Chair recognizes the Senator from Oxford, Senator Dunn.

Thereupon, on motion by Mr. Dunn of Oxford, tabled and tomorrow assigned, pending the motion by Mr. Katz of Kennebec that the Resolution be referred to the Committee on Education.
