Mr. WYMAN of Washington: Mr. President, I move that we accept the Majority Ought Not to Pass Report of the Committee, which was eleven to two, all three Senators having voted Ought Not to Pass.

The PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Kellam.

The PRESIDENT: The Chair recognzes the Senator from Cum-

berland, Senator Graham.

Mr. GRAHAM of Cumberland: Mr. President and Members of the Senate: I would like to say some words for this bill. We have here a bill that would permit the noise pollution of planes coming into our airports to 108 decibels. Now, this is the limit that already applies to subsonic planes, according to FAA regulations, and I think we should apply it to supersonic planes too because they will be bringing in a great deal of noise pollution, because pollution is caused by noise. Noise is pollution, and we have a chance here to nip this new form of pollution in the bud.

As you know, construction of the SST was suspended in the United States, so these will be foreign planes. That is, they will be planes manufactured abroad. And if the American aircraft companies know that we have this prohibition, and it is also being enacted, I understand, in Massachusetts and New York, where the other big eastern landing strips are, if they know we have this prohibition they will be less inclined to buy these planes. Once these new supersonic planes are bought by American companies, it will be difficult indeed to cut off this form of pollution.

As any of us who have sat on the Natural Resources Committee know, it is very, very difficult to end pollution once it has begun. How nice it would have been years ago if we could have stopped the grade of pollution that now occurs in our rivers, streams and lakes, which we could have then. Here we have a chance to do it with noise pollution. I, therefore, urge this Senate to vote against the motion of my esteemed colleague, with whom I really hesitate to disagree, but I think that this is a good move forward toward ending a form of pollution that we can end without any cost. Thank you.

The PRESIDENT: The Chair recognizes the Senator from Sagadahoc, Senator Schulten.

Mr. SCHULTEN of Sagadahoc: Mr. President and Members of the Senate: I appreciate those fine words from the very fine Senator from Cumberland County, Senator Graham. We worked very closely in committee, and I am very happy to have a man of such caliber associated with us there.

I think this particular bill that we are looking at today, which we tabled the other day, L. D. 887, which would regulate noise pollution of the supersonic transport under the Environmental provement Commission, I believe this bill had a lot of merit up until the time that the United States Congress decided that they were changing the priorities of what they considered important in the world and that they were suspending the construction of the supersonic planes. So that leaves only one manufacturer in the world making a supersonic plane, and I believe that is a Russian manufacturer. As we all know, there is the British-French joint venture to produce a supersonic plane, but the actuality of this plane being brought to the point of commercial production, I would say, today is very much in doubt. Doubt about design, doubt about financial capabilities of these countries to produce, and also the doubt that they would find the buyers to make it commercially profitable.

So, while I think that the bill did have merit, I think the destiny of the world has moved on. And we should move on also, recognizing that we do not at the present have the emergency situation on supersonic transports that we once had. So, I consider this bill untimely, irrelevant, and really cluttering, to no advantage.

I would just read a bit from the statement of fact on this particular bill, because I think it helps understand the problem. It says: "The Legislature further is particularly concerned that the proposed supersonic transport which will significantly increase the noise level surrounding our state's airports - 40 times louder than the existing noise of the 108 PNdB for present supersonic transports, which is the proposed Federal Aviation Administration limit." They go on to say they hope the Federal Aviation Administration will continue to expand these limitations to the new supersonic transports when they do become available.

This is a matter of the United States Government. It is a great cause of concern for the Government and, as the editorial in the Portland Press Herald today points out, that if all the states get into the act of prohibiting or licensing what supersonics can do, before they are even available, we are going to have a very confused legislative mess which will finally have to be straightened out by the Federal Government anyway.

I would like to say that if I had a reason to vote for this bill, and if I had a reason to vote for another supersonic bill, which is also tabled for today, that the only two good reasons I can presently think of as to why it should be done is because of the work done by two freshman legislators from the other house. These two young men devoted tremendous time and energy to producing bills and arguments for these supersonic prohibitions that really were outstanding, and I think that the 105th Legislature is very proud to have young men coming along who are so willing to dedicate themselves to what they believe is important. fortunately, their idea of importance just doesn't happen to be

relevant at the moment, but the work they did, I think, should deserve quite a lot of praise from the rest of us, and I hope that we would all carry on in the same manner of dedication. But, outside of that I don't feel that this particular bill is timely, and I would urge the Senate to go along with the Majority Ought Not to Pass Report of the Committee.

The PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Kellam.

Mr. KELLAM of Cumberland: Mr. President and Members of the Senate: I believe, as I stated the other day on the other SST bill that I had sponsored myself, that it is very, very important for the State of Maine to go on record as being opposed to the noise level which would be generated by the SST as it now stands.

I believe that while the British-French SST is in the development stage is the time to force them to perfect their aircraft to the level where it will be able to meet a tolerable standard. I feel that if we do not do so, and they are allowed to continue and to probably sell the airplane to the U.S. airlines, and we know there are orders in for this plane, it would be very difficult then to back up and try to eliminate the noise that would be generated.

This bill, as the previous bill we discussed, does deal with noise levels, and it ties in with the FAA and tries to make a workable formula. I think it is a very good bill. I think it spells out considerably more detail than the other SST bills.

I did want to say that I have received back copies of the bills in Massachusetts which have received approval down there. I am not sure if the bill has finally been enacted, but at least in some vote it received approval. Their bill runs about two lines and just merelly prohibits the SST from landing at Logan Airport and other airports.

I feel that this bill is certainly very well thought out and very meritorious, and I hope that the body will stand up and try to help the environment for the future while it still can be done. When

the vote is taken I would appreciate having a roll call.

The PRESIDENT: A roll call has been requested.

The Chair recognizes the Senator from Sagadahoc, Senator Schulten.

Mr. SCHULTEN of Sagadahoc: Mr. President and Members of the Senate: Your indulgence please for one moment, because I am afraid that the good Senator from Cumberland, Senator Kellam, has not yet had an opportunity to read this morning's paper, and one of his friends of the same party was good enough to pass it around to the Senate here. There is a particularly important paragraph here that I think deals with this matter that we are considering, and I will quote:

"With or without a federal standard, commercial operators of supersonic aircraft will give careful thought to the matter of speed over land areas. The congressional debate on the continued funding of the SST provided a generous expression of feeling about the swift aircraft and their sonic booms.

"If the nuisance of sonic booms should become common because of commercial use of the new planes, the reaction could be a set of restrictions more severe than those presently contemplated — and perhaps a state-by-state set of regulations confusing as well as restrictive."

I would suggest that the good Senator read this article and ponder it, because I think it has a great deal to do with the problem we are now considering.

The PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Kellam.

Mr. KELLAM of Cumberland: Mr. President and Members of the Senate: I appreciate having the Portland newspaper pointed out to me by the good Senator from Sagadahoc and I have taken the opportunity to read the quoted paragraph while he was reading it.

The part that strikes me, it says, "With or without a federal standard, commercial operators of supersonic aircraft will—" and so forth, as the good Senator stated. One problem that bothers me is this "with or without federal

standards," because we do know that in the past commercial aircraft have never given attention to noise pollution without federal standards and, as a matter of fact, the present 747 does not meet these standards and has an exception for a period of time while they are being forced to readapt engines to meet the noise level standards. It would seem to me to be very, very important to put this bill on the record, and not only rely upon the interpretation given by probably some very well qualified editorial writer in Portland, but we do knw that the commercial operators have not taken into consideration the best benefit of the welfare of the country.

The PRESIDENT: The Chair recognizes the Senator from Aroostook. Senator Violette.

Mr. VIOLETTE of Aroostook: Mr. President and Members of the Senate: I rise to oppose the motion of the good chairman of my committee, Senator Schulten from Sagadahoc, in regards to this bill. This is with some hesitancy that I oppose his motion because we get along so well in our committee work, but I guess it is inevitable that we are not going to be able to agree one hundred per cent of the time.

I too was impressed with the presentations made by the sponsors of these bills. I felt that the new draft which we have, 1675, which is the original bill presented by Representative McCloskey of the other branch, is a very, very good bill.

Now, I know that there is a lot of emotion mixed in with this type of discussion, in the consideration of supersonic aircrafts and so forth. I know the situation that took place in the Congress some weeks ago. My feeling on this is that it does not direct itself at all to whether we should have supersonic planes or should not have them. I think certainly that it is inevitable that we will have them. I guess, like everything else, after we built the Model T Ford, if we passed a law and said that cars aren't going any faster than model T Fords could go at that time, maybe it might have been a good thing, now that you think of the deaths on the highways. Regardless, progress has moved along and certainly we will have, in my judgment, supersonic planes flying before too many years.

My position that I take here is not whether or not we should have supersonic planes flying but I think the noise emissions from whatever planes are flying, and it is a very important matter for us here in the state to consider. I think it is a very valid subject for us to consider. Now, this bill does place under the jurisdiction of E.I.C. the noise pollution of aircraft, noise from aircraft which exceeds the standards established by the Federal Aviation Administration Regulation. These have been pointed out to you today. I think that these are reasonable standards and I don't know, of course, if there are a lot of people that live around airports, but I know that I live in the vicinity of Loring Air Force Base, and my residence is probably twelve to fifteen air miles from the take-off strip at Loring Air Force Base. And the noise that these planes make as they take off and pass over my house. and which most of Van Buren is within the take-off path of the bombers and tankers at Loring Air Force Base, will wake you up at night and also disturb you in the daytime. I guess we kind of get used to them at times. I don't know what the noise emission levels of those planes are; I have never asked anybody, but I do seriously believe that the matter of noise emissions is a very important matter for us to consider.

Under this FAA regulation, Part 36, the Federal Aviation Administration has set noise emission standards which they feel are reasonable and which should not be exceeded for subsonic planes, because that is all we have today. Fine, commercially. The loophole in the law is that it provides for states and airport management to set their own standards. They can either reduce them or raise them. So, in fact, the Federal Aviation Regulation is subject to being changed by any legislation in the

State of Maine we were to make, or which any airport in the State of Maine, any airport management in the State of Maine wishes to make, so they don't have to adhere to those. While they say these are the standards which are tolerable by people today with regards to these planes, any airport management is free to raise them. So, I think it is a valid subject for us to consider.

I personally have no objection to whether or not we fly supersonic planes, and it is not the subject which ought to be under consideration here. But I think the emission of noise which any of these planes are going to make is very valid for us to consider, and that is the point on which I support this bill, that whatever planes fly in our state, why they should not today make greater noise than those which the FAA presently feels are compatable with our standards of noise emissions. That is the basis on which I support this legislation that I would hope this Senate would accept.

The PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Berry.

Mr. BERRY of Cumberland: Mr. President and Members of the Senate: It would seem that any further words of wisdom might be a little bit redundant, but I would just merely like to point out that we have been assured that there will be no supersonic transports flying over or landing in Maine at least for another two years. As a matter of fact, I think the Concorde is scheduled perhaps for operational flight in 1975. In view of this fact, it would seem that we can well leave this matter to consideration by subsequent legislatures. I would hope that you would support the position of Senator Schulten and his committee majority report.

The PRESIDENT: The Chair recognizes the Senator from Franklin, Senator Shute.

Mr. SHUTE of Franklin: Mr. President, would the Secretary give us the reading on the two reports?

The PRESIDENT: The Secretary will give the committee report.

The SECRETARY: The Majority Ought Not to Pass Report was signed by Senator Schulten, Representatives Ault, MacLeod, Curran. Herrick. Marion Brown. Hardy.

The Minority Ought to Pass in New Draft Report was signed by Senator Graham, Representatives Whitson, Kilroy, Senator Violette, Representatives Smith and Cummings.

The PRESIDENT: Is the Senate ready for the question?

The Chair recognizes the Senator from Waldo, Senator Greeley,

Mr. GREELEY of Waldo: Mr. President and Members of the Senate: I just want to say something in reference to what the Senator from Cumberland said. Senator Graham, about controlling pollution noise. They did try it years ago. When I was a kid and lived in Bar Harbor I had a flock of hens and I had a rooster to go with them. And during the summer months when the millionaires and the summer people came there, I had to ship that rooster up to my grandfather's farm and then I couldn't have him back for the whole year.

PRESIDENT: The Chair The recognizes the Senator from Aroos-

took, Senator Violette.

Mr. VIOLETTE of Aroostook: Mr. President, I would just like to ask the good Senator from Waldo, Senator Greeley, if the egg production declined during the absence of the rooster?

The PRESIDENT: The Senator has posed a question through the Chair which the Senator may an-

swer if he desires.

The pending question before the Senate is the motion of the Senator from Sagadahoc, Senator Schulten, that the Senate Accept the Majority Ought Not to Pass Report of the Committee on Bill, "An Act to Regulate Noise Pollution of the Supersonic Transport under the Environmental Improvement Commission."

A roll call has been requested. In Order for the Chair to order a roll call, it requires the affirmative vote of one-fifth of those Senators present and voting. Will all those Senators in favor of ordering a roll call please rise and remain standing until counted. Obviously more than one-fifth having arisen a roll call is ordered.

The Chair will state the question once more. The pending question before the Senate is the motion of the Senator from Sagadahoc, Senator Schulten, that the Senate Accept the Majority Ought Not to Pass Report of the Committee on Bill, "An Act to Regulate Noise Pollution of the Supersonic Transport under the Environmental Improvement Commission". "Yes" vote will be in favor of accepting the Majority Ought Not to Pass Report; a "No" vote will be opposed.

The Secretary will call the roll.

I note in the same editorial quoted by the Senator from Sagadahoc, Senator Schulten, that the comment is that certainly we can restrict flights over the state and avoid perhaps very, very major sonic booms without in any way restricting the flight of aircraft over the state. I would hope that we would reject the Ought Not to Pass Report and move on to accept the Ought to Pass Report. I would request a division.

The PRESIDENT: A division has been requested.

The Chair recognizes the Senator from Sagadahoc, Senator Schulten.

Mr. SCHULTEN of Sagadahoc: President and Members of Mr. the Senate: It seems too bad to end the week disagreeing with members of my own committee, as much as I admire and respect them. I think here again we have a bill regarding supersonic aircraft, and it is not relevant at all. This particular bill. L. D. 818, "An Act Prohibiting Supersonic Flights by Nonmilitary Aircraft", on this particular bill I have been given to understand that the State of Maine has no constitutional right to regulate the use of the airspace over the state. The Federal Aviation Agency has this jurisdiction, and this came from the Attorney General's Office, and I think this statement once and for all should lay to rest the supersonic aircraft until another session of a new legislature comes to review the problem as it exists then.

I would move that the Senate Accept the Minority Ought Not to Pass Report of the Committee.

The PRESIDENT: The Chair would inform the Senator that is the motion presently before the body.

Is the Senate ready for the question? The pending question is the motion of the Senator from Sagadahoc, Senator Schulten, that the Senate accept the Minority Ought Not to Pass Report of the Committee on Bill, "An Act Prohibiting Supersonic Flights by Nonmilitary Aircraft".
