SENATE

Monday, January 24, 1972 In compliance with a Proclamation of His Excellency, Governor Kenneth M. Curtis, the Senators convened in the Senate chamber at four o'clock in the afternoon, Eastern Standard Time, and were called to order by the Secretary.

Prayer by the Rev. Bruce W. Meyer of Augusta.

On motion by Mr. Hoffses of Knox, Senator Richard N. Berry was unanimously elected President pro tem for today's session and was escorted to the rostrum by the Sergeant - at - Arms where he assumed the duties of that office.

The Secretary read the Proclamation:

STATE OF MAINE

PROCLAMATION

By the Governor

WHEREAS, I have determined that there exists in the State of Maine an extraordinary occasion requiring the Legislature of this State to meet in a special session to consider legislative proposals concerning:

Reorganization of State departments and agencies, a bill appropriating operating and surplus funds to departments, agencies and the University of Maine, a construction bond issue for the University of Maine, a municipal bond finance authority, an expanded food stamp program, the Municipal Public Employees Labor Relations law, an authority to regulate Maine industrial port and land development, payment of State school construction subsidies, ambient air quality standards, revisions of the site location law, the management of solid wastes, conforming certain State laws to federal statutes affecting property acquisition, the correction of errors and inconsistencies in the State laws, and other matters judged by the Legislature as necessary to the welfare of the State; and to receive communications on bills affecting the public prosecuting system and taxation in unorganized townships

as passed in the regular session, and

WHEREAS, legislative leaders have agreed that a Special Session is necessary;

NOW, THEREFORE, I, Kenneth M. Curtis, Governor of the State of Maine, by virtue of the Constitutional power vested in me as Governor, convene the Legislature of this State, hereby requesting the Senators and Representatives to assemble in their respective chambers at the Capitol at Augusta on Monday, the twenty - fourth day of January, 1972, at four o'clock in the afternoon, in order to receive communications and to consider and enact such measures as in their judgment will best promote the welfare of the State.

ORDERED, that free telegraph service may be provided for the special session for each member of the Senate and House, and each representative from the Indian Tribes at the Legislature, to the number of 10 messages of reasonable length, to points within the State of Maine, the privilege granted to be a personal privilege, not to be exercised by other than the member of the Senate and House, and each representative from the Indian Tribes at the Legislature, may be provided with a credit card under the direction of the Secretary of the Senate and Clerk of the House, respectively, the cost of the service to be paid to Western Union Telegraph Company at regular tariff rates. (S. P. 736)
