Tuesday, February 1, 1972 Senate called to order by the President.

Prayer by the Rev. Father Henry B. Dallaire of Hallowell.

Papers from the House Joint Order

Whereas, the tax structure of the State of Maine must adequately meet the ever-increasing demands for financing future public services; and

Whereas, the additional demands for welfare, educational subsidy and change in method of school financing pose grave challenge to the existing structure; and

Whereas, all major sources of taxation are presently being utilized by the State with no consideration being given to alternative means of meeting probable increases: and

Whereas, there is an urgent need to determine if the present tax structure is fair, equitable and adequate as presently constituted to meet the needs of the future;

now, therefore, be it

ORDERED, the Senate concurring, that there is created a Special Joint Interim Committee to consist of 3 Senators to be appointed by the President of the Senate and 4 Representatives to be appointed by the Speaker of the House to study the tax structure of this State and for the purpose of this study any subject or matter adjudged by the committee to be relevant or germane to the subjects of its study or helpful to it in the consummation of its work hereunder shall be deemed within the scope of the committee's inquiry hereunder; and be it further

ORDERED, that the committee shall report the results of its study to the next regular session of the Legislature; and be it further

ORDERED, that all state departments and agencies provide the committee to the extent possible, with information and assistance in the fields of tax and economic research, and make available to the committee, as needed, the services of persons knowledgeable in

the field of taxation, public finance and economics; and be it further

ORDERED, that the members of the committee be compensated for time spent in attendance at meetings of the committee and when engaged in performance of duties under instructions of the committee and authorization by its chairman at the rate of \$25 per day and actual expenses incurred in the performance of their duties under this Order; such sums to be paid out of the Legislative Account; and be it further

ORDERED, that the committee shall have the authority to employ professional and clerical assistance within the limits of funds provided;

and be it further

ORDERED, that there is allocated to the committee from the Legislative Account the sum of \$10,000 to carry out the purposes of this Order.

Orders of the Day

SENATE REPORT - Ought to Pass as Amended from the Committee on Legal Affairs on Bill, "An Act Relating to Municipal Fin-

ance." (S. P. 700) (L. D. 1881) Tabled—January 28, 1972 by Senator Minkowsky of Androscoggin.

Pending-Acceptance of Report. The PRESIDENT: The Chair recognizes the Senator from An-

droscoggin, Senator Minkowsky. Mr. MINKOWSKY of Androscoggin: Mr. President and Members of the Senate: I look upon this particular act, An Act Relating to Municipal Finance, basically in the vein that it is a proliferation of the bureaucratic process of municipal government. Of course, in the City of Lewiston I think we are faced with a dual dilemma, but in this particular instance here I don't think that this bill clearly spells out the intent, and that is for the borrowing capacity for a sewage treatment plant.

I think this bill here can be misconstrued in that it can be used as a vehicle to promote other activities of a bureaucratic system in a municipality. I made an inquiry yesterday insofar as why was this not brought under municipal home rule. That particular

question, I understand, at the present time is still being studied, and I should be receiving an answer, hopefully, within the next week or so.

In my estimation this bill is a little too broad. At the present time, Mr. President and Members of the Senate, I won't make a motion to injure this particular bill, but will let it pass for the timebeing so that at least more evaluation can be determined to see if the objections I have raised so far are valid.

The PRESIDENT: Is it now the pleasure of the Senate to accept the Ought to Pass as Amended Re-

port of the Committee?

Thereupon, the Ought to Pass as Amended Report of the Committee was Accepted and the Bill Read Once. Committee Amendment A, Filing No. S-321, was Read and Adopted and the Bill, as Amended, Tomorrow Assigned for Second Reading.

Reading.

Mr. Harding of Aroostook was granted unanimous consent to address the Senate.

Mr. HARDING: Mr. President and Members of the Senate: First of all, I would like to say that I think all of us are very fortunate in the State of Maine to have our legislature covered by the press, who I believe do a very fair job and a very complete job, and I think we are blessed with members of the press who take a great deal of pains to find out what is going on in state government and

reporting it to the people,

I have always had and I still have a very high regard for a political writer for the Gannett Press because he came from my own home town of Presque Isle that I represent, he graduated from Presque Isle High School and is someone that the school is very proud of. In fact, they inquire about him each of the years I go down to the school to speak. However, I was amazed to read in the Portland Press Herald this past Sunday that although I "made an impassioned speech against the Governor's veto", that I had previously agreed with somebody, although apparently nobody knows who, to change my vote if I had been successful in getting the Senate to accept my views. Well, I have seen some less than wise performances in this legislature, but nothing would come as close to sheer idiocy as that kind of a performance. If there is one thing that we have to have here, it is the confidence of our fellow Senators that we mean what we say and that we will stick behind what we say

Now, had anyone cared to check with the following before this article was printed, they would have known that no such agreement ever existed: For example, they might have checked with the Minority Leader of this body, Senator Violette: they might have checked with the Assistant Minority Leader, Senator Conley: they could have checked with the Democratic members of this body who heard my views in caucus; they might have checked with the members of the press who attended the Democratic caucus; they might have checked with the Governor of the State; and each of them would have told them that that was totally without foundation.

Now, I never was contacted for a comment upon this ridiculous charge that appeared in the Sunday Portland Press Herald before it was printed. Of course, the fact is that there was no such agreement made by me with anybody at all.

You know, when something as ridiculous as this is printed about you, you run a risk. You dignify this type of charge by making a formal denial. If you don't deny it, however, you run the risk of somebody saying that it must be so because you did not deny it. In order that there may be no misinterpretation, and that we may use words that everybody can understand, I wish to state categorically that the story is a complete lie.

Now, of course, the fact that my feelings were hurt is beside the point, and I felt real bad about it when I read it on that day, but I got some calls from my constituents and their reaction was much as your reaction was. I mean, anything as ridiculous as that, on its face value is not to be taken very seriously. But one

of my constituents mentioned to me, he said, "You know, if that is the worst that they can concort against you down there, you may not be in very bad shape at all."

I regret very much that this very able and distinguished columnist was victimized by publishing such a patently ridiculous statement. As I say, I have no bitterness. After all, only my honor and integrity were involved in this story. Of course, those of us who are poor in personal assets, that may be all we have, but we have to risk a great deal to serve the public. However, I am confident that this error will be corrected, and I look forward to mentioning this distinguished columnist again and how proud I am to know him when I go back to address the Presque Isle High School students next year, and I am sure that he will make proper amends once these facts have been brought to his attention. Thank you very much.

Mr. Katz of Kennebec was granted unanimous consent to address the Senate:

Mr. KATZ: Mr. President and Members of the Senate: I want to express my gratitude to the Senator from Aroostook, Senator Harding, for making these remarks this morning because I have to admit that I was really taken aback when I read of the supposed deal, and I say these words sincerely, because it was so out of character, as I know the gentleman, for him to have made such a deal and stand up and make such an effective speech on the other hand. So I am glad to hear it.

I was shaken by two disillusionments on the occasion of reading that. Frankly, I am disillusioned about the direction the vote on the big box has taken, and I was disillusioned reading about the supposed deal on Senator Harding, I am still disillusioned about the big box. And if I get disillusioned about supposed deals in government, I want you to know that

my constituents feel it even more deeply than I do. I want you to know that I am to some degree less proud of being a member of state government today because of the performance of the Governor on this big box deal. I am not speaking for my party; I am speaking for myself as a member of this body and the other body for many, many years, and to some degree I have a feeling that my office and my participation in state government has been degraded by the little shenanigans that are going on between the legal profession and the Governor this week and last.

You will remember that when the question of the income tax referendum came up during the regular session. I have been pretty much a key figure in throwing the income tax down the throat of the people, and at the time it was at a substantial personal injury to myself. I offended the sensibilities and the deep convictions of many members of my party, and yet when it came up for referendum I stood before you and said that I would have no partnership whatsoever in any shenanigans, any cute little deals, any challenging of votes, any putting out cute little questions on the same ballot with the income tax so that the will of the people could be confused. I have a tremendous respect for the right of the people to express themselves in government, and the people justified themselves when it came to the income tax vote. And I feel, as I said, just a little degraded, just a little less proud, that the people apparently are not going to get their day in court with respect to this other referendum until long after the fact next November.
