SENATE

Wednesday, February 16, 1972 Senate called to order by the President.

Senate Papers

Mr. Hichens of York presented the following Joint Resolution and moved its adoption:

Joint Resolution Memorializing Congress to Call A Convention For The Purpose of Amending The United States Constitution to Permit Voluntary Prayer in Public Schools.

We, your Memorialists, the Senate and House of Representatives of the State of Maine now assembled in the First Special Session of the One Hundredand Fifth Legislature most respectfully present and petition your Honorable Body as follows:

WHEREAS, Article V of the Constitution of the United States grants to the states the right to initiate constitutional change by applications from the legislatures of two-thirds of the several states to the Congress, calling for a constitutional convention; and

WHEREAS, the Congress of the United States is required under the Constitution to call such a convention upon receipt of applications from the legislatures of two-thirds of the several states; now, therefore, be it

RESOLVED: That we, your Memorialists, in accordance with the provisions of Article V of the United States Constitution. d 0 hereby make application to the Congress of the United States to call a convention for the purpose of proposing an amendment to the Constitution of the United States, which shall provide the offering of voluntary prayer in the public school system; and be it further

RESOLVED: If the Congress shall have proposed an amendment to the Constitution, to the same effect as the foregoing, prior to January 1, 1973, this application for a convention shall no longer be of any force or effect; and be it further RESOLVED: That c e r t i f i e d copies of this memorial be transmitted forthwith by the Secretary of State to the Secretary of the Senate, Clerk of the House of Representatives and the Members of the Ninety-second Congress of the United States elected from the State of Maine and the secretary of the state of each of the several states for transmittal by him to the legislature of his respective state. The PRESIDENT: The Chair recognizes the Senator from Somerset, Senator Johnson. Mr. JOHNSON of Somerset: Mr. President and Members of the Senate: That halo you see around my head this morning is just barely hanging on there. I would hate to let this occasion go by without saying a few words about this particular bill, which is the first bill that the Select Committee on Reorganization heard.

As you recall, this particular bill was not in the original bills that we heard in the beginning on State Government. We worked very hard and got these three departments together and I would like to give a great deal of credit for the cooperation, the work, and the perseverance of the three gentlemen in these departments, who worked so hard to resolve this, and that would be General Hayward, Mr. Levesque and Mr. Washburn. I think that this is probably one of the finest bills that we have come up with, the least controversial. and it is a bill that accomplishes a great deal. I would like to make just these few remarks for the record to compliment these people that helped us in the committee and the Legislature.

The PRESIDENT: The Chair at this time would like to put on the record, and I think it would be the appropriate time to do it, the fact that this Legislature in the State of Maine owes an awful lot to the Committee as a whole, but one gentleman in particular, and that is the Senator from Somerset. Senator Johnson, who has worked long and hard with this committee since the adjournment last June. When I say long and hard, I'm talking about two and three days a week that Senator Johnson has been in Augusta working on these government reorganization bills. And he was able to mold the Committee into a real team so that all these bills, if you have noticed have been coming out as unanimous reports without any partisanship whatsoever. I think the Senate and the House in the State of Maine owe the Senator from Somerset, Senator Johnson, a lot of credit.

Thereupon, the Bill was Passed to be Enacted and, having been signed by the President, was by the Secretary presented to the Governor for his approval.

The PRESIDENT: The Chair recognizes the Senator from Franklin, Senator Shute.

Mr. SHUTE of Franklin: Mr. President and Members of the Senate: I request this vote be taken by the yeas and nays.

The PRESIDENT: A roll call has been requested. Under the Constitution, in order for the Chair to order a roll call, it requires the affirmative vote of one-fifth of those Senators present and voting. Will all those Senators in favor of ordering a roll call please rise and remain standing until counted.

Obviously more than one-fifth having arisen, a roll call is ordered.

The Chair recognizes the Senator from Franklin, Senator Shute.

Mr. SHUTE of Franklin: Mr. President and Members of the Senate: This bill was debated quite thoroughly when it was before this body previously. It carried the day by a narrow margin and, as you will recall, we pointed out the dangers of passing such legislation in that it established a precedent and would change a provision in the law. Title 28, which permits municipalities to gather fifteen per cent of the registered voters of the previous gubernatorial election and provide them with the opportunity to submit petitions and vote in the general election. We submit that once you change this law you will open up the floodgates to additional requests from other communities.

I don't believe the special session of the Legislature is the proper place to entertain such a bill, and I don't believe that this legislature has any business making an exception of the law which is working well.

I hope you will vote against this bill and maintain the law as it now is constituted.

The PRESIDENT: The pending question before the Senate is the enactment of Bill, An Act Authorizing Town of Dresden to Vote on Certain Liquor Local Option Questions.

The Chair recognizes the Senator from Cumberland, Senator Moore.

Mr. MOORE of Cumberland: Mr. President and Members of the Senate: I had no intention of speaking on this bill; I didn't think it would be debated again. I am not interested in the Town of Dresden, but I do believe that this is an emergency here.

It was brought out in the debate earlier in the Senate that this would increase the tax base in the Town of Dresden, and that is true. But that is not the point that I wanted to bring out to you folks here today. This creates another industry in the Town of Dresden, and I understand that they need it. This would mean that possibly twenty or twenty-five young folks going to school who need some extra money to go to school could be working there during the summer months.

As far as an emergency, we give the people in the Town of Dresden the chance to vote on this bill in March, instead of a year from March, which they would have to do if they went through the regular channels. I believe that this is an emergency, and I hope you vote for it.

The PRESIDENT: Is the Senate ready for the question? The pending question is the enactment of Bill, An Act Authorizing Town of Dresden to Vote on Certain Liquor Local Option Questions. A yes vote will be in favor of enactment, a No vote will be opposed. The Secretary will call the roll.

ROLL CALL

A roll call was had. Eighteen Senators having voted in the affirmative, and ten S e n a t o r s having voted in the negative, with four Senators being absent, and eighteen being less than two-thirds of the entire elected membership of the Senate, the Bill failed of Enactment in non-concurrence.

The PRESIDENT: The Chair recognizes the Senator from Franklin, Senator Shute.

Mr. SHUTE of Franklin: Mr. President, I ask for reconsideration of this vote and ask that you vote against me.

The PRESIDENT: The Senator from Franklin, Senator Shute, moves that the Senate reconsider its action whereby this bill failed of enactment. As many Senators as are in favor of reconsideration will please say yes, those opposed No.

The Chair recognizes the Senator from Cumberland, Senator Berry.

Mr. BERRY of Cumberland: Mr.

President, I respectfully ask for a division.

The PRESIDENT: A division has been requested. As many Senators as are in favor of the motion of the Senator from Franklin, Senator Shute, that the Senate reconsider its action whereby this bill failed of enactment, please rise and remain standing until counted. Those opposed please rise and remain standing until counted.

A division was had. Fifteen Senators having voted in the affirmative, and thirteen Senators having voted in the negative, the motion to reconsider prevailed.

Thereupon, on motion by Mr. Berry of Cumberland, tabled and Tomorrow Assigned, pending Enactment.
