The SPEAKER: The Chair recognizes the gentleman from Orono, Mr. Curtis.

Mr. CURTIS: Mr. Speaker and

Ladies and Gentlemen of the House: State Government is the Committee which is responsible for overseeing the organization of state government, and it was my con-cern yesterday that possibly this bill might be creating an important new division within a body of state government. After further analysis of the bill it seem's that other policy matters would require that this bill more logically be sent to the Committee on Agriculture. So would like to withdraw my motion to send the bill to State Government.

Thereupon, Mr. Curtis of Orono withdrew his motion that this be referred to the Committee on State

Government.

The Bill was referred to the Committee on Agriculture in nonconcurrence and sent up concurrence.

At this point, the Speaker appointed the following House member to the Joint Standing Committee

Veterans and Retirement Gahagan of Caribou

In accordance with Title 20, Maine Revised Statutes, Section 2903, the Speaker appointed Mr. Bither of Houlton to the Maine Education Council.

Mr. Jalbert of Lewiston was granted unanimous consent address the House:

Mr. JALBERT: Mr. Speaker and Members of the House: My remarks this morning will be merely of a suggestive nature. It is not my intention in the least to usurp anybody's powers, anybody's prerogative. I am just going to touch on a subject that was close to me at one time that I was involved in and make a suggestion to you for what it is worth.

I speak on this beleaguered topic called conflict of interest. It was about a year ago that at my own request I asked the conflict of interest to rule as to whether or not I was in conflict of interest in serving on the subcommittee of

the Legislative Research Committee. I was told by their chairman that I was not. I offered to resign from the committee. He refused to accept my resignation. I pursued the topic further, and I asked for a hearing by the Legislative Ethics Committee which was made up of the leadership of both parties, exclusive of the assistant leaders. Committee of Legislative Ethics is made up of the President of the Senate, the Speaker of the House and the leaders of both the Democrat and the Republican party in the House and Senate.

The matter, as you probably know, carried quite a lot of space in the press. It got to a point where my employer, for whom I have a tremendous amount of personal respect, suggested to me that I might want to withdraw myself from the subcommittee. I had by that time built myself in that I was not in conflict and stated that as much as I loved my work that before I did I would resign my employment which would really chagrined me, not because of the monetary results from my efforts of work but because of my personal feeling for my employer. The result was that I was declared by a vote of 6-0 not in conflict of interest, notwithstanding the fact that possibly one or two had reservations.

I might state, because I don't think I ever get up on my feet without entertaining some philosophy of levity, I might state that it was my opinion that it could have been possible that some members of the Legislative Ethics Committee themselves could have found themselves under pressure somewhere along the line in conflict of interest. And that is the reason why I am on my feet, added to my own personal reasons.

I would suggest to the membership that they might think of the idea of looking the situation, looking the legislation that is before us over. If they find that they might there might be a possibility in their mind that they might be in conflict of interest, instead of having a hearing, instead of the newspapers trailer the thing over back and forth, instead of having the headlines say, "Jalbert not in

conflict" or "Jalbert in conflict," bearing in mind that no one wins an argument anyway, it leaves just that little tinge that I personally dislike. I think it might be possible that this might avert a great deal of conflict within ourselves; it might relieve the Legislative Ethics Committee, it might possibly avoid a great deal of embarrassment should the problem be one that might be of a serious nature.

My remarks are only made, Mr. Speaker, on a suggestive basis, probably based on the fact of the few semesters I have been around. I think it might be an idea if you could only go to one of the members of the leadership and say there might be a question on this thing here, what do you think? The answer might be resolved very easily and very quickly without any embarrassment whatever. I thank you for your attention.

Mr. Emery of Rockland presented the following Order out of order and moved its passage:

ORDERED, that a suitable copy of the Order be transmitted forthwith to the Gahagans to convey these sentiments.

The Order received passage. (Applause — Members rising)

Mr. Birt of East Millinocket presented the following Joint Resolution and moved its adoption: WHEREAS, the flags of our republic were lowered in deep

sorrow on December 26, 1972, with the passing of the late Harry S. Truman, 33rd President of the United States of America; and

WHEREAS, he is remembered as a "common man" who employed a "give 'em hell" technique to advance his conception of the President as champion of "the

people;" and

WHEREAS, his achievements are too numerous to account but few will forget the Truman Doctrine, the Fair Deal, the Berlin Airlift, the close of World War II, the Marshall Plan, the North Atlantic Treaty Organization, the establishment of the United Nations and the blessed defense of Western Civilization; now, therefore, be it

RESOLVED, in concurrence, that when We, the Members of the

Senate and House of Representatives of the 106th Legislature of the State of Maine adjourn this day, we do so in honor and out of respect to his memory; and be it further

RESOLVED: that a copy of this resolution, suitably engrossed and attested on our behalf by our presiding officers, be transmitted to the family of the deceased. (H. P. 192)

The Joint Resolution was read and adopted and sent up for concurrence.

The members stood for a moment of silence out of respect to the memory of the late Harry S. Truman.

Thereupon, the House adjourned until ten o'clock tomorrow morning.
