The SPEAKER: The Chair recognizes the gentleman from Ellsworth, Mr. McNally.

Mr. McNALLY : Mr. Speaker, Members of the House: Just so

that I won't be accused by the media of being for corporations only, as I read so many times in the paper about other gentlemen in this country, I would like to tell you how I have become interested in this particular bill.

1942 we built a rural electrification line through northern Hancock County and at that time a lot of the people that worked on the line for my company had small farms, had cattle, did some raising of crops; but since that time, through death and other things, the farms deteriorated, the cattle were sold, no longer did they find it profitable to sell milk and bushes began growing in the fields and they started burning them and when they burned them, they discovered blueberries grew like they did in the big tracts that had been purposely laid out for blueberries.

Well, everything went well until 1963. There was a sales tax imposed for the fuel used to burn blueberries; and at that time, a letter was written December 9, 1963, Knox Brothers, Incorporated, which says, "I apologize for the error and I hope that this corrected notice will reach you in time to prevent too much confusion conthe taxability of cerning oil used in burning blueberry land. In that letter I said that fuel oil will be subject to sales tax. I find that I was incorrect and for this use, fuel oil is non-taxable.

Then one day after about a year ago, I happened to be sitting in the kitchen of a widow who owns quite an extensive bunch of blueberry land and we were discussing different things and she made the remark, "Why couldn't we have some relief?" She said, "You know since 1971 we have had to pay a sales tax on the fuel we use to burn blueberries." Now she says, "It is a fact that they burn the potato tops up in Aroostook. They put fuel oil with the dinitro and defoliate them. So I began to look into it and obtain information anywhere that I could and I discovered first that Chapter 36, paragraph 1760, item 7 under the exemptions says, "Products used in agricultural production — notice agricultural production — "N.B., sales of feed, hormones, fertilizer, pesticides, insecticides, weed killers, defoliants—they spell it d-e-f-a-l but I think they mean defoliants—litter and medicines used in agricultural productions and sale of bait to commercial fishermen," these are all exempted.

So then I got hold of the Cooperative Extension Service at the University of Maine and they furnished with the Blueberry me News dated November 2nd, 1972 and it "Why to burn? Burning low savs. blueberry plants is one bush method of pruning them, an operation that is necessary to encourage new stem growth on which the following year's crop is produced. Pruning by burning eliminates most of the stubs and other undesirable growth which interferes with harvesting the berries. Other methods of pruning have been tried but are not practical at present." And they then go on to say, "A proper burn is important to preserving the organic matter layer on the soil's surface."

Well, then they also sent me "Growing Potatoes in Maine" which I will just read to you four things for top killing. "To insure dead tops at harvest time and prevent the spread of late blight from tops to tubers during the harvest operation; to toughen the skins of tubers so it will be more resistant to skinning and bruising during harvest, to control size and to facilitiate harvesting."

So I couldn't see in my mind if the law said that defoliants was exempted, I didn't see any reason the people, especially the small people with their little, small farms that was eking out money wherever thev could to keep themselves off welfare shouldn't receive the exemption of any fuels that they use for burning their lands. Then it was remarked, I guess I asked the question of somebody, "What happens if a big con-cern, if a canner comes in or a freezing plant and burns your fields?" and they said, "Oh, well, when we deliver our blueberries to their places, we find we have got a bill against us for doing the burning and also on it is included the sales tax for the fuels.'

So that is simply what the bill is for. The price of it, according to a letter I have here from the Tax Department is \$10,000.00 for each year, 1973-74 and \$10,000.00 1974-75. That is the cost of it. I don't know of any better way that we could help a good many people, and I don't mean the big people, I mean the little people, than we could passing this bill and I move when the vote is taken that it be by division.

The SPEAKER: The Chair recognizes the gentleman from Bridgewater, Mr. Finemore.

Mr. FINEMORE: Mr. Speaker, Members of the House: As the chairman of the Taxation Committee is not present, I would like to mention that this bill was taken up in the Taxation Committee. We had several proponents and no opponents to the bill and everything I find that Mr. McNally has said is true. Up in Aroostook — of course, we are not God's chosen children, a lot of people think we are but we aren't and we are allowed tax free for all propane gas and all fuel oil used in the killing of tops and this is nothing any more than killing of the tops. And the fact that we are unanimous, we passed this bill, I hope you will go along with Mr. McNally when the vote is taken.

The SPEAKER: The Chair recognizes the gentleman from Augusta, Mr. Bustin,

Mr. BUSTIN: Mr. Speaker, Members of the House: I was sitting here minding my own business in the beginning of the week when this particular L.D. came sailing through the Consent Calendar and asked to have it set aside to look into it, because I wondered whether this was really a kind of exemption for fuel oil or whether it might be tax relief for the big blueberry operator, so I thought I would take a look at it; and the more I look at it, the more I am convinced that that is exactly what it is. And that is why I move to have it indefinitely postponed.

Now, Mr. Finemore is right, they do put the fuel oil on Aroostook County potatoes, but in the case of the blueberries -- and this is a minor point and I am not leaning

on this — the defoliant is fire, it is not fuel oil. And that was the reason that they are not exempt at this time.

This bill is going to cost the State \$10,000 in revenue and I think most of us agree it is a little early in the session to start giving away any money.

The gentleman from Ellsworth, Mr. McNally, has made a plea that what we are really going to do if we pass this measure is help out all the small growers down along Hancock and Washington County.

Consider these statistics: average of the amount of fuel that they put on an acre of blueberry fields when they burn it is fifty gallons, fifty gallons per acre; and the price of that oil is less than twenty cents a gallon. But for the purpose of the statistics that I am going to give you because it multiplies easily, let's use twenty cents per gallon. So a fifty-acre farm - and I understand that the vast majority of those who are not in the blueberry business but just grow the berries are under a hundred acres — so a fifty-acre farm at fifty gallons per acre means they would be using two thousand five hundred gallons at twenty cents a gallon or five hundred dollars worth of fuel oil for a grand total of sales tax of twenty-five dollars.

If, on the other hand, you have a five hundred acre operation, your sales tax will figure on twenty-five thousand gallons of fuel oil at two hundred fifty dollars. And if you happen to be in the category where you are really pushing out blueberries and packing them and have a major operation — and there are about thirteen or fourteen which do control most of this business in the area that the gentleman spoke of - if you had five thousand acres, you would be saving yourself through this L.D. two thousand five hundred dollars in sales tax.

I am sure that this probably would be going too far to suggest that this bill is Maine's answer to the oil depletion allowance, but I must say that this strikes me as a pretty slick piece of legislation. I hope that you will indefinitely postpone this measure.

The SPEAKER: The Chair recognizes the gentleman from Rockland, Mr. Emery.

Mr. EMERY: Mr. Speaker and Members of the House: I also come from an area in which blueberries are grown and there are a couple of other facts that I think we ought to mention. First of all, I am in complete agreement with the gentleman from Ellsworth, Mr. McNally.

Many of the very small growers, who also depend on some method of burning their fields, rely on spreading hay and burning the hay. Well in some ways this isn't very efficient. Now in my area we have a very rocky terrain and I think that most blueberry growers would tell you that using the burning method that involves oil is more efficient.

Another thing that I think it would be well to consider at this time is that the money which is saved on sales tax on oil does not necessarily go into the pockets of some big blueberry tycoon from somewhere but would pay the salaries of many high school students and others who depend on harvesting blueberries by hand for summer employment. I did that a few times when I was in high school and even in grade school and this employs a lot of kids in my area raking blueberries. And I know for a fact that because of increased cost of production, many of the blueberry manufacturers have had to consider alternate methods of harvesting their crop, which means cutting down on the number of kids employed during the summer. I think this is something we have to be concerned with.

I was quite surprised to notice that the gentleman from Augusta had set this item aside because I think that it is something that we ought to pass. I can see a lot of merit in it. But I am glad to know that the M. T. A. hasn't gone into the blueberry business.

The SPEAKER: The Chair recognizes the gentleman from Enfield, Mr. Dudley.

Mr. DUDLEY: Mr. Speaker and Members of the House: I come from an area where we don't raise blueberries, and I do feel that this bill has merit and should pass. I think it is a matter of justice. Now in my area we can use fuel for spraying, spraying bushes if you may, in your pasture to make them die, kill the foliage so to speak, spray potatoes and other things.

I think just because I come from an area where we don't raise blueberries doesn't make me feel that I don't want justice. I think the whole of us here in this House stand for a certain amount of justice, and if we do we should support this bill because this is important to the people in this area as much as burning fuel or spraying or making the spray material in the area from which I come.

I can't see as it would make a great deal of difference to the Members of this House whether we burn this fuel or whether we mix it with some other deterrent and spray it. The fact is that these people are certainly entitled to this mild, little amount of money and before you leave here, ladies and gentlemen, you are going to be spending money by the millions and it is going to be for causes nowhere near as worthy as this. So I suggest that this is like pennies so let's be gentlemen about it and pass the bill and be honest with these people in this particular area. I hope you will go along and pass this minor piece of legislation without further ado.

The SPEAKER: The Chair recognizes the gentleman from Oakland, Mr. Brawn

Mr. BRAWN: Mr. Speaker and Members of the House: I am not like Mr. Bustin. I have raised blueberries. I had a 175-acre farm in Montville. I have 46.8 acres up there in the north so I am familiar. This is one more thing I have done. When you take \$45 out of a man's pocket that is raising blueberries, this may not sound like much to you but it is the blueberry man that gets hit. And I do not care if these big tycoons he tells about comes in and does it. They do not suffer this price. They put it back on to that little grower, and I hope you will go along and pass this bill.

The SPEAKER: The Chair recognizes the gentleman from Houlton, Mr. Bither.

Mr. BITHER: Mr. Speaker and members of the House: I do not always agree with the gentleman Oakland. Mr. Brawn. especially on pheasants, but I will agree with him on blueberries. I would like to just add one little thing that has not been mentioned here. And I would like to sav even though from Aroostook that I know something about blueberries because I grow blueberries. I actually grow blueberries. I have three acres of blueberry land down in Jonesport and I have supplied one of the members of the committee. I know this did not have anything to do with his decision, but I supplied him with some blueberries.

Now I would like to add this. Mr. Speaker, this one point, that these big growers, many many of these big growers may own much of their land and I know some of them do. I could perhaps name two but most of that land that those growers are growing blueberries on is just a management proposition. The land is owned by someone else and they are managing them completely. They pick the blueberries, they burn the blueberries and I have been around that area down there enough to know that this growing of blueberries is not a very profitable business. There is no great profit in it. You want to remember that once you burn this land it does not produce that year at all — the next year I mean. That year when that is burned in the spring it does not produce at all. It will not produce until the next year so every other year, or every third year your land is not in production at all. They are not making a vast amount of money. I go along wholeheartedly with this bill.

The SPEAKER: The pending question is on the motion of the gentleman from Augusta, Mr. Bustin, that this Bill and all accompanying papers be indefinitely postponed. All in favor will vote yes; those opposed will vote no.

A vote of the House was taken.

16 having voted in the affirmative and 102 having voted in the negative, the motion did not prevail.

Thereupon, the "Ought to pass" Report was accepted. The Bill was read once and assigned for second reading the next legislative day.
