Mr. JALBERT: Mr. Speaker and Ladies and Gentlemen of the House: There is an old expression that newspaper editorial writers have used for years. It goes like this . . . "to point with pride" at something or "view with alarm" a disturbing situation.

On the floor of this House, this morning, I want to borrow these two expressions. I want to borrow each to prove a point as well as to try to convince you, my colleagues, of the wrong approach that some are making these days concerning the news media now assigned to cover this Legislature and the daily happenings within our State House.

First. . I want to "point with pride" to the excellent relationships that sessions of the Legislature have had over the years with the so-called Fourth Estate.

The working news media, including television and radio reporters, always has shown responsibility, a real respect for the traditions and protocol which we, in Maine, value so highly within our legislative process.

The news media in our state does not go into the type of sensationalism so often found i n other states. The reporters, whether they are employed by the wire services or by individual papers or stations, pride themselves in sticking to the facts. They do not and have not been our antagonists. They have been a most creditable source of news for the people of our state.

So as the years have gone by, we, the Legislature, have provided the news media with space in which to work to report our activities on a daily basis and that of the state government both during our sessions and after.

Traditionally, the Legislature — in fact, the Clerk of the House — has provided not only space for the press but typewriters, desks and chairs. They have brought in their own working utensils such as paper, pencils, teletypes, photo machines and so forth.

So I point with pride to our relationships with the news media and the fact that we always have supported the concept of freedom of the press and freedom of

expression. But now I have to view with alarm a new direction that some would have us take. In effect, there is going to be an attempt to force the news media into paying for space they occupy in this building. an attempt to take away existing typewriters that are the property of the Legislature, an attempt to say to the news media, "You cannot be hooked into the state's telephone network. From now on, you'll have to have your own, outside telephones hooked up and then dial outside to get inside the State House."

Now I view with alarm these new, and I think thoroughly unjustified attempts to further hamstring the press.

What goes on in the nation's capitol in Washington? The news media is provided space and has

been for years and years as we in Maine have done. Around the Nation, state house after state house has space for the newsmen and women, most of the m more appropriately equipped, more reasonably decorated.

In Connecticut, and I recognize the wealth of Connecticut, the Legislature has provided a paneled lounge next to the working newsroom so that the members may relax once in a while from their many pressures and, also, so that the legislators in that state may confer with individual newsmen outside the noise and hustle and bustle of the newsroom.

It was only a few years ago that we, the Legislature, found the space on the fourth floor for the news reporters on a permanent basis. It used to be that the newsmen were on the third floor, in the first office outside the other body, on the further end of this floor. When the sessions came in, the press had to move upstairs for the four and five-months sessions then

I happen to be one legislator who believes that we do not provide enough space for those in question. We should provide a studio for the television cameras for interviews away from the noise of our outside corridors. We should take pride, as much pride as we appear to have taken this year, in the furnishings of some of the new legislative aides, in the facilities that custom and tradition and a belief in the value of freedom of the press always have been held by our predecessors.

I don't have to remind this House of the national attempts these days to further curtail the workings of our free press. There is a bill before us to make sure that we in Maine do not infringe upon the freedom of the press. Let's not give even the slightest impression that we want to join those who want to slash out at the newspapers, television and radio stations. Let's point with pride to our belief in the freedom of the press.

This concludes my remarks, Mr. Speaker, which are prepared. I might state this, and I say this in all sincerity, this certainly is

by no means an attempt to make brownie points, because of the fact that over my last more than two decades here I have both been clobbered and praised by the press. Two things I have feared, and that is to be laughed at and ignored by the press.

As far as the press is concerned, I lived for thirty years and I live now with the very same philosophy. If an editorial pleases me, I buy a hundred copies. If it is against me, it is the opinion of one man.

Mr. Hoffses of Camden was granted unanimous consent to address the House.

Mr. HOFFSES: Mr. Speaker, Ladies and Gentlemen of the House: I would call your attention to the Council of State Government material which has been deposited on your desk this morning. It consists of the yellow folder which has the names and titles, the officers and the executive committee of the Council of State Government and also the associated organizations.

Also, you have copies of several subject matters which have been prepared by the Council of State Government, ranging from No-fault Insurance to Equal Rights, Constitutional Revision, Reapportionment and the green one, Gambling, A Source of State Revenue.

Also, you have a card on your desk which, if you care to fill out, you may be mailed a copy of the quarterly magazine of the state government.

I would like to point out at the eastern regional meeting last year in Albany, New York, one of the subject matters which discussed was the matter gambling as a source of revenue for the several states. It was one of the most interesting subject matters which was discussed, and the delegates there were very much interested in questioning the several panelists. It unfortunate that we could not have the amount of time which a lot of them would like to have to devote to it.

I would also call your attention to Mr. Sokolow who was at the pre-legislative conference and urged each and every one of you to take advantage of the Council of State Government publications which are available to the states. I would emphasize to each and every one of you that this information is not intended to in any way influence any legislator or any state legislature. It is merely factual information which has been provided by the Council of State Government.

The Council of State Government and its associated organizations purpose is to strengthen the roles of the individual states and to recapture, if you will, some of the duties and responsibilities which the several states have lost and the federal government has taken over. The purpose is to take back some of those responsibilities that we as state legislatures can be more effective in the federal-state system; and I would urge you, if you so desire, to fill out the card and send it on to the headquarters in Lexington, Kentucky, to receive the quarterly reports.
