The SPEAKER: The Chair recognizes the gentleman from Rockland, Mr. Emery.

Mr. EMERY: Mr. Speaker, I move acceptance of the Majority "Ought not to pass" Report.

The SPEAKER: The gentleman from Rockland, Mr. Emery, moves the acceptance of the Majority "Ought not to pass" Report.

The Chair recognizes the gentleman from Fryeburg, Mr. Trumbull.

Mr. TRUMBULL: Mr. Speaker and Ladies and Gentlemen of the House: I was amazed at the way this bill came out of committee. This is just a simple act changing the name of the Region 12Coordinating Committee Incorporated to the Western Maine Counseling Service Advisory Board Inc. This apparently came out for reason the simple that the argument was the use of the word Maine on a local level only. Now for the very name of the committee, it is intended to be used on a local basis only. For five years this has been a publicly accepted name. It is apparent that originally when these groups were set up, they were set up to allow on the basis from health and welfare so that this area was designated as region 12.

But for the public and all those concerned, it has always been known as The Western Maine Counseling Service. Now they came to me and asked me to put this act in so that they could then have both their advisory board and their legal name agree with the name they had publicly been accepted by. Now, if we allow this majority "ought not to pass" report to be accepted, it will be the same thing as, supposing that at birth I had been known as Baby Trumbull. I had gone on for 21 years known only as Baby Trumbull, legally. But everybody else had known me as Charles Allen Trumbull. Now, if I went to the court and tried to get my name changed so that my publicly accepted name and my legal name would be the same thing and that I was turned down on this basis, why then I would be stuck with, for the rest of my life, according to legality, with the name of Baby Trumbull.

Now this is just the same thing as we are doing right here. And I will hope that you will vote against the majority "ought not to pass" and instead vote that the minority report be accepted and I ask for division.

The SPEAKER: The Chair recognizes the gentleman from Waterville, Mr. Carey.

Mr. CAREY: Mr. Speaker and Ladies and Gentlemen of the House: In relation to Mr. Trumbull changing his name, if he wants to name himself Charles or Henry or Martin or anything he wants, it is perfectly all right with us. When he gets involved with changing his name to Maine Trumbul, then the Legal Affairs Committee has some say on it.

This particular bill r e f e r s generally to the Bridgton area and the Bridgton area only. And we are quite concerned that there are too many people that are getting involved using the name Maine in their titles. We have 30 or 40 bills that are coming before us, which if they have not been there already, referring to the use of the word Maine and we are now trying to offer the people of Maine some protection.

Mr. Trumbull of Fryeburg requested a vote.

The SPEAKER: The pending question is the motion of the gentleman from Rockland, Mr. Emery, that the House accept the Majority "Ought not to pass" Report. All in favor will vote yes; all opposed will vote no.

A vote of the House was taken.

The SPEAKER: The Chair recognizes the gentleman from Pittsfield, Mr. Susi.

Mr. SUSI: Mr. Speaker and Ladies and Gentlemen of the House: I move the acceptance of the Majority "Ought not to pass" Report and would speak to my motion. The SPEAKER: The gentleman from Pittsfield, Mr. Susi, moves the acceptance of the Majority "Ought not to pass" Report.

The Chair recognizes that gentleman.

Mr. SUSI: Mr. Speaker and Ladies and Gentlemen of the House: This bill is sponsored by the gentleman from China, Mr. Farrington; and it provides generally that in a case where a person has an automobile destroyed in an accident and has to replace that automobile, he then would have to pay the sales tax on the entire purchase price losing the benefit of the credit of the automobile destroyed. Supposing the automobile is worth \$2,000 at the time of the accident, he would lose \$100 in taxes. I think that there was general agreement amongst the members of the Taxation Committee that he should receive this credit or should somehow be compensated on it. Now, from the evidence that we have heard, it is the obligation of the insurance company, if the insured can enforce it on the owner of the automobile to compensate, not just for the loss of the automobile, but for the tax, which is in a sense an inherent part of the value of this vehicle.

I think that the difference in opinion between those who support the legislation and those who oppose it was whether or not we in this legislature want to, in effect, subsidize the insurance companies who fail to compensate the owner of the automobile for the amount of the sales tax. Now, it apparently is so that should the owner force the issue, the insurance companies will ordinarily pay this. But where the owner is perhaps distressed about his loss and all in a flutter about getting another automobile and everything and does not force it, the insurance companies are perfectly happy to avoid payment of it.

What I am building up to is this, that I believe that the members of the committee would all support an amendment which provided that the insurance companies had to make up this loss. If at this time the sponsor or any other interested person would like to table this until

such time as we could get an amendment providing for that, it certainly would reach my agreement.

The SPEAKER: The Chair recognizes the gentleman from China, Mr. Farrington.

Mr. FARRINGTON: Mr. Speaker and Ladies and Gentlemen of the House: I certainly would like to thank my good friend, Mr. Susi, for explaining just about what I would explain regarding this document. I think the purpose of my introducing such a bill is the result of some experience that I have had dealing with automobiles. And there certainly is no reason, unless the person who has the damage brings it to the attention of the insurance company, that this claim is paid, this sales tax claim is paid.

I think that we should spell out very clearly in some manner whose responsibility this is. As we have said often times in the past, we need to protect that minority group who does not know what it is all about. The insurance companies are not compelled to pay this 5 per cent. Often times they do not. I think even though perhaps the insurance companies are caused to pay it, that charge indirectly will come back to the insured, because I am sure the insurance companies will add it on to your insurance policies some way.

I certainly would like to see this spelled out in terms that would be well understood and well applied without the confusion that now exists. I, too, would hope that somebody might table this so that we can get it in proper context.

The SPEAKER: The Chair recognizes the gentleman from Auburn, Mr. Drigotas.

Mr. DRIGOTAS: Mr. Speaker and Ladies and Gentlemen of the House: I feel qualified to speak somewhat on this subject. As perhaps some of you know, I was involved in an accident a while ago and confined to the hospital for a period of five months. While this thing went along, there was need of an automobile in the family, and the insurance company was kind enough to settle the claim. But it was only when I came back to the legislature here that I found out

that possibly the amount of — oh, pretty close to \$100 was left out of the negotiated settlement.

Now, under conditions, particularly such as I was in. it is very obvious that an insurance company can legally and rightfully take advantage of a situation. I certainly was in no situation where I could say yes or no to any settlement involved; and as someone else also brought out, it was also an area where some people feel that this is the law, perhaps if so, this is the settlement, thereby losing any amount perhaps ranging from \$25 to \$150, which rightfully belongs to them.

So I would hope that somebody would table this motion.

Mr. CAREY: Mr. Speaker and Ladies and Gentlemen of the House: In the Sunday Telegram of yesterday, Jim Brunelle wrote about the great hoax that was perpetrated upon this legislature by a member of the other body who happens to represent Augusta.

The gentleman was quoted as saying that anything can be brought up and passed before the legislature regardless of value. I want the record to show that we as members of the legislature pretty much pass things as a courtesy to the sponsors of some of these measures, and we depend very much and we place an extremely high value on the integrity of the sponsors of some of these measures.

Now this gentleman has done a tremendous disservice I think to the State of Maine, and he has ridiculed the members of this body as well as the other body. I personally feel now that that gentleman's integrity is somewhat questionable; and I would suggest to him if he wants to play that type of game, that he find himself a sandbox someplace. That may be a little less expensive to the state.

Mr. Martin of Eagle Lake was granted unanimous consent to address the House.

Mr. MARTIN: Mr. Speaker and Ladies and Gentlemen of the House: I agree with the remarks made by the gentleman from Waterville in reference to this particular order. As soon as we can find out how to kill it, we will do it; and we are going to send it back to the other body where it probably should have stayed. I cannot believe that we have nothing better to do than pass orders like that and that sponsors can think of nothing else to do than to introduce orders like that. I hope that as far as I am concerned when an individual member of the legislature introduces an order, that he does it because he has a real desire to serve the people he is elected to represent and not because he wants to play jokes in the Maine Legislature. And so in due course, we will have the order in front of us to kill that order; and this basically is what the Speaker, the Majority Floor Leader and myself were discussing a few minutes ago.

The SPEAKER: The C h a ir concurs with the remarks of the two gentlemen, and in the past the House has tried to be careful as to orders. Since I have been in the House there was an order once that would have allowed lobbyists to drill holes in the glass at the back of the House so as to tap legislators. There have been other frivolous orders which have never passed before to my knowledge. I regret that this one did pass.
