#### Orders Later Today Assigned

Mr. Evans of Freedom presented the following Joint Order and moved its passage:

ORDERED, the Senate concurring, that the Joint Standing Committee on Agriculture be authorized to attend the public hearing of the Maine Milk Commission on Saturday, January 12, 1974, at the Civic Center in Augusta and the members of said committee shall be reimbursed from the Legislative Account for their expenses. (H. P. 1843)

The Order was read.

The SPEAKER: The Chair recognizes the gentleman from Bangor, Mr. Kelleher.

Mr. KELLEHER: Mr. Speaker, Ladies and Gentlemen of the House: I don't think this order is necessary. In my opinion, that is a public hearing; the citizens of the State of Maine aren't going to be going down there and getting paid to participate in it. I move the indefinite postponement of this order.

The SPEAKER: The gentleman from Bangor, Mr. Kelleher, moves the indefinite postponement of this Order.

The Chair recognizes the gentleman from Portland, Mr. La Pointe.

Mr. LaPOINTE: Mr. Speaker and Members of the House: I plan to be coming up from Portland as a member of the legislature, and I don't plan to be reimbursed for this. I support the motion of Mr. Kelleher.

Thereupon, Mr. Evans of Freedom requested a vote.

The SPEAKER: The Chair recognizes the gentleman from Standish, Mr. Simpson.

Mr. SIMPSON: Mr. Speaker, Ladies and Gentlemen of the House: I oppose the motion to indefinitely postpone. I do realize it is a public hearing that is taking place and all of us have the opportunity to attend, and those who will attend will probably do so at their own expense.

However, I think there is one difference. This is a particular instance

where a Joint Committee of the Legislature was asked if they would attend, and as part of the leadership and as far as I am concerned, and those of us that they have asked, we have advised them that we thought it was in their best interest to attend, and therefore where the request had been extended to a committee, we feel that that committee should be reimbursed.

The SPEAKER: The Chair recognizes the gentleman from Bangor, Mr. Kelleher.

Mr. KELLEHER: Mr. Speaker, Ladies and Gentlemen of the House: I believe that the hearing that was going to be held on the 12th, I got a personal invitation to appear. It was sent to me in the mail, and I think it is our legislative duty and our prerogative, if we want to attend, we should. I do not think that we should be supporting an order such as this in this House.

The SPEAKER: The Chair recognizes the gentleman from Portland, Mr. La-Pointe.

Mr. LaPOINTE: Mr. Speaker and Members of the House: I would like to see this possibly tabled for one legislative day so an amendment could be prepared for the order, when it is appropriate, so that any member of the legislature, both of this body and the other body who would like to attend this public hearing could be reimbursed for their expenses.

The SPEAKER: The Chair would inform the gentleman that he may not debate a tabling motion.

The pending question is on the motion of the gentleman from Bangor, Mr. Kelleher, that this Joint Order be indefinitely postponed. All in favor of that motion will vote yes; those opposed will yote no.

A vote of the House was taken.

Thereupon, Mr. Kelleher of Bangor requested a roll call vote.

The SPEAKER: A roll call has been requested. For the Chair to order a roll call, it must have the expressed desire of one fifth of the members present and voting. All those desiring a roll call vote will vote yes; those opposed will vote no.

A vote of the House was taken, and more than one fifth of the members present having expressed a desire for a roll call, a roll call was ordered.

The SPEAKER: The Chair recognizes the gentleman from Lewiston, Mr. Jalbert.

Mr. JALBERT: Mr. Speaker, Ladies and Gentlemen of the House: I truly hate to take up the time of the legislature on this thing. I have a tremendous amount of respect for the committee in question. I have a very strong, personal feeling for the House Chairman of the committee. I have known him for a great many years, and I have gone along with him without even reading things, and I have asked him, "Mr. Evans, is this all right?" If he says yes, that is the end of it with me.

I think we are opening up a real can of worms here. I think we are opening up a real bad precedent. Gee, if you are going to pay some, pay the others. I got invited. I can't come, and I am going to judge myself by what I hear when the debate comes on the floor anyway.

But I think probably the idea of having this thing tabled might not be a bad idea so you can discuss it, at least among yourselves, and have further discussion with the leadership of both parties. I don't want to have anybody be angry because I am for or against, but I am truly saying that this is setting up a real real bad precedent.

Thereupon, on motion of Mr. Martin of Eagle Lake, tabled pending the motion of Mr. Kelleher of Bangor to indefinitely postpone and later today assigned.

On motion of Mr. Martin of Eagle Lake, tabled pending the motion of Mr. Kelleher of Bangor to indefinitely postpone and tomorrow assigned.

Mr. Dyar of Strong was granted unanimous consent to address the House.

Mr. DYAR: Mr. Speaker, Ladies and Gentlemen of the House: It has been brought to my attention that certain oil dealers here in the State of Maine are being harassed by a State agency and being told that they must deliver oil to persons who in the past have not paid their oil bills. They have been instructed that possibly, if a person will not pay previous oil bills, that they should go to the local town fathers and have the town fathers take over the financial responsibility for these parties.

I am quite concerned that a State agency will try to tell a man in a free enterprise system that he must deliver his product to a person who refuses to pay for that product and has refused to pay in the past. Hopefully, some member of this body is in a position to do so will clarify this situation.

Mr. Martin of Eagle Lake was granted unanimous consent to address the House.

Mr. MARTIN: Mr. Speaker, Ladies and Gentlemen of the House: I would not like to rebut the comments made by the gentleman from Strong, Mr. Dyar, but perhaps give you a few things that have transpired, since we started the so-called "energy crisis," off the top of my head, and to give you a couple of instances that occurred yesterday in reference to people not paying their bills to oil dealers.

It is my understanding that the Department of Civil Defense has handled some 30,000 calls since we started the so-called "energy crisis." That's an awful lot of calls; that's an awful lot of time. Some of those people are working from six o'clock in the morning until midnight answering calls coming in and trying to respond to some of the demands that are made by Maine citizens. It is very true, I suppose, that some citizens are obviously making calls that they ought not to be making, and perhaps vice versa. But on the whole. I think that what has taken place so far shows that State employees are willing to work overtime in order to do a job which is worthwhile doing and to help the citizens. Actually, I think we ought to stand and congratulate that department and its employees.

Yesterday, I got involved with a particular case, or two cases, from Aroostook County where an oil dealer had told or informed the people that unless they paid their back bills they would not be entitled to any oil, even though they attempted to keep the oil payment current. Rather than to call Civil Defense myself, I decided to call the oil distributor. It may well be that I harassed the oil distributor, I am not sure. If I did, I am not at all unhappy that I did.

Basically, the one bill, for example, in one instance, was an amount that was owed in the amount of sixty dollars. The person had offered to pay and keep his bill current and had done so for a year and a half since that bill. He also had been paying a couple of dollars a month on that sixty dollars. It involved people over 65 on old age and social security. And as you all know it's a heck of a job to try to keep current when you're receiving as little as some of these people are.

The second instance involved a family with four children in the community of Washburn. And, basically, they had a bill that I guess was a couple of years old, and the oil distributor now informed them that unless they paid that up they would not be entitled to oil. Certainly, if the bill was two years old, just because of the energy crisis, it ought not to be used as an attempt to harass people by the oil distributor, which I am sure this is what was being done in part.

Now, I know that it has got to work both ways. And I know that the gentleman from Strong was not referring to in saying that this is occurring statewide on the part of Civil Defense employees. But let's not forget that some of these people that are being served by the oil companies and the oil distributors are also doing their share of harassing.
