Monday, January 14, 1974 The House met according to adjournment and was called to order by the Speaker.

Prayer by the Rev. Mr. Lelton Orewiler of Gardiner.

The members stood at attention during the playing of the National Anthem.

The journal of the previous session was read and approved.

Papers from the Senate Reports of Committees Ought Not to Pass

Report of the Committee on Appropriations and Financial Affairs on Bill "An Act Relating to Recruiting and Retention Incentives for the National Guard" (S. P. 783) (L. D. 2263) Emergency, reporting "Ought not to pass"

In accordance with Joint Rule 17-A, was placed in the legislative files.

Ought to Pass

Report of the Committee on Appropriations and Financial Affairs on Bill "An Act Appropriating Funds to Carry out Duties of the Director of Legislative Research" (S. P. 728) (L. D. 2140) Emergency, reporting "Ought to pass"

Report of same Committee reporting same on Resolve Providing Funds for Cerebral Palsy Centers (S. P. 706) (L. D. 2118)

Came from the Senate with the Reports read and accepted and the Bill and Resolve passed to be engrossed.

In the House, the Reports were read and accepted in concurrence, the Bill and Resolve read once and assigned for second reading tomorrow.

Report was read and accepted, the Resolve read once and assigned for second reading tomorrow.

No objection having been noted, was assigned to the Consent Calendar's Second Day list.

On the request of Mr. Simpson of Standish, was removed from the Consent Calendar.

Thereupon, the Report was read and accepted, the Bill read once and assigned for second reading tomorrow.

No objection having been noted, was assigned to the Consent Calendar's Second Day list.

Were reported by the Committee on Bills in the Second Reading, read the second time, passed to be engrossed and sent to the Senate.

Orders of the Day

The following paper appearing on Supplement No. 1 was taken up out of order by unanimous consent:

Bill "An Act to Apportion the House of Representatives" (H. P. 1844) (L. D. 2351) (Presented by Mrs. Lewis of Auburn) Emergency.

On motion of Mr. Simpson of Standish, under suspension of the rules the Bill was read once and assigned for second reading tomorrow without reference to any Committee.

The following Enactors appearing on Supplement No. 2 were taken up out of order by unanimous consent:

An Act Relating to Membership on Maine State American Revolution Bicentennial Commission (H. P. 1679) (L. D. 2072) Emergency

Was reported by the Committee on Engrossed Bills as truly and strictly engrossed. This being an emergency measure and a two-thirds vote of all the members elected to the House being necessary, a total was taken. 120 voted in favor of same and none against, and accordingly the Bill was passed to be enacted, signed by the Speaker and sent to the Senate.

An Act Increasing Borrowing Capacity of School Administrative District No. 64 (H. P. 1692) (L. D. 2085) Emergency

Was reported by the Committee on Engrossed Bills as truly and strictly engrossed. This being an emergency measure and a two-thirds vote of all the members elected to the House being necessary, a total was taken. 120 voted in favor of same and none against, and accordingly the Bill was passed to be enacted, signed by the Speaker and sent to the Senate.

An Act Relating to Breaking and Entering, and Larceny of Trailers and Semitrailers (S. P. 712) (L. D. 2124)

Was reported by the Committee on Engrossed Bills as truly and strictly engrossed, passed to be enacted, signed by the Speaker and sent to the Senate.
